Private Reps: Two further letters of representation have been received in response to the Committee report making the following points:

- It is considered that the proposal represents overdevelopment and that the plot is not wide enough to accommodate two large houses without harming the character of Downderry Way. Bungalows would be more appropriate.
- KCC has made no reference to the lack of parking space in Downderry Way.
 Reference to a site further down Downderry Way is not considered to be relevant to this application.
- There is concern about visibility at the access onto Bradbourne Lane and that the
 proposal will lead to intensification in road traffic. There is no pavement in
 Bradbourne Lane and so cars travel very close to the edge of the road making an
 exit from Downderry Way very dangerous.

Environment Agency: The application has a low risk and there are no planning comments to make. The applicant may be required to apply for other consents directly from the Environment Agency. This matter can be covered by an informative.

DPHEH: I consider the above points have been addressed in the main report.
