

**COUNCIL TAX****DRAFT RESOLUTION**

1. That it be noted that at its meeting on 19th February 2009, the Council calculated the following amounts for the year 2009/2010 in accordance with regulations made under Section 33(5) of the Local Government Finance Act 1992:-

(a) 47,951.43 , being the amount calculated by the Council, in accordance with regulation 3 of the Local Authorities (Calculation of Council Tax Base) Regulations 1992 as amended, as its council tax base for the year.
