CPK CAR PARKING FEES, CHARGES AND OPERATIONS - ANNUAL 09/003 REVIEW

Decision Notice D090113MEM

The joint report of the Director of Planning, Transport and Leisure and Director of Finance provided an analysis of the level of fees and charges for the Borough car parks in the context of the current financial climate, car park usage monitoring and the needs of the local economy. Particular emphasis was given to the need to strike a very careful balance in approach to reflect the sensitivities of parking charges related to local economic factors for residents and businesses in the Borough.

In the circumstances it was concluded that there was no justification for a general increase in fees and charges although attention was drawn to a number of anomalies persisting in the pricing structure that merited review. Particular consideration was given to the position regarding season tickets and a possible review of the charging regime at Lower Castle Field car park. Reference was made to an examination of three potential new sources of revenue (charging in the northern car parks, extending the fee paying hours, and Sunday and public holiday charges) and the conclusion that the Council should continue to refrain from introducing such charges.

Members commended the report for its pragmatic approach in the current economic circumstances and considered that the proposed season ticket prices still represented good value relative to the annualised cost of paying the daily rate for long stay parking. In considering the possibility of realigning the charges in Lower Castle Field with other town centre car parks, Members requested that full consultation be undertaken with all the main sports users, with a report back on the results to the appropriate advisory board later in the year.

RECOMMENDED: That

1) consultations for the charging system for Lower Castle Field car park to be aligned with the one that currently exists in Upper Castle Field be carried out through the Tonbridge Sports Association;

2) the price of a season ticket for the Tonbridge long stay car parks be adjusted in accordance with the table shown at paragraph 1.6.6 of the report; and

3) all other charges remain unaltered as part of this year's review.
