FUTURE ADMINISTRATION OF CONCESSIONARY TRAVEL

(1) expressing support for a transfer of the administration of statutory and discretionary concessionary travel from district level authorities on the basis advocated by the Kent Finance Officers Association but making it clear that if responsibility is transferred to county councils and applications continue to be processed by the district councils, the latter should receive full reimbursement of costs;

(2) emphasising that any transfer of responsibility should be complete to ensure clarity for the public and that no residual costs fall upon the district councils;

(3) drawing attention to the problem of cross-boundary travel and urging that if responsibility is transferred to county councils, appropriate finance and guidance should be made available to enable discretions beyond the core scheme (such as additional hours and companion passes) to apply across county boundaries; and

(4) drawing the Government's attention to the need to address the issue of concessionary rail travel to ensure a consistent and equal approach across the bus and rail networks.
