	The applicant applied for £8,988 being 25% of estimated cost. Figure rounded up to the nearest £500
Details	Refurbishment of all weather training area including, re-surfacing, re- lining, repairs to fencing, overhaul of floodlighting and improving access for disabled people.
	The project should be considered as exceptional because without these works the facility may need to close, resulting in the loss of a valued amenity serving a population of approx 10,000, for whom there are no local alternatives.
	The Town Council has set aside £5,000 for this project and will start work, which should take about 3 weeks, as soon as funding is secured.
Officer's Comments	Chief Leisure Officer: The Snodland All Weather Pitch is a valuable local sports facility in terms
	of both casual use and structured club use. The repair and refurbishment work included in the application is needed urgently if the Town Council is to recover the pitch's former usage, and to develop new users/activities. The application is considered to be exceptional on health and safety

	grounds and is supported. Director of Planning and Transportation I believe there are special circumstances in this case which would be 'exceptional' in view of the strict test we should be applying to such applications.
Local Member Comments	Cllr David Keeley I support this project. The training area is in continuous use throughout the year for people of all ages. The health and safety aspect comes to mind especially when young children play on it. The surface is very rough and if one falls it can be quite painful with small pieces being lodged in the skin etc. Cllr Anne Moloney I am fully supportive of this application. The All weather pitch is a valuable asset to the sporting facilities in Snodland and it would be a great loss if it were unable to continue to offer the facilities so greatly valued. The pitch is in relatively poor condition and the added improvement to the existing facility, of access for the disabled would be a great benefit.
