WEST KENT INVESTMENT STRATEGY - REVISED DRAFT

Decision Notice D100030MEM

The joint report of the Cabinet Member for Community Development and the Chief Executive presented a second draft Strategy revised in response to comments received from partner agencies. Consideration was given to a suggested response to the further draft document prior to its final adoption by the West Kent Partnership.

It was noted that local partners had drawn up a detailed action plan setting out the key economic and infrastructure priorities needed to achieve the overall aims and objectives of the strategy. Effective implementation of the strategy required an on-going commitment to joint working amongst key partners, which Members welcomed.

CD BOROUGH COMMUNITY DEVELOPMENT PARTNERSHIP - 10/004 UPDATE

Decision Notice D100031MEM

The joint report of the Cabinet Member for Community Development and the Chief Executive provided an update on proposals to establish a single community development partnership for the Borough. Subject to ensuring that such work continued to focus primarily on the three priority communities of East Malling, Snodland and Trench, negotiations had commenced with key partners with a view to securing support for, and financial commitment towards, the establishment of a single partnership from April 2010. The report also outlined partner support and future funding.

It was noted that Kent Police, West Kent Primary Care Trust and Russet Homes had expressed support in principle for the proposal. Two local partners, the Snodland Partnership and East Malling and Larkfield Parish Council, had agreed to continue funding their local community development workers.

The Board was advised that the proposed Borough Community Development Partnership sought to provide longer term sustainability for important local community development work and that the Borough Council would act as the financial administrator for the partnership to ensure that proper accounting procedures were followed.

Members acknowledged the valuable contribution and hard work of external partners and the Community Development Team for the excellent partnership working to improve and develop the local community.

RECOMMENDED: That progress towards the formation of a Borough Community Development Partnership be noted and a further report be made to the next meeting of the Advisory Board.

COMMUNITY SAFETY PARTNERSHIP DRAFT ACTION PLAN

Decision Notice D100032MEM

The Chief Executive sought endorsement of the draft Community Safety Partnership Action Plan for 2010/11. Key issues to be addressed included anti-social behaviour and violent crime. It was noted that some aspects needed to be finalised with partners and a final copy of the Action Plan would be presented to the Community Safety Partnership at its meeting on 26 April 2010.

Members recognised the excellent work undertaken by the Community Safety Partnership and were confident that good progress would continue to be made in 2010/11. However, concern was expressed at the high levels of anti-social behaviour experienced by residents, the perception arising from youths gathering and under age drinking. The intention of working in conjunction with the Kenward Trust in engaging with and educating young people on alcohol related issues was reported.

Police visibility in the local community and lack of confidence in the effectiveness of CCTV, especially the mobile cameras, was discussed. Members were assured that Tonbridge and Malling Borough Council remained committed to CCTV, in particular the fixed equipment, although it was acknowledged that the current kit needed to be reviewed and digitalised. There would be an ongoing and serious financial commitment to CCTV, subject to finalising equipment specifications.

RECOMMENDED: That the draft Community Safety Partnership Action Plan for 2010/11, as set out in the Annex to the report, be supported and endorsed.

VOLUNTARY SECTOR GRANTS - 2010/11

Decision Notice D100033MEM

The report of the Chief Executive reviewed performance against adopted Service Level Agreements for the Borough's key voluntary sector bodies and sought agreement on grant support for the coming financial year. Members noted that all of the reports submitted

demonstrated good progress against objectives set out in the service level agreements, although little progress had been made towards the two Age Concern organisations working closer together as referenced in their adopted service level agreements. It was recommended that the 2009/10 service level agreements for the two Age Concerns be extended for a further year.

The significant increase in approaches to the Tonbridge and Malling Citizens Advice Bureau during the current economic climate was also noted.

Due to pressures from the County Council on the two Age Concerns, the voluntary organisations would be encouraged to ring fence any grant awarded to ensure that services would be provided for the benefit of Tonbridge and Malling residents.

RECOMMENDED: That:

- (1) a grant of £10,000 be offered to the Tonbridge Volunteer Centre for 2010/11;
- (2) a grant of £6,000 be offered to Maidstone Mediation for 2010/11;
- (3) grants of £10,000 be offered to Age Concern Malling and Age Concern Tonbridge for 2010/11 and Service Level Agreements be extended for a further year; and
- (4) a grant of £111,000 be offered to the Tonbridge and Malling Citizens Advice Bureau for 2010/11.
