MATTERS FOR RECOMMENDATION TO THE CABINET

FP CONCESSIONARY FARES UPDATE 10/057

The joint report of the Central Services Director and Director of Finance provided an update on the transfer of responsibility for the administration of concessionary fares to Kent County Council (KCC) from April 2011 and considered the future of the discretionary rail concession option. It was noted that the County Council had indicated that it would not be offering any discretions beyond those currently applying to the bus pass and the report examined the legal and financial implications for those district councils that offered rail (or other) discretionary concessions. It was recognised that, in the current climate of financial cutbacks throughout the public sector, a cost benefit analysis of this potential concession would need to be considered with the assistance of an Equality Impact Assessment.

Members referred to a local campaign for the extension of the concessionary fares scheme to include rail travel which, it was believed, had received indications of support from a number of Kent local authorities including KCC. It was therefore considered that in seeking clarification of the position, the scheme as currently operated in the Borough should be commended to KCC on transfer of the function in order to maintain service to recipients and avoid the confusion of different authorities dealing with various elements of concessionary travel.

In commenting on the future arrangements for face-to-face contact with customers, Members suggested that applicants for travel concessions should be able to use any of the Gateways in Kent.

RECOMMENDED: That

- (1) the position regarding transfer of responsibility for concessionary fares be noted subject to clarification of Kent County Council's position regarding the offer of rail concessions and commending the Borough Council's approach, and to future face-to-face contact being available to applicants at any Gateway facility; and
