## Suggested Key Principles to apply to future funding rounds from 2012/13

- 1. Funding will only be provided for projects and proposals which result in tangible community benefits. No applications will be entertained which, either whole or in part, involve revenue funding of a recurring nature.
- 2. Specific funding rounds might be dedicated to provide support for the celebration of nationally important events. Exceptionally, the fund might be used to support events of local importance, such as a 25th, 50th, 60th, 75th or 100th anniversary, of a community or community group, but not of an individual resident.
- 3. Criteria will be adopted, on a round by round basis, to enable fair judgements to be made on all bids received. These will include priority being given to proposals which relate to the Council's key priorities and the availability of match funding to support any initiative for project bids over £500 in value.
- 4. The aim should be to achieve a fair distribution of grants across the Borough.
- 5. For future rounds, given the need to manage resources set aside for the community enhancement fund, grants will be limited to a maximum of £2500.
- 6. Funding will not be provided for projects and proposals on a retrospective basis.
- 7. Borough Council Members will continue to assess bids prior to their submission to the Panel. Detailed guidance will be issued on a round by round basis to enable this to be undertaken fairly. The range of issues to be initially assessed by this process should include the extent to which the application accords with any adopted guidance, and whether the amount bid for is judged to be appropriate in relation to the proposed project. No application will be considered by the Panel unless formal Member endorsement has been confirmed by his or her signature on the application form.

## **Community Enhancement Fund Bids to Support Jubilee and other National Events**

- 1. Parish Councils and local Community Groups can apply for financial support from the Borough Council to assist with Jubilee celebrations and community events related to the Olympics.
- 2. A grant of up to £500 will be available for those wishing to provide a Jubilee Beacon or Bonfire provided this is formally registered and undertaken in accordance with official guidance. Further information is available on <a href="www.diamondjubileebeacons.co.uk">www.diamondjubileebeacons.co.uk</a> or by contacting the Pageant Master direct on 07737 262913.
- 3. In exceptional circumstances, additional funding of normally up to £1500 will be available to assist with the funding of celebrations related to the Queen's Jubilee or Olympics. Priority will be given to events which:
  - (a) engage a whole local community
  - (b) promote inclusiveness
  - (c) achieve improved and lasting community spirit within the locality
  - (d) are supported by additional funding from other sources
  - (e) meet the Council's key priorities.
- 4. If more than one application for funding is received within a single ward or community, higher priority will be given to the bid which best achieves the wider objectives set out in section (3) above.
- 5. Funding is available for either capital or revenue funding subject to the above limits.
- 6. Applications for funding for events must include a costed summary of likely expenditure supported with any formal quotations received.
- 7. Appropriate recognition of the contribution made by the Borough Council should be made in any event publicity material. Applicants will be asked to provide the Borough Council with a short summary of how the event was received locally, for use in local publicity.

#### **Community Enhancement Fund**

#### **Draft Criteria for Parish Council Funding Round**

- 1. A single grant of up to £2,000 will be available to each Parish Council to fund a specific project in their area.
- 2. Funding will only be provided for projects and proposals which result in tangible community benefits and do not involve revenue funding of a recurring nature.
- 3. The costs of routine repairs and maintenance of buildings or other facilities are excluded.
- 4. Projects should relate to at least one of the Borough Council's key priorities and applications should indicate an element of match funding for the project.
- 5. Funding cannot be provided for any projects and proposals on a retrospective basis.
- 6. Funding for a one-off event may be supported from the Fund with the exception that grant cannot be used to pay for food and drink associated with that event.
- 7. Appropriate recognition of the contribution made by the Borough Council should be made in any publicity material.
- 8. The project or proposal should be completed within one calendar year of the grant being offered. No grant will be paid after that date.
