

**CAR PARKING ARRANGEMENTS****Parking Permits**

Head Office and other senior staff within the Trust receive an 'All Car Parks' parking permit free of charge.

<b>Site</b>	<b>Car Parking</b>
Larkfield Leisure Centre	<p>The car park falls within the red line on the lease agreement.</p> <p>It is intended for exclusive use of patrons and there is no charge.</p> <p>It is litter picked and generally hand swept by the Trust but maintained by the Council to include re-surfacing, kerbs, re-lining, signage, fencing, other furniture, CCTV and lighting.</p> <p>The Trust undertakes grounds maintenance but tree work is the responsibility of the Council.</p> <p>Snow clearance and gritting of the car park is undertaken by the Council on a non-priority basis. Local gritting of paths is undertaken by the Trust.</p>
Angel Centre	<p>The car park is not within the red line on the lease agreement.</p> <p>Angel Front &amp; Rear car parks are short stay (4hr) public pay and display car park for all town centre users. A charge is applied Monday to Saturday (0800 - 1800). There is no charge on Sunday. No system of customer refund is in place for users of AC.</p> <p>Long stay parking is available adjacent to at Sovereign Way Mid where duty staff are allowed to park by issue of a permit.</p> <p>Snow clearance and gritting of the car park is undertaken by the Council on a priority basis. Local gritting of paths is undertaken by the Trust.</p>

<p>Tonbridge Swimming Pool</p>	<p>The car park is not within the red line on the lease agreement.</p> <p>It is a long stay public pay and display car park for all town centre users. A charge is applied Monday to Friday (0800 – 1800) and Saturday (0800 - 1230). There is no charge on Sunday.</p> <p>Customers are offered a refund for the first hour of parking at the applicable rate (currently £1.00) based on a minimum spend equivalent to at least a concessionary swim (currently £2.60). The refund is coded to a DPHEH budget i.e. funded by the Council.</p> <p>Snow clearance and gritting of the car park is undertaken by the Council on a priority basis. Local gritting of paths is undertaken by the Trust.</p> <p>Duty staff are allowed to park by issue of a permit.</p>
<p>Poult Wood Golf Centre</p>	<p>The car park falls within the red line on the lease agreement.</p> <p>It is intended for exclusive use of patrons and there is no charge.</p> <p>It is litter picked and generally hand swept by the Trust but maintained by the Council to include re-surfacing, kerbs, re-lining, signage, fencing, other furniture, CCTV and lighting.</p> <p>The Trust undertakes grounds maintenance but tree work is the responsibility of the Council.</p> <p>Snow clearance and gritting of the car park is undertaken by the Council on a non-priority basis. Local gritting of paths and hard standing car parking area is undertaken by the Trust and clubhouse contractors to facilitate clubhouse visitors.</p>
