1 WEST KENT BUSINESS SUPPORT INITIATIVES

To provide an update on the development of additional. jointlycommissioned business support services for West Kent to be implemented in 2013/14.

1.1 Background

- 1.1.1 A report was made to the previous meeting of this Board setting out proposals for a pilot programme of business support initiatives across West Kent. The initial proposal was for this to be undertaken in January – March 2013 as a precursor to a full programme being developed for the new financial year. The pilot programme was to be funded by Kent County Council but, in the event, the County Council indicated that a pilot programme could not be supported. Instead, the West Kent Partnership were invited to proceed direct to a full bid for funding for a business support programme for 2013/14.
- 1.1.2 As set out in the previous report to this Board, given the ongoing challenging economic situation for our local businesses, our collective ambition for 2013/14 is to pool the limited economic development resources available to the three West Kent districts and the West Kent Partnership to promote a single and clear business support 'offer' for West Kent businesses. This will require a review of what we currently provide individually and the development of a limited commissioning process to secure the business support services that are most effective and needed locally from the best provider or providers. Additional funding from the County Council could provide a significant enhancement to the services that the three West Kent districts could provide themselves.

1.2 West Kent Pilot Programme

1.2.1 A bid to the County Council's Regeneration Fund for 2013/14 has now been prepared. The bid is for funding totalling £52,000 which would be partly matched funded by the three West Kent Districts and the West Kent Partnership. The bid

would enable the following additional/enhanced business support initiatives to be implemented:

- providing additional impartial and confidential 1:1 business advice to start up, and micro businesses
- 1:1 mentoring to bring forward businesses to qualify for High Growth Kent support
- Meet the Expert workshops signposting to professional services available to improve management and performance of a business and move it into growth.
- Topic specific workshops across all sectors focusing on particular areas, identified according to demand but likely to include, finance, sales and marketing, export markets
- 1:1 and workshop support for home based businesses
- 1:1 and workshop support for rural, especially land based businesses
- Pilot programme of tailored support to encourage entrepreneurship in deprived communities
- 1.2.2 The bid has received a first stage approval from the County Council and is now proceeding to a final assessment. If that is successful, then funding would be available for West Kent Partners to commission the above initiatives from April 2013.
