

COUNCIL TAX**DRAFT RESOLUTION**

1. That it be noted that at its meeting on 22nd February 2007, the Council calculated the following amounts for the year 2007/2008 in accordance with regulations made under Section 33(5) of the Local Government Finance Act 1992:-
