#### **1.2** Community Enhancement Fund – Member Panel

1.2.1 At the meeting of the Cabinet on 22 June 2011 the criteria governing the operation of the new Community Enhancement Fund were approved (Decision Number D110088CAB). It was also agreed, subject to the approval of the Council, that a Member panel of nine, politically balanced to comprise eight Conservative members (including two representatives from each of the Areas in the Borough and the Chairmen of the Communities and Finance and Property Advisory Boards) and one Liberal Democrat member, be established to assess grant applications and make recommendations to the Cabinet Members for Communities and Finance.
