1 ARRANGEMENTS FOR COMMITTEES, ADVISORY BOARDS AND PANELS

This report proposes some changes to advisory boards to reflect revised Cabinet portfolios and the rationalisation of those boards and panels which rarely meet.

1.1 Introduction

- 1.1.1 A review of the priorities, challenges and capacity of the organisation has been undertaken and where there are Advisory Boards or Panels that have not met for some time, or meet only infrequently, we have taken the view that these should be deleted as part of a restructure of the overall programme. These proposals are set out in the table at the **Annex** to the report. The main changes to the Advisory Boards are brought about by the merging of Cabinet portfolios i.e. Communities with Health and Finance with Innovation and Improvement. A new Economic Development portfolio and Advisory Board is also planned.
- 1.1.2 A number of specific subject Panels which rarely meet are proposed for deletion and their functions subsumed into other Boards as required.
- 1.1.3 It is also proposed that the function of the Community Safety Scrutiny Sub-Committee be transferred to the parent Overview and Scrutiny Committee.
- 1.1.4 The proposed changes may be summarised as follows:
 - Merged Communities and Health Advisory Board
 - Merged Finance, Innovation and Property Advisory Board
 - New Economic Regeneration Advisory Board
 - Deletion of Health and Wellbeing Advisory Board
 - Deletion of Innovation and Improvement Advisory Board
 - Deletion of Car Parking Charges Advisory Board

- Deletion of Community Enhancement Fund, Community Infrastructure Levy, Gypsy and Travellers Issues, Local Plan, Management Liaison, Tonbridge Town Centre Panels
