1 PROGRAMME OF MEETINGS 2013/14

- 1.1 This report brings forward for consideration the programme of meetings for 2013/14.

As a consequence of this the meeting of the Parish Partnership Panel scheduled for 21 November will need to be brought forward to 14 November 2013. Members are also asked to note that, at the request of Financial Services, the meeting of the Audit Committee scheduled for 31 March will be held on Monday 14 April 2014.
- 1.1.4 In respect of the proposed programme for 2014 onwards the meetings of Area 1 Planning Committee and Tonbridge Forum (marked with an asterisk in the Annex) have yet to be confirmed with the Angel Centre; it has been confirmed that the County Council budget Meeting will be held on 13 February 2014 (with the third Thursday reserved for any incomplete business); and efforts have been made to avoid scheduling meetings during school holiday and political party conference periods.
