Pedestrian Route between Aylesford Village and Eccles	Improvements to the pathway including widening, resurfacing, pedestrian safety barriers, provision of dropped kerbs and improving accessibility for disabled users.	Further investigations required for a potential bid in 11/12
A228 Safety Improvements	Potential safety improvements from Kings Hill to Mereworth along the A228 including Kent Street junction.	Land issues therefore, undeliverable in 10/11 investigations on going to bid for scheme in 11/12
Bellingham Way Link	A new link along Bellingham Way between Leybourne Way and Station Road.	Land issues therefore, undeliverable in 10/11 investigations on going to bid for scheme in 11/12
Lucks Hill - CRM Refurbishment and surface improvements	Casualty reduction measures including footway & surface improvements.	Improvements being carried out with land being acquired for larger scheme if required in 11/12
Measures to tackle transport issues identified in AQMA's	Bids to be developed by working group set up to investigate potential transport improvements in the identified AQMA's in Tonbridge & Malling.	Further investigations required for a potential bid in 11/12
Pedestrian crossing in the middle of East Peckham	Pedestrian crossing along Pound Road in East Peckham following a request from the Parish Council.	Further investigations required for a potential bid in 11/12
Cycling improvements. A20 Cycle Route (phases 2 & 3) including improvements in front of Sainsbury's at Quarry Wood and across Hermitage Lane. Link from B245 London Road to Welland Road (Tonbridge School), Penshurst to Tonbridge improvements and Kings Hill to Maidstone cycle link.	Extending cycle network to provide improved continuity, greater attractiveness and value, to promote safer routes to schools, more cyclists and cycling volumes.	Many drawings and designs already available, awaiting funding priority.
Pedestrian crossing bottom of Quarry Hill Road, Tonbridge	Promote improved safety between education establishments in Brook Street and accessibility to bus stop on eastern side.	Preliminary design available for a potential bid in 11/12
Tonbridge High Street – Gateway (1): High St / Vale Rd junction	Improving the pedestrian environment in Tonbridge High Street, including improved air quality and public transport access, depends vitally on remodelling this junction.	Scheme currently undeliverable in 10/11 further investigations required for a potential bid in 11/12

Tonbridge High Street - Gateway (2): High St / Bordyke junction	Improving the pedestrian environment in Tonbridge High Street, including improved air quality and public transport access, depends vitally on remodelling this junction.	Scheme currently undeliverable in 10/11 further investigations required for a potential bid in 11/12
Tonbridge High Street - traffic management and pedestrian improvements.	A package of measures to support town centre regeneration and to create significant improvement in the pedestrian environment along the length of the High Street to support the TCAAP. This should include a pedestrian signing strategy.	Scheme currently undeliverable in 10/11 further investigations required for a potential bid in 11/12
Tonbridge Train Station	Network Rail is promoting works at Tonbridge Station as part of its National Stations Improvement Programme. The bulk of the works will deal with remodelling within the building. However, part of the scheme will include a substantial change to the external appearance and also some focus on the untidy area at the Barden entrance. Therefore, this is an excellent opportunity for a joint scheme with to take a fresh look at the public areas around the station frontage to improve the access routes, remodel the bus stop areas, further discourage encroachment by private cars waiting to pick up passengers in the bus waiting areas and generally improve the surfaces in parallel with the enhanced appearance of the building.	The timescale for the Network Rail project is uncertain but is likely to be during 2011/12 therefore further investigations required for a potential bin in 11/12.
UTMC System for Tonbridge	Extension of current Urban Traffic Management Centre to Tonbridge Town Centre.	Scheme currently undeliverable in 10/11 further investigations required for a potential bid in 11/12
Vale Road / Vale Rise Roundabout	Work on a transportation strategy for the town centre highlighted how critically important this junction is in terms of local network management. This has been reinforced by the recent studies carried out by Jacobs for the TCAAP. Refining the operation of this junction is vital to the regeneration of the town centre.	Scheme currently undeliverable in 10/11 further investigations required for a potential bid in 11/12
West Malling Station Forecourt	Remodelling of West Malling Station forecourt in line with the already adopted station master-plan. Additional contribution to come from S106 for Leybourne Grange development.	Scheme currently undeliverable in 10/11 further investigations required for a potential bid in 11/12
