#### 1 PARKING ACTION PLAN

#### Summary

This report updates Members on the phased approach to on-street parking management with a focus on the detail of the current initiative – Phase 6b

#### 1.1 Introduction

- 1.1.1 The Borough Council's approach to on-street parking management has been divided into phases so economies of scale can be applied and work is delivered in a timely manner. Phase 6a was introduced earlier this year, and we have been carrying out informal consultation on proposals that form Phase 6b. We have also started compiling requests that will form Phase 7 for future investigation.
- 1.1.2 We have received comments on most of the proposals in Phase 6b, some in favour, some against and others suggesting changes and alterations. The Board is invited to consider these responses, and to accept (or otherwise amend) the recommendations so that these proposals can proceed to formal consultation.
- 1.1.3 Informal consultation has already been carried out on the proposals for Aylesford, forming part of the Aylesford Local Parking Plan and the responses were reported to the Board in June. To take advantages of the economies of scale the agreed proposals in Aylesford Village will join in with the formal consultations as part of Phase 6b.

#### 1.2 Phase 6b

1.2.1 Phase 6b consists of approximately 40 locations across the Borough. We sent out letters and plans to 1184 properties that 'front' the proposals and received replies from 462 properties, an overall return rate of 39%, which is significant when compared to an average of 15-20% for this sort of consultation.

1.2.3 Additionally, there were two locations where informal consultations with residents were not carried out, both related to new developments that are currently under construction, as the surrounding residents have had the opportunity to comment on the proposed changes to parking arrangements as part of the planning process.

1.2.5 There was one other location where changes to parking restrictions were proposed. Previously there had been limited waiting parking bays in The Street in Ightham that had been removed at the request of residents, businesses and the local Member. However, the items within the Traffic Regulation Order still exist and need to be removed. Informal consultation has not been carried out for this removal as the bays have long since disappeared.

- 1.2.6 Each location where restrictions or changes are proposed are considered in detail in their respective Annexes, where the history of the request, the proposals and the consultation responses are discussed, along with a recommendation for the Board's consideration.
- 1.2.7 Where alterations have been recommended, an amended plan has been included for consideration.
- 1.2.8 It worth noting that whilst some of these proposals were not supported by the public, most of them were and some just needed some minor tweaking to address a particular local issue.

## 1.3 Next steps

1.3.1 Those areas that meet with the Board's approval will now be taken through the formal consultation process and objections reported back to the next meeting. In the meantime the focus of our work will turn to the following projects. Our rate of progress on each will, as always, depend on how extensive the solutions are at various locations.

## 1.4 Borough Green and Snodland – Parking Reviews

1.4.1 Over the next couple of months we will revisit particular aspects of the Local Parking Plans for Borough Green and Snodland with local members and consider any alterations to the existing parking regime at specific locations identified.

## 1.5 West Malling Local Parking Plan Review

1.5.1 I anticipate calling a meeting of the Steering Group for West Malling within the next two months to consider the results of the consultation held earlier this year following, to take stock of the options and to consider any further steps required before proposals are formulated. A further report will then be made to the Board.

## 1.6 East Malling Local Parking Plan Review

- 1.6.1 Though most of the changes and restrictions introduced in East Malling have settled in well, there are a few locations where there have been reports where parking issues remain, or where the changes associated with the parking review have led to a change in parking habits.
- 1.6.2 In consultation at the turn of the year with local Members, the locations where changes may be required will be assessed and, if appropriate, can be included with other proposals as part of Phase 7.

#### 1.7 Phase 7

1.7.1 We are currently compiling a list of locations for investigating the possibility of new parking restrictions. Currently the list of locations for consideration is as follows;

## 1.8 Future Work

1.8.1 Development of the Hadlow Local Parking Plan was put on hold some four years ago pending the Parish Council moving forward with a village redesign project. I am advised that the Parish Council is now ready to consider options to address parking issues in various areas. An assessment of the current parking restrictions and an overall review of the requests and aspirations of the Parish Council can be considered, in consultation with local Members, following Phase 7.

# 1.9 Legal Implications

1.9.1 The on-street parking service is undertaken by the Borough Council on behalf of the County Council under the terms of the formal legal agreement

# 1.10 Financial and Value for Money Considerations

1.10.1 Funding to implement the parking action plan is provided within existing approved Borough Council Budgets

# 1.11 Risk Assessment

1.11.1 The assessment and consultation process applied to parking management should provide the assurance that the Borough Council has the will and ability to adapt the Parking Plans in the light of comment and circumstances to ensure that it achieves a best balance of local parking needs. A regular review of the schemes is crucial to ensure that we can correctly and effectively manage on street parking in these areas as the proposals are either introduced for safety reasons or to provide a more appropriate balance of parking needs.

1.11.2 A major risk is that scheme proposals encounter significant lack of local support. This risk is mitigated by the considerable effort devoted to ensuring there is widespread consultation on proposals through two stages of informal consultation before any formal stage of consultation is reached. There is also care given to ensuring that schemes are adjusted and adapted in the light of comments and observations received from the local community without compromising safety of the Councils commitment to deal appropriately with identified safety concerns.
