# 1 <u>LEYBOURNE LAKES COUNTRY PARK IMPROVEMENTS</u>

## Summary

This report brings forward proposals for improvements at Leybourne Lakes Country Park for Members' consideration. The proposed improvements are funded in full from developer contributions.

# 1.1 Background

1.1.1 A Capital Plan scheme for improvements at Leybourne Lakes Country Park was considered at Cabinet on 1 February 2011, with a recommendation to Council to transfer the scheme from List B to List A of the Capital Plan, for progression in 2011/12. A copy of the List C Evaluation for the scheme, reported to the Finance & Property Advisory Board on 5 January 2011 can be found at [Annex 1]

## 1.2 Proposed Improvements

- 1.2.1 Following comments from users of the Park, and a recent site risk assessment undertaken by the Council's Insurers, a number of improvements have been identified for the site:
  - Play Area Surfacing Members will be aware that a new play area was provided in the Country Park in 2009, funded by the Government's Playbuilder Scheme, and has proved to be very successful. Due to its popularity, sections of the play area are prone to heavy wear and can become very muddy. This has prompted a number of comments from parents and it is, therefore, proposed that appropriate surfacing be provided around key areas, including the main entrance points and picnic area.
  - <u>Path Improvements</u> A number of paths around the site have been highlighted for repair by the Head Ranger, and the Council's Insurers during a recent site risk assessment. It is proposed that repairs be undertaken, prioritising those paths most in need of improvement.

- Primarily, the works will focus on the main path alongside the Millstream towards Brooklands Lake.
- <u>Slipway</u> The existing slipway is used by a number of water sports users including the Scouts, and is essential to the success of many events taking place on site. It is proposed that improvements are undertaken to the slipway surfacing and the concrete apron entering the water to maintain its future use.
- <u>Site Furniture/Signage</u> Additional site furniture will be provided including litter bins and seats. The main pedestrian entrance signs will be replaced and improved following liaison with local Parish/Town Councils.

#### 1.3 Timescale

1.3.1 Subject to confirmation by Full Council on 17 February 2011 that the scheme is included in the Capital Plan List A for 2011/12, the works will be undertaken over the coming financial year, with the play area surfacing and new pedestrian entrance signs being progressed in advance of the school summer holidays.

# 1.4 Legal Implications

1.4.1 The works will be progressed in accordance with the Council's approved procurement procedures.

# 1.5 Financial and Value for Money Considerations

1.5.1 The proposed works will cost £55,000, and can be funded in full by developer contributions held by the Council.
