# DECISIONS TAKEN UNDER DELEGATED POWERS IN ACCORDANCE WITH PARAGRAPH 3, PART 3 OF THE CONSTITUTION

## LA APPLICATION FOR A NEW PREMISES LICENCE FOR MARTINS, 1-13/008 2 THE BROADWAY, HIGH STREET, HADLOW

The Panel gave consideration to an application made by Martin McColl Ltd for a premises licence under Section 17 of the Licensing Act 2003 in respect of Martins, 1-2 Broadway, High Street, Hadlow. The application related to the supply of alcohol for consumption off the premises.

Details of the representations and petition received during the statutory consultation period were set out in Annex 2 and 3 to the report. The Panel noted that no objections or comments had been made by the statutory consultees.

The Panel listened carefully to the representations made by Mr D Crank, the applicant's solicitor, the comments made by Councillor Miss Sergison in support of the objections raised in the petition made by local residents and to comments made by Mr Hammond, Chairman of Hadlow Parish Council; Mr Wheeler, St Mary's Church; and Mrs Cox and Mr Bellamy in respect of the objections raised in their written representations.

In accordance with the objectives contained in the Licensing Act 2003 and Guidance received from the Secretary of State and the objectives contained within the Licensing Policy of Tonbridge and Malling Borough Council, the Licensing and Appeals Committee, sitting as a Panel.

RESOLVED: That the Premises Licence be Granted as follows:-

- 1. For the sale of alcohol for consumption off the premises from Monday to Sunday, 05.30 hours to 21.00 hours;
- 2. For the premises to be open from Monday to Sunday, 05.30 hours to 21.00 hours;
- 3. For the digital CCTV system to be extended to provide external monitoring; and
- 4. For the display of signage around the store advising customers not to cause nuisance and to have regard for the locality upon leaving.
