### 1 SCRUTINY WORK PROGRAMME

To review the future programme of scrutiny reviews.

#### 1.1 Introduction

- 1.1.1 A report was made to the meeting of this Committee in June 2011 setting out a suggested work programme of reviews. As reported elsewhere on this agenda, the three reviews which were being taken forward: planning enforcement; winter maintenance; and air quality have all been progressed by separate scrutiny panels. The final report on the air quality review appears on this agenda. A further panel meeting of the planning enforcement review is being arranged for February and a final report will be made to the March meeting of this committee. An update on the winter maintenance review is being reported separately and will continue into the Spring with any final recommendations of that Panel being reported to June meeting.
- 1.1.2 Although a number of current reviews are ongoing, it is appropriate to examine which additional reviews could be undertaken by the Committee for the rest of 2012. The report to the June 2011 meeting identified the following areas for possible consideration:
  - Waste Strategies
  - Parking Management and Enforcement
  - Occupational Therapy services (children)
  - Deposit Bond/Rent in Advance/Rent Deposit Schemes
- 1.1.3 Although waiting times for Children's Occupational Therapy assessments have recently improved, the Director of Health and Housing believes that a further review of this topic by the Scrutiny Committee would be well timed and would aim to ensure recent improvements in this important service can be maintained. It is therefore suggested that a scoping report for this review be made to the March

meeting of the Committee to set out the terms of the review and how this might best be progressed.

- 1.1.4 Parking Management is to be subject to an internal audit review during the first half of 2012. On this basis, it would appear appropriate for any recommendations from that process to inform a further review by the Scrutiny Committee. This could be undertaken later in the year. A scoping report for this review could therefore be considered at the June meeting of this Committee.
- 1.1.5 It is suggested that the remaining reviews, regarding waste strategies and rent deposit schemes etc should be deferred until later in the year. The shape and direction of the Government's future waste strategy and its priorities for recycling are yet to be fully clarified and the Kent Joint Municipal Waste Management Strategy is due to be refreshed in the Spring of 2012. A review of this topic would best be timed to co-incide with any newly emerging draft strategy documents later in 2012.
- 1.1.6 A full review of the rent deposit/deposit bond schemes was undertaken early in 2011 and reported to the Strategic Housing Advisory Board. It is suggested that a review of this scheme should be left to later in the year to enable a suitable period of operation of the new scheme to be undertaken and any additional issues to be identified.
- 1.1.7 Taking into account the above suggestions, the intention will be to ensure that, along with those reviews which have yet to be completed, new reviews are brought forward to maintain an appropriate work programme for the Committee for the remainder of this calendar year and beyond. Any additional suggestions from Members of the Committee regarding future topics for review are welcomed.
