1 JOINT STANDARDS COMMITTEE – APPOINTMENT OF TOWN AND PARISH REPRESENTATIVES

To consider the appointment of the Town and Parish representatives to serve on the Joint Standards Committee for the municipal year 2013/ 14.

1.1 Introduction

- 1.1.1 At the meeting of Council on 16 July 2013 it was agreed that a Joint Standards Committee be established with all Town and Parish Councils within the Borough.
- 1.1.2 The Joint Committee will be comprised of 13 Borough Councillors together with 6 Parish and Town representatives (to be appointed on a rotational basis drawn from a pool of Parish and Town representatives). It was agreed that the Parish and Town representatives shall be nominated by the Parish Partnership Panel on an annual basis.
- 1.1.3 Following the July meeting of Council I wrote to all Town and Parish Clerks to invite their nominations.

1.2 Nominations

1.2.1 I have received the following nominations :-

Aylesford Parish Council – Cllr Dennis Elvy

1.2.2 6 members of the pool shall be appointed as voting members of the Joint Standards Committee for each meeting. The most straightforward way to administer these appointments will be to appoint on an alphabetical basis e.g. for the first meeting the representatives from Addington to Mereworth shall be appointed, for the second the representatives from Aylesford to Plaxtol etc.

1.3 Legal Implications

1.3.1 A general power for local authorities to discharge their functions through a joint committee is provided under sections 101 and 102 of the Local Government Act 1972.

1.4 Financial and Value for Money Considerations

1.5.1 It is important that a robust system exists for the promotion and maintenance of high standards of conduct. The absence of such a framework will lower public confidence in the democratic process.
