## Rolling Programme – Phase 4 (2005/06) (Revised)

Description of Service Request and Initial Analysis	
Aylesford	Burnt Ash Road – Parking restrictions installed last year have transferred parking from Quarry Wood Road into the side roads causing obstruction to motor vehicles delivering to the business premises.
Burham	Haleys Place/Court Road corner protection Old School Lane – corner protection to prevent obstruction of junction by customers to the Public House Church Street – Problem not established or verified.
Ditton	Priory Grove – Problem not established or verified.
East Malling & Larkfield	A20 London Road – need for RPPZ in Lay by Larkfield. Lunsford Lane/Springfield Road – corner protection
Leybourne	Old Barn Road – obstruction to through traffic at junction Redbank/Baywell corner protection Lillieburn/Castle Way corner protection.
Platt	Platt Mill Close – problem not established or verified Residents Assn to report back with evidence at a later date.
Shipbourne	A227 Stumble Hill to Upper Green Road – problem not established or verified.
Snodland	Brook Lane – obstructive parking opp Lakeview junction Brook Street – junction parking.
Wateringbury	Mill Lane - access and obstruction – problem not established or verified. Fields Lane – obstruction on days when football matches are played for emergency vehicles to and from Cobbs Close, The Bricks and A26 Teston Road. Needs further investigation with landowner issues on gate across track to playing fields.

Blue Bell Hill	Various Roads – Control of commuter parking (completed).
Aylesford	<p>Robin Hood Lane – in vicinity of community hall and church - persistent obstruction to through traffic to Crematorium (complete).</p> <p>Bellingham Way – All night causing lorry parking health and hygiene issues on surrounding land. Obstruction of the footway and carriageway. Video footage of crashes on junction from ANP security office. Aylesford Newsprint - Extended DYL to end of adopted highway – funded by Aylesford Newsprint (due to be advertised June 2007).</p>
Tonbridge	<p>Higham Lane/Hartfield Close - corner protection (due to be advertised June 2007).</p> <p>Ridgeway Crescent – review restrictions at allotment entrance (due to be advertised June 2007).</p> <p>Five Oak Green Road – obstruction to through traffic from Porsche entrance to Roundabout at Woodgate Way (passed to TWBC as just inside their boundary).</p> <p>Welland Road/Longmead Way – corner protection (due to be advertised June 2007).</p> <p>Dernier Road – around Green – obstructive parking (due to be advertised June 2007).</p> <p>Shipbourne Road – corner slip rd/entrance/exit YMCA – Mrs Goodman 173 Shipbourne Road (due to be advertised June 2007).</p> <p>Trend Road/Greenfrith X Roads – DYL corner protection – school traffic (due to be advertised June 2007).</p> <p>Hadlow Road – approach to Cannon Lane t/lights cluster of driveways – van parking on the approach – reported by Ray Dines (due to be advertised June 2007).</p> <p>Morley Road – DYL requested opp Crutch Removals entrance as parking opp access causes obstruction to the removal vehicle operations (due to be advertised June 2007).</p> <p>Waveney Road – changes to SKC and bus stop clearway markings at request of Police (due to be advertised June 2007).</p>
