### Rolling Programme - Phase 4 (2007/8)

### DITTON

#### **Bellingham Way**

The section of road from College Road to the entrance of Aylesford Newsprint was formally adopted this year. Aylesford Newsprint funded the TRO to extend the extension of the existing DYL to cover this part of the highway to deter persistent overnight parking by HGVs. This has resulted in improved safety on the bends and footways, an increase in traffic flows and a decrease in litter.

### TONBRIDGE

Site assessed and consultation with residents complete. These sites will be formally advertised during October

#### Trench Road/Grenfrith/Northwood Staggered Crossroads

Corner Protection and bus stop clearways to facilitate bus service in the vicinity of St Margaret's Clitheroe School

### Waveney Road – O/s Longmead and Oakley Schools

Extension of the 'School Keep Clear Markings' and 'bus stop clearway' to reduce gridlock around the school gate each end of the school day

### Higham Lane jw Hartfield Close

Corner protection and extension of existing DYL to reinforce the rules of the Highway Code and improve sight lines around the bend and introduce bus stop clearways to aid public transport in the area

### **Dernier Road**

Corner protection to keep the junction clear of parked vehicles and facilitate turning manoeuvres for essential service vehicles

## A227 Shipbourne Road – service road opposite YMCA Club

Corner protection to prevent obstruction to access to properties

## B245 London Road

DYL between the entrance to Tonbridge School to Dry Hill Park Road to deter all day parking and reduce congestion at peak times

# **Morley Road**

Extension to existing corner protection to facilitate larger vehicles accessing the units on the industrial estate

# Welland Road jw Longmead Way

Introduce corner protection to reinforce the rules of the Highway Code and prevent parking in unsuitable places

## The Ridgeway

This is the second time we have followed up a complaint about parking obstructing the access to the allotments. Following representation from the residents that the proposal for corner protection is not needed at the service road the proposal is abandoned.

## A26 Hadlow Road

Proposal to join up gap in existing DYL approaching Cannon Lane has been deferred following residents production of a letter from TMBC dated 2003 agreeing to the gap in the restriction. Residents are advised that the site will be closely monitored. Should further complaints about congestion be received then the proposal will be revisited.

# Rolling Programme - Phase 4a (2007/8) (Revised)

### Description of service request and initial analysis

## AYLESFORD

**Burnt Ash Road** – Parking restrictions installed last year have transferred parking from Quarry Wood Road into the side roads causing obstruction to motor vehicles delivering to the business premises

**Mills Road** - 3 cars blocking sight lines between junction protection markings Mr Gladstone 07713 793 773 – needs DYL to be joined up

Lake Road /Quarry Wood - Control of overflow from Ind. Estate

**Pratling St Aylesford -** Obstruction from Business site Old Mill – Mrs Chivers No.175

**Hermitage Lane** – No 151 spur road – commuter parking for Barming Station Mr Foster – junction protection and in turning area DYL

White Post Wood Lane – commuters – road not yet adopted – Referred to Russet Homes

**Teapot Lane -** DYL junction protection around Elm Walk junction both sides and A20 to reinforce the rules of the Highway Code from parent parking.

**Russett Close** - O/s 21 residents requests DYL to prevent neighbour parking on the bend in dangerous manner

## BURHAM

Haleys Place/Court Road - corner protection

**Old School Lane** – First advertised in 2005. Objection from P Council so proposal was dropped and the Objection never considered by Members. There is a persistent nuisance of obstruction by parking and residents have asked for the need to keep the access clear to be re assessed. Corner protection to prevent obstruction of junction by customers to the Public House

**Church Street** – Parish Council request– to reduce parking in unsuitable places. High degree of on-street parking. 40% off street provision. 2 public houses to extreme congestion at all times. Access difficult for refuse freighter and emergency services

**Rochester Road o/s garage** - Resident reports that garage are using footway as storage depot for cars under repair. Monitoring underway

## DITTON

Priory Grove – Monitored - Problem not established or verified

Acorn Grove jw Woodlands Road - Corner protection – Mr Divall No.42 Acorn Gr.

Bradbourne Lane jw A20 - Corner Protection D P Council

Cobdown Close and Orchard Grove - Corner protection D P Council

**New Road** - Resident requests DYL reduced as her neighbour at 94 keeps parking Works van and her daughter cannot park outside when she visits. (School crossing patrol sight lines need to be checked) Mrs Fenner 92 New Road

Scott Close - Corner protection at junctions New Road

**Fernleigh Rise** - Parking commercial vehicles on grass verges DPC – referred to KCC for consideration of bollards not DYL

### EAST MALLING AND LARKFIELD

**A20 London Road** – need for RPPZ in Lay by – defer pending planning application in the area – land rear of properties

Twisden Road and Lavender Road - Corner Protection – Cllr Simpson

**Gilletts Lane - Extension** of DYL opp. factory entrance to protect structural integrity of railings and pond edge S McL/KHS Liaison meeting

**Stickens Lane** - Extension of the DYL southern boundary of 3 and northern boundary of 13 to deter vehicles being parked around the spur where the lane divides – Mr Hance No 5

**Rocks Road** – Mr Harris No. 24 has SYL 10 - 2 o/s property but no restriction on opp side of road. Cars park there all day and restrict deliveries to the house. Requests staggered/daytime SYL to prevent obstruction

**Bondfield** – request for DYL to prevent cars parking opp driveways and obstructing access/egress

Lunsford Lane/Springfield Road - corner protection

**Heron Road** – Anon resident reports parking on footway causing obstruction for peds and pushchairs – assessment – Residents will not use remote garaging due to security issues on the estate.

## LEYBOURNE

**Old Barn Road** – obstruction to through traffic at junction – wait until the T/C works are finished

Redbank/ Baywell corner protection

**Lillieburn/Castle Way** corner protection – wait until the T/C works are finished

**Rectory Lane North** –Mr Stockdale requests more DYL on narrow section of road to prevent obstructive parking when school functions and cricket matches are played – wait until the T/C works are finished

**Woodleas** – Problems with parking in turning head so residents unable to gain access/pass each other. Refuse vehicle unable to gain access on occasions Cul de Sac spur. Mrs Broadmore no 110

## PLATT

Platt Mill Close – problem not established or verified Residents Assn to report back with evidence at a later date

### SHIPBOURNE

A227 Stumble Hill to Upper Green Road – Fairlawne estates to put in bollards to prevent parking on the common. Parking bays provided and serve parking needs for weekly farmers market. The success of The Chaser public house means there are a number of cars parked on the carriageway on some nights when car parks at front and back of pub are full

### WALDERSLADE

**Hepplewhite Mews** – Corner protection – needs to be assessed

**Walsham Road** – Nos 30 – Dogbone is ignored and request enforceable restrictions are considered – needs to be monitored

### WROTHAM

Forge Cottages Wrotham Heath (1 - 4) lay by in front of old post office/shop Residents request RPP

**White Hill/A20 Junction** – Corner protection to prevent Lorries parking on the verge at the junction of A20 and filter lane – Les Henry Associates 18/9/07

### WATERINGBURY

Mill Lane - access and obstruction – problem not established or verified

Fields Lane – obstruction on days when football matches are played for emergency vehicles to and from Cobbs Close, The Bricks and A26 Teston Road. Needs further investigation with landowner issues on gate across track to playing fields

Love Lane - Corner Protection jw A26 Mrs Levett 813582 Cllr English

Bow Road - Corner Protection on access to Scout Hall – No.43 Cllr English

Allington Gardens – Turning area protection – Parks No. 15 Cllr English

Beddow Way – east side, parked cars blocking sight lines in the vicinity of Lillicoes. Request from David Chapman at Lillicoes

## EAST MALLING AND LARKFIELD

### High Street and the Surrounding roads

Review of all parking controls due to commuter parking – could require a Local Parking Plan approach as the issue of use of car park (PC) needs to be looked at as well as the surrounding roads which cars will transfer to. D Charlesworth No 29. PC have carried out survey

### EAST PECKHAM

**Pound Road** 11 – 13 Post Office Parking - outside and in bus stop when they could be parking in free car park and lay by. Mrs Julie Webb reported they also block driveway despite SYL. Email sent to PAs 24/8/07 about enforcement

### HADLOW

#### **Carpenters Lane**

DYL on both sides from jw A26 need to be extended - KCC Richard Long **To be assessed as part of the Hadlow Parking review** 

#### HILDENBOROUGH

**London Road** - Parking in Vicinity of Church and Watts Cross – Mrs Nairne Riding Lane

**Lower St** - Station Parking – All tied in with future Car Park provision but now needs to be progressed in terms of safety

**Riding Park** - Extend DYL up to and around island to prevent obstruction to the highway by parked cars

**Brookmead jw Greenview** – corner protection as commercial vehicles are parking there for shops all day obstructing sight lines

### SNODLAND

Brook Lane – obstructive parking opp Lakeview junction

**Brook Street** – junction parking by Redmans

Pout Road – parking in turning head

Rocfort Road – parking by Pedestrian crossing

All to be assessed as part of Snodland Parking Review

## TONBRIDGE

**Uridge Crescent** - parking junction with Welland Road and footway parking – also missing section of DYL not on Order

**Royal Rise, Kings Road and Goldsmid Road -** Commuter parking and school traffic – call for DYL or some form of parking restriction Mrs Cornwell No. 2 and Mr Russell No. 18. **Review Zone P** 

White Cottage/Thorpe Ave/Cage Green - School traffic Cllr N Heslop

**Audley Avenue** - Between Pembroke Road and Ives Road – Access problems

**College Road** - Between No. 64 – 70 protecting apex of bend – Cllr Bolt advised. **Will be included as part of the area review WK college developer funded scheme.** 

**Nelson Ave -** Extend DYL to cover extended driveway – Mr Searles (now extended driveway so not needed)

Burns Crescent Area - Request for One way system and parking scheme to offset pupil parking from College and schools – Mr Wilson NW Co ordinator – letters on file. Will be included as part of the area review WK college developer funded scheme

Shakespeare Road - Corner Protection – Mr Wood No.1 Shakespeare Road. Will be included as part of the area review WK college developer funded scheme.

**Quarry Bank, Hilltop and Silver Close** - Pupil/commuter parking from schools transferred from Zone M – **Review for Zone M** 

**Quarry Hill Gardens** - Resident reports parking is occurring on this 34m length carriageway off Waterloo Road. Entry is already protected by "No Entry except for Access" regulation but there is no Order to enforce the obstruction that occurs when cars park here blocking access to the 4 houses served by this short section of road. Mr. Rishman 5/7/07

May be the parking is a Police matter in breach of the No Entry Order and obstruction.

**Croft Close – Estridge Way** – cars parking opposite turning at junction cause cars to drive around a blind bend obscuring sight lines

**Chiltern Way Dernier Road** – White Van parking in front of flats that abut Shipbourne Road. Sometimes parks in the turning head or dangerously at end of parking bay for the flats reducing the turning area from Dernier into Chiltern Way (Marquee equipment Van) – Corner protection and look at preserving turning movements for turning head. Cllr Baldock 20/8/07
