1 MANAGING LAND FOR HORSES: A GUIDE TO GOOD PRACTICE

The Kent Downs Area of Outstanding Natural Beauty (AONB) Unit has produced Managing Land for Horses: A Guide to Good Practice. This report sets out the background to this document and recommends its approval as a material consideration for Development Control purposes across the borough.

1.1 Introduction

- 1.1.1 Today there are nearly a million and a half horses in the UK being kept essentially for leisure purposes. These numbers, along with changes to agricultural practices and lifestyles mean that horses are now often kept more intensively than in the past. Horses can have a positive impact, however, without due care they can affect the quality and character of the landscape and impact on wildlife and the environment. The adoption of good practices can bring advantages for economics and the environment, as well as animal health and welfare.
- 1.1.2 The Guide to Good Practice provides information and advice on a range of issues, including grassland management, fencing and buildings and waste management, to help ensure that the positive impacts of horse keeping are maximised. - 1.1.3 Although this document has been produced by the Kent Downs AONB Unit for application in the AONB, it is based on national guidance produced by the SEEDA Rural Sector Champion programme and as such sets out practices that can beneficially be applied borough-wide. It is envisaged that the Guide can be used to inform and help applicants for planning permission and assist the Council in helping to shape successful approaches to the management of land holdings in rural areas.

1.2 Legal Implications

1.2.1 Paragraph 6.3 of Planning Policy Statement 12 (PPS12) allows for supplementary guidance to be produced by other bodies including AONB committee. The Guide to Good Practice has already been approved by the Kent Downs AONB Joint Advisory Committee for use within the Kent Downs area and is commended to district councils for adoption for development control purposes. Its has been subject to wide consultation by the AONB unit.

1.3.1 This Guide is based on a SEEDA funded study and has been prepared and funded by the Kent Downs AONB Unit. There has been no additional financial contribution from Tonbridge and Malling Borough Council.
