Mrs Marion Cole Birch Crescent	Now that there is a traffic light controlled crossing, is it not possible to remove the awful old footbridge as happened at Ditton?	The unsympathetic nature of the footbridge and the fact that it significantly detracts from the setting of the Conservation Area is noted in the Appraisal. However, it acknowledges that it is most unlikely in the foreseeable future that it will be dismantled since the cost of doing so would be high. The circumstances at Ditton Corner were different because the bridge had been damaged in an accident and other improvements to the junction were proposed. Nevertheless, the environmental benefits of removing the bridge will be drawn to the attention of the Highway Authority as will the mitigation measures mentioned in the Appraisal.
