Summary

1.1 Introduction

- 1.1.1 The Management Team report to the Finance and Property Advisory Board on the 5 October 2005 detailed the background and process of Post Implementation Review (PIR) for capital projects and adopted a standard template for reporting to the appropriate board.
- 1.1.2 The completed templates for the above listed PIR's are attached at **Annex 1 to Annex 4** respectively.
- 1.1.3 All schemes have in their own way fulfilled the expectations and have been generally well received.
- 1.1.4 The schemes undertaken in accordance with the Parking Action Plan have each achieved a clear and balanced comprehensive package of parking controls to manage public expectations.

The Winter Emergency Vehicle has enabled the authority to maintain an operational presence in the main council buildings during periods of snowy weather. It has also been able to grit car parks in conjunction with snow clearance activities

The Countryside Partnerships Initiatives in Areas of Outstanding Natural Beauty (AONB), also known as the Landscape and Biodiversity Enhancement Grant, has enabled landowners within the Kent Downs AONB to access funding for projects to enhance landscape and biodiversity based on a match funding basis. The scheme has been successful in delivering enhancements including the restoration of chalk grassland, cobnut plats and woodland and also hedgerow planting throughout the Kent Downs AONB. It has also contributed to positive partnership working with the Kent Downs AONB Unit, the Medway Valley Countryside Partnership, Natural England and local landowners.
