**1 ROAD TRANSPORT MATTERS**

**Summary**

**This report provides an update on a range of road transport issues affecting the Borough.**

**1.1 Introduction**

1.1.1 At the last meeting the Board considered various reports on transportation issues currently affecting the Borough. This report provides an update on matters previously discussed together with some information relating to the Tonbridge Transportation Strategy and some feedback on a meeting of the Joint Parish Councils Transport Consultation Group.

**1.2 Local Parking Studies**

1.2.1 Phase 6B of our parking programme will be formally advertised shortly following a comprehensive informal consultation as set out in the September report to the Joint Transportation Board.

1.2.2 The parking review for West Malling was the subject of public consultation earlier this year and will have been considered by the West Malling Local Parking Plan Steering Group after this report was written. I will give an oral update on progress at the meeting. Any proposals coming forward from this work will be reported to the Board for decisions on implementation in due course.

**1.3 Tonbridge Transport Strategy**

1.3.1 In September the Director of Kent Highways & Transportation and I reported to the Joint Transportation Board outlining a proposed shift in the transport strategy for Tonbridge Town Centre away from the aspiration to redistribute traffic from the High Street. The intention now is to provide better management of the current road structure through improved signalling, signing and some relatively modest and more achievable engineering works which would ease the flow of traffic in and around the town centre. Table 1 (**Annex 1**) sets out the objectives and proposed approaches for achieving the new Transport Strategy. Further reports will be

made to the Joint Transportation Board as the detailed programme to implement this strategy is developed in consultation with local Members.

- 1.3.2 I am conscious that significant interest has been expressed locally in Tonbridge about bus the importance of bus transport to serve the town. In particular I am very much aware that during the first weeks of the new academic year some difficulties were experienced by school children not being able to access services due to apparent capacity issues. I have asked the County Council for a report to be submitted to the Joint Transportation Board in order to outline the way in which the organisation and provision of bus services works in connection with school travel and how the relationship between KCC and bus operators works in planning services.

#### **1.4 The Joint Parish Councils Transport Consultation Group**

- 1.4.1 This Joint Parish Councils Transport Consultation Group (JPCTCG) met at the end of September and received a presentation from Tim Shaw, Chairman of the J5 Slips Committee. This group is, amongst other things, campaigning for east facing slips at junction 5 of the M25. Its aim is to promote and lobby for practical support to assist in enabling the building of these slip roads which would allow full road connectivity in all directions at the M25/M26/A21 interchange and a consequential reduction in traffic along the A25 through several villages including Borough Green. #### **1.5 A21 Tonbridge to Pembury Dualling Scheme - Public Inquiry**

- 1.5.1 The Transport Minister Stephen Hammond has just announced that the Department for Transport will shortly restart the statutory process for the proposed multi-million pound widening of the A21. This is excellent news and should now pave the way for construction work to begin in 2015, subject of course to the release of funds. Officers will be liaising with the Highways Agency, Kent County Council, Tunbridge Wells Borough Council and others in the course of the inquiry preparations. The news release issued by the Highways Agency can be found in **Annex 2**.
