# 1 REVIEW OF THE WEST KENT HOMELESSNESS STRATEGY

## Summary

This report presents the draft West Kent Homelessness Strategy for the period 2011-2016. It has been developed in partnership with Tunbridge Wells Borough Council, Sevenoaks District Council and partner agencies that provide advice and services to households across West Kent.

#### 1.1 Introduction

- 1.1.1 Members will recall that the current West Kent Homelessness Strategy, Towards 2010 was endorsed for adoption in July 2007. Originally developed to cover a three-year period, it would have been due for review in July 2010. However, in July 2009 approval was given to deferring the review for one year and proceeding instead with a refresh of the original action plan. The action plan was duly reviewed and it was approved in July 2010 to cover the twelve months to July 2011.
- 1.1.2 In September 2010 the three West Kent authorities commissioned consultants WK Consulting to co-ordinate and lead a review of homelessness across West Kent; and to develop and write a homelessness strategy and action plan for implementation by July 2011.
- 1.1.3 The development of the draft strategy has been closely overseen by a project team of senior staff from within the housing service of each authority; and in consultation with the housing options teams, key partners and stakeholders including current and former customers.
- 1.1.4 It will be noted that parts of the draft strategy are not fully completed. Specifically the Foreword (which will be added to the final version following the forthcoming two-month consultation); an outstanding case study to section six; and parts of the draft Action Plan which will be completed by officers during March and April.
- 1.1.5 A copy of the draft strategy is attached at [Annex 1].

# 1.2 Next Steps

- 1.2.1 The draft strategy will be made available for further comment by key partners and stakeholder during March and April. It will also be made available on the web sites of the three authorities during this period.
- 1.2.2 Thereafter it will be finalised and submitted to Members for approval:
  - Strategic Housing Advisory Board 7 June 2011;
  - Cabinet 22 June 2011; and
  - Council 12 July 2011.

## 1.3 Legal Implications

1.3.1 The *Homelessness Act 2002* places a statutory duty on all local authorities to publish a homelessness strategy. This duty is disapplied by the Local Authorities *Plans and Strategies (Disapplication) (England) Order 2005* to local authorities that are rated as excellent. The three West Kent authorities are all rated as excellent, and as such need not publish a homelessness strategy. However, none consider the absence of a homelessness strategy to represent good practice.
