1 KENT FORUM HOUSING STRATEGY REFRESH: CONSULTATION REPONSE

Summary

The Council's response to the consultation on the refresh of the Kent Forum Housing Strategy has been prepared in consultation with the Cabinet Member for Housing and the Cabinet Member for Planning and Transportation. It was submitted in time for the consultation deadline on 23 May 2012, having been considered by Management Team on 15 May. Members are invited to retrospectively endorse the response.

1.1 Introduction

- 1.1.1 The Kent Forum Housing Strategy was launched in May 2011. The Government has since introduced significant policy and legislative changes, and the strategy has been updated accordingly. It will be published in October 2012.

- 1.1.3 We are satisfied that the strategy presents a more cogent case of the key housing issues facing all authorities on behalf of communities across Kent. In particular, it makes the case for local housing authorities to be able to develop new funding models for the future delivery of both social and affordable rent housing, assist first time buyers, tackle issues in the private housing sector, meeting rural housing needs and the needs of more vulnerable households. Where, in our view, the strategy strays into difficulties, is how it purports to promote a number of wider planning issues such as Community Infrastructure Levy (CIL) and especially Neighbourhood Planning. It is simply over-optimistic on the prospects of using these mechanisms to generate future funding or affordable housing development

opportunities. These points are picked up within the more detailed comments we suggest in our response
