

Question regarding reinstatement of List D in Planning

Subsequent to the publication of the agenda for Parish Partnership Panel of 21 November 2024, a question had been received from Hadlow Parish Council in respect of the reinstatement of List Ds for planning applications, and a response had been provided by the Head of Planning (James Bailey), as follows:

Response:

“Following requests from some Parish Council about the re-instatement of List D, unfortunately with our current software this is not possible, however you can use the TMBC planning portal to search for determined and registered applications which can be exported into an excel spreadsheet by following the attached instructions.”

Searching for Determined & Registered Applications

From the Home Page select **Planning**

Select **View applications and submit comments**

From there select **View Applications And Submit Comments**

View and comment on applications

To view applications, search by using the application numbers, for example 23/01474 and remove the code, for example FLMAJ. If you have any queries email us at planning.applications@tmbc.gov.uk

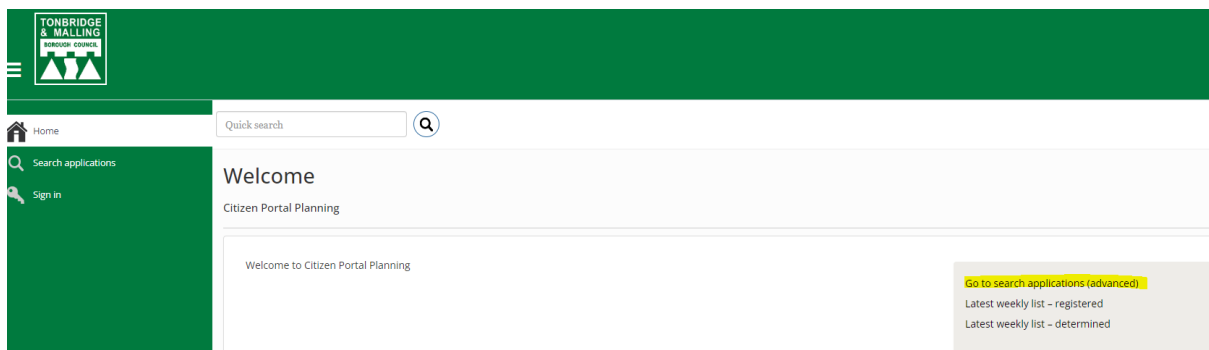
