TCF 25/14 APPOINTMENT OF CHAIR AND VICE CHAIRS

The appointments of Borough Councillors were confirmed. A nomination of Vice Chair from community representatives was received from Mark Ansdell. As there were no further nominations received, the community representatives agreed that Mark Ansdell be duly appointed as the second Vice Chair of the Tonbridge Community Forum.

TCF 25/15 NOTIFICATION OF SUBSTITUTE MEMBERS

There were no substitute Members nominated for this meeting.

TCF 25/16 MINUTES

RESOLVED: That the Minutes of the meeting held on 24 February 2025 be approved as a correct record and signed by the Chairman.

TCF 25/17 UPDATE ON ANY ACTION IDENTIFIED IN THE LAST MINUTES

Minute Number TCF 25/3 (meeting held on 24 February 2025) – Update on Access to Cash

Sally Pearce provided an update on the 'Access to Cash' campaign during which Members were advised that the Banking Hub had been approved and the location for the Hub had been identified. The Forum expressed their gratitude to Ms Pearce.

TCF 25/18 MEMBERSHIP OF THE TONBRIDGE COMMUNITY FORUM

Members noted that the organisations for EMBER and Tonbridge and Malling Seniors had ceased to exist and therefore were no longer members of the Tonbridge Community Forum; and the appointment of Scotts Project Trust as a member of the Forum was agreed.

TCF 25/19 IMAGO COMMUNITY

Following an invitation from the Forum, Lysette D'Urso, Community Development Co-ordinator provided a brief overview of Imago Community whose services supported vulnerable adults and those in caring roles to maintain independence, navigate challenges and improve overall wellbeing. The organisation offered information, guidance, activities and support to meet people's needs, along with access to a range of community, health and social care services.

TCF 25/20 KENT POLICE UPDATE

Members received an update from Kent Police on neighbouring policing and recent initiatives and operations.

Concern was raised regarding the high level of shoplifting in the town, in particular in and around Cannon Lane. Members asked that consideration be given to the deployment of mobile CCTV in areas where there was a high level of crime.

Members discussed the traveller encampment at Salisbury Road and recognised the joint effort of the Police and the Local Authority in raising the court order and took the opportunity to thank Waste Services for their work in removing the waste that had been left on the land.

MATTERS RAISED IN ADVANCE OF THE MEETING

TCF 25/21 HIGHWAY IMPROVEMENT PLANS

Members received a briefing note that provided an introduction to the Highways Improvement Plans. The Highways Information Pack was currently in the process of being updated for 2025/26 and the pack

circulated was the most up to date version available. Officers had advised that the best way for the public to input into the Highways Improvement Plan for their areas was to contact their Parish/Town Council or County Member in an unparished area such as Tonbridge.

TCF 25/22 PAVEMENT PARKING

An item on pavement parking and the impact of safe walking had been requested by Tonbridge Bicycle Users Group, in particular pavement parking on the High Street. County Councillor Mark Hood advised that he had raised the enforcement of illegal parking with the Borough Council and the County Councillors had allocated funding for a number of trees to be introduced on the junction in the hight street, and the installation of bike stands and benches, to prevent future pavement parking.

TCF 25/23 SAFE CROSSING OF PEMBURY ROAD

Tonbridge Bicycle Users Group had requested a discussion on the safety of school children crossing side roads along Pembury Road. Previously Pembury Road had been restricted to a 20mph limit which had helped to slow traffic, however this speed limit had subsequently been removed, whilst the 20mph limit on the side roads had remained. Concern was raised that vehicles were not given priority to pedestrians crossing the side roads and the safety of school children. During discussion it was suggested that the use of Speed Watch be considered to generate data that supported a change in speed limit to revert Pembury Road back to a 20mph speed limit.

TCF 25/24 ACCIDENT HOT SPOT - THE RIDGEWAY AND HADLOW ROAD JUNCTION

Tonbridge Bicycle Users Group raised concern regarding the accident hot spot at the junction of the Ridgeway and Hadlow Road. During discussion it was noted that the installation of dragon teeth markings has had an impact on reducing driver speeds, however the impact had not been sufficient. County Councillor Mark Hood would identify if there were any resources available on Vision Zero, a road safety strategy aimed at eliminating deaths and serious injuries on roads, to educate drivers.

TCF 25/25 TOWN CENTRE REDEVELOPMENT

Members received an update on the town centre development during which Councillor Adem Mehmet reported that he had been appointed as Cabinet Member for Infrastructure and Tonbridge Regeneration. The central location of the new leisure facility had been confirmed as Sovereign Way Mid Car Park however the design of the new leisure centre had yet to be confirmed. Councillor Mehmet provided assurance

that consideration would be given to the archaeological period of the site.

TCF 25/26 PROMOTION OF UPCOMING EVENTS

(1) Council Events

Members were advised that all events booked in with the Council to be held on its open spaces were available to view on the Councils website - https://www.tmbc.gov.uk/events. Recent events included the VE Day Community event held on 4 May 2025 and the VE Day Commemorative Beacon lighting on 8 May 2025. The VJ Day Commemorative Beacon lighting would take place on 15 August 2025 and the Asian Market continued to be run every forth Sunday from April to November.

(2) Tonbridge Lions Community Fete

The annual Tonbridge Lions Community Fete would be held on the Castle Lawn on 1 June 2025 and would include a parade themed 'Read All About It'. This year, there would also be an attempt at a Guiness World Record for odd socks and a request was made for volunteer counters.

(3) Tonbridge Town Council

Members were encouraged to respond to the Council's consultation on a Tonbridge Town Council. The consultation would run for six weeks up until 14 July.

(4) Rotary Club Classic Car Event

The Rotary Club Classic Car show would be held on 21 June 2025, 10am – 4.00pm, at Tonbridge Castle. There was free entry to the event, although charity donations were requested.

(5) Supercar Charity Rally

Over 100 cars would gather on the 29 June 2025 at Tonbridge Racecourse Sportsground.

(6) Tonbridge Pride

Members were informed that Tonbridge Pride would be held on 9 August 2025 and were invited to join the town's vibrant LGBTQ+ community for a fun filled day of celebration and acceptance.

(7) Football Fiesta

The football fiesta would be held at Tonbridge Race Course on 18 and 19 June 2025.

(8) Tonbridge Historical Society

A schedule of talks for 2025-26 would be available to view on the Tonbridge Historical Society website from the beginning of June.

TCF 25/27 ANY OTHER BUSINESS

(1) Devolution

Members sought an update on devolution and were advised the Council had submitted its initial proposals for new Unitary Councils across Kent and Medway as part of the Government's Local Government Reorganisation Programme.

(1) The use of Cycle Lanes

Concern was raised regarding the use of cycle lanes and noted that until there was a cycling infrastructure, cyclists would continue cycling on pavements due to the dangers of cycling on the roads. County Councillor Mark Hood advised that the Active Travel Plan would form part of the Local Plan and involvement would be sought from Tonbridge Bicycle Users Group.

(2) S106

The Chair advised that she would be submitting a response on the Tonbridge Infrastructure by the deadline of 1 June 2025.

MATTERS FOR THE BOROUGH COUNCIL

JTB 25/10 PARKING ACTION PLAN - PHASE 15 (INFORMAL CONSULTATION)

(Decision Notice D250069MEM)

The report of the Director of Street Scene, Leisure and Technical Services provided an update on the progress of Phase 15 of the Borough Council's Parking Action Plan and detailed the outcomes arising from the informal consultation, undertaken between 18 February and 16 March 2025.

A list of all the locations, the issues raised and a summary of the responses received were attached at Annex 1 and the plans for each location were attached at Annex 2. A location summary and a more detailed response rate and analysis, and recommendation for each location were attached at Annex 3.

The views of local members were sought and where appropriate and/or practical these would be reflected in the final proposals.

In addition, reference was made to the proposal to reintroduce single yellow line parking restrictions at Common Road, Blue Bell Hill, as part of Phase 14 of the Council's Parking Action Plan. It was noted that no objection had been received following a full public consultation and therefore the scheme would proceed to implementation subject to a decision being taken by the Cabinet Member.

RECOMMENDED*: That

- (1) the recommendations in respect of locations Phase 15-01, 15-03, 15-06, 15-07, 15-09, 15-10, 15-14, 15-15, 15-16, 15-21 & 22, 15-24 and 15-30 for Phase 15 (as set out in Annex 1) be taken forward for investigation and formal consultation;
- (2) the views of local Members having been sought, the following revised recommendations be taken forward for investigation and formal consultation:
 - (i) location Phase 15-08 (The Rocks Road (near Paris House), East Malling) introduction of 'No waiting at any time' parking restrictions (double yellow lines) based on a revised plan in order that small gaps could be retained for residents parking and parking at access locations could be restricted:
 - (ii) location Phase 15-18 (Charles Close, Snodland) extension of the proposed double yellow lines to one end of the road, taking into account any highway boundary issues;

- (iii) location Phase 15-27 (Robin Hood Lane, Walderslade) amendment of the proposed restriction to single yellow line, extended to the far cul-de-sac end of the road; and
- (iv) location Phase 15-29 (Worrall Drive, Wouldham) restrictions to manage parking at Peters Village, subject to further discussion between Officers and the local Members to agree a revised plan for formal consultation, taking into account proposals for restriction in the area by Kent County Council and highway boundary issues;
- (3) the recommendations in respect of locations Phase 15-02, 15-04, 15-05, 15-11, 15-12, 15-13, 15-17, 15-19, 15-20, 15-23, 15-26 and 15-28 for Phase 15 (as set out in Annex 1) be abandoned; and
- (4) it be noted that the parking restriction proposed for location Phase 15-25 had already been completed in Phase 14.

JTB 25/11 HILDENBOROUGH PARKING REVIEW

(Decision Notice D250070MEM)

Members received an update on the outcome of the formal consultation on the Hildenborough Parking Review and considered whether proposals should be implemented or abandoned.

Due regard was given to the responses received and it was noted that whilst there might have been a need for a wide scale parking review prior to the coronavirus pandemic, the need for intervention had significantly diminished as working from home arrangements and the desire to commute by train had altered. As a result the proposals had been revised significantly at informal consultation stage in respect of reducing residential parking permits and elements of on-street pay parking, prior to a formal consultation undertaken in January 2025.

RECOMMENDED*: That

- (1) the objections received for proposals shown for Riding Lane (North) (Location 2), Stocks Green Road (East) (Location 9) and Watts Cross Road and B245 London Road (Location 12) be set aside and parking restrictions at these locations proceed for implementation, subject to the effect of the agreed reduced restrictions set out as follows:
 - (i) Riding Lane / Riding Park junction new "junction protection" double yellow lines for 15m in each direction;

- (ii) Leigh Road (opposite Stocks Green Road) replacing existing single yellow lines with double yellow lines; and
- (iii) Watts Cross Road and B245 London Road new double yellow lines at the junction of Watts Cross Road and B245 London Road, extending southeastwards to the northwestern side of Foxbush (on the northeast side) and to the northern side of Noble Tree Road (on the southwest side).
- (2) the objections at all other locations be upheld and those parking restriction proposals be abandoned, including Ashley Road (Location 3) which was originally recommended for implementation by Officers.

MATTERS SUBMITTED FOR INFORMATION

JTB 25/12 HIGHWAYS FORWARD WORKS PROGRAMME 2025/26

The report of the Kent County Council Highways and Transportation summarised schemes programmed for delivery in 2024/25 and 2025/26. The report provided an update on Road, Footway and Cycleway Renewal and Preservation Schemes (Appendix A), Drainage Repairs and Improvements (Appendix B), Street Lighting (Appendix C), Transportation and Safety Schemes (Appendix D), Developer Funded Works (Appendix E), Bridge Works (Appendix F), Traffic Systems (Appendix G), Combined Members Grant (Appendix H) and Road Markings (Appendix I).

A clarification was sought on the road names where street lighting column replacements had been identified in Borough Green by way of a map to be provided by Kent County Council.

Members were provided with details about the methodology used in the micro resurfacing and surface dressing, in response to a query raised on inconvenience caused to the users during the surface settlement period and any specific concerns regarding pre-patching were invited to be raised with Kent County Council Highways directly.

Planned footway improvements in Vauxhall Ward were welcomed by ward Members and it was suggested that consideration should be given to sequencing the work on the plan and avoiding working on Deakin Leas during school term time.

Lastly, a query was raised in respect of the A20 London Road/Hall Road Aylesford Junction Improvement Scheme and it was noted that Kent

County Council had decided not to proceed with this scheme but to use the funding to support other schemes.
