#### 1 <u>PETITION – KEEP RIVER LAWN GREEN</u>

#### Summary

This report presents Members with a petition submitted on behalf of the Keep River Lawn Green organisation. The petition relates to intended disposals of land owned by the Council at River Lawn Road and at 1-4 River Walk, Tonbridge.

#### 1.1 Introduction

- 1.1.1 On 2 June 2017 the Council received via email a petition on behalf of the Keep River Lawn Green organisation.
- 1.1.2 The petition calls on the Borough Council to 'stop their plans to sell off River Lawn and old CAB building in River Walk until a proper public consultation has been held.' The petition also comments as follows –

'It has emerged that they plan to sell the River Lawn itself and allow luxury flats to be built there. This will not help to reduce the waiting list for families in need of housing and it is unacceptable to build on our recreational land.

The River Lawn and former CAB building are being redeveloped to provide riverside apartments. When we need homes for over 900 families waiting to be housed in Tonbridge & Malling they are providing them for the highest bidders'

- 1.1.3 It is not known what status the 'Keep River Lawn Green' organisation has.
- 1.1.4 At the time of initial submission the petition had 1,576 signatures. On 3 July the Barden Road Residents Association submitted an electronic copy of the petition on behalf of Keep River Lawn Green, with 1,617 signatories (attached as Annex 1), together with a separate paper petition containing a further 1,601 signatures. The provisional total is therefore 3,218, although it is not been possible to verify (as of 3 July) the total number, or whether the 2 versions of the petition contain any duplicate signatures.
- 1.1.5 A copy of the paper petition will be made available for Members to view prior to the Council meeting.

- 1.1.6 In accordance with the Council's adopted petition scheme (a copy of which is attached as **Annex 2**), petitions containing more than 1,500 signatures will be debated by the Full Council. The petition organiser will be given 5 minutes to present the petition at the meeting and the petition will then be discussed by Councillors for a maximum of 15 minutes.
- 1.1.7 In the present case, the issue being raised in the petition is one on which the Council's Cabinet is required to make the final decision. The role of the Council is therefore limited to a decision as to whether to make recommendations to the Cabinet to inform that final decision. In accordance with the Petition Scheme Council may recommend the following:
  - to take the action requested
  - not to take the action requested, for reasons put forward in the debate
  - to commission further investigation into the matter
- 1.1.8 The petition organiser will receive written confirmation of the decision reached and this will also be published on the Borough Council's website.

#### 1.2 Background

- 1.2.1 For the assistance of Members the background to the issue raised in the petition is set out below.
- 1.2.2 On 9 February 2017 the Cabinet considered the report of the Management Team in relation to the strategic asset review of Tonbridge Town Centre. A copy of the report is attached as **Annex 3**. Members are reminded that due to the commercial nature of the proposals set out in the report, details of the financial arrangements and the terms of any proposed agreements are set out in the private annexes under the provisions of Schedule 12A to the Local Government Act 1972.
- 1.2.3 The report provided Members with an update on the progress of negotiations with the Tonbridge Medical Group and developers acting on their behalf (Assura) to purchase land at River Lawn Road (on the site of the Teen and Twenty Club) for the purposes of constructing a new medical centre. These proposals had previously been reported to Cabinet in March 2015.
- 1.2.4 The report also set out further proposals to dispose of land adjacent to the site of the proposed medical centre and vacant office land at 1-4 River Walk. The latter of these sites was formerly occupied by the Citizens Advice Bureau and a private company, both of whom had vacated the building to occupy other properties owned by the Council. The Citizens Advice Bureau moved in the summer of 2016 to Tonbridge Castle, with the private company (Jawatte) having relocated to the Gibson Building at Kings Hill at around the same time.

- 1.2.5 For the assistance of Members, photographs of the sites in question are attached as Annex 4. These include aerial photographs of the open space at River Lawn and adjoining areas of open space owned by the Borough Council.
- 1.2.6 At the meeting on 9 February Cabinet authorised the Director of Central Services to
  - (a) complete the contract for the sale of freehold land with Assura on terms substantially as set out at Annex 3 to the report together with all other necessary agreements in order to implement the proposals, including the Car Parking Lease and the Compound Lease. Any amendments to the documents at Annex 3 to be agreed in consultation with the Leader and Deputy Leader;
  - (b) advertise the intention of the Borough Council to dispose of the River Lawn Land;
  - (c) Subject to the completion of the agreement(s) with Assura under (a) above and the receipt of no objections in response to (b) above, proceed with the disposal of the River Lawn Land (shown edged in red and marked '3' on the plan at Annex 1 to the report) as set out in paragraph 1.7 of the report, such authority to include (but not be limited to) advertisement of the land, negotiation of terms and completion of any necessary legal agreements; and
  - (d) Proceed with the disposal of land at River Walk (shown edged in red on the plan at Annex 5) as set out in paragraph 1.8 of the report, such authority to include (but not be limited to) advertisement of the land, negotiation of terms and completion of any necessary legal agreements

#### 1.3 Consultation on intended disposal of open space land at River Lawn Road

- 1.3.1 Officers advertised the intended disposal of open space land at River Lawn Road via public notices in the Kent Messenger on 24 February, 3 March, 23 March & 30 March 2017. The notices also appeared in the online edition of the newspaper (Kent Online) and on the Council's website.
- 1.3.2 The notices placed in the Kent Messenger on 24 February and 3 March related to a small area of the open space at River Lawn Road required in connection with the proposed medical centre development. A plan showing the extent of this area is attached as **Annex 5**. The land in question covers an area of 432 sqm.
- 1.3.3 The notices placed in the Kent Messenger on 23 March and 30 March related to the larger area of open space at River Lawn Road. A plan showing the extent of this area is attached as **Annex 6**. This land covers an area of 2184 sqm.
- 1.3.4 The notices met the requirements of section 123 of the Local Government Act 1972, which provides that a principal council may not dispose of any land consisting or forming part of an open space unless before disposing of the land they cause notice of their intention to do so, specifying the land in question, to be

advertised in two consecutive weeks in a newspaper circulating in the area in which the land is situated, and consider any objections to the proposed disposal which may be made to them.

- 1.3.5 The Council is under no legal obligation to advertise the intended disposal of land at 1-4 River Walk, as it is not held as public open space. In that regard the Council is in no different a position to any other landowner. No public advertisement was therefore given in relation to this proposed sale.
- 1.3.6 The Council received no objections to the notices pertaining to the smaller area of open space i.e. that detailed at paragraph 1.3.2 above.
- 1.3.7 The Council received a total of 59 objections to the statutory notices pertaining to the larger area of open space at River Lawn Road. Cabinet is required to consider these before any final decision can be made about disposal of the area of open space in question. The objections were due to be considered by Cabinet at its meeting on 28 June but in light of receiving the petition on 2 June 2017 it was felt appropriate to defer consideration until after Council had first determined whether it wished to make any recommendations to Cabinet to inform that decision. The objections will be considered at the next meeting of Cabinet.
- 1.3.8 In summary, the issues raised within the objections are as follows:-
  - Loss of green space
  - Impact on public services serving the area (Schools, Doctors)
  - Lack of or incorrect public consultation
  - Improvements required to River Lawn
  - Flooding / drainage concerns
  - Objection to flats being constructed
- 1.3.9 Members are reminded that any development proposals arising from the disposal of any site referenced in this report will need to be the subject of conventional planning applications, including public consultation in the normal way and any applications will be determined by the Area Planning Committee.

#### 1.4 Other considerations

Members will be aware that the Council has led on the delivery of a number of recent projects designed to enhance Tonbridge Town Centre and to encourage local growth. These are summarised below.

#### River Walk Improvement Scheme

1.4.1 The recent enhancement of the surfacing and street furniture will encourage more people to use the riverside walk and will promote the use of shops and amenities in and around the town centre.

#### Tonbridge Memorial Gardens

1.4.2 A capital plan scheme for refurbishment of this area was undertaken during 2014 in consultation with the Tonbridge Memorial Garden Trust. The company appointed to deliver the scheme later won an award in the British Association of Landscape Industries (BALI) National Landscape Awards

#### Tonbridge High Street

1.4.3 Members will recall that a significant scheme for improvement of Tonbridge High Street was delivered during 2016 in partnership with Kent County Council. The key elements of the scheme included widened footways, a 20mph speed limit, environmental improvements and improved street furniture.

#### Town Lock

1.4.4 A scheme for enhancement of the open space adjacent to the river was undertaken in partnership with the Environment Agency during 2015/16. This scheme provided a high quality area of open space, a boathouse for use by the Environment Agency and river users and a new telemetry station to provide the Agency with information on river levels. It also ensured that important works could be undertaken to maintain flood defence levels.

## 1.5 Site of former Teen & Twenty Club, River Lawn Road – Tonbridge Medical Group

- 1.5.1 The proposed sale of land to Assura for the development of a medical practice has progressed since the Cabinet meeting on 9 February, with agreements for sale of the freehold shortly due for exchange.
- 1.5.2 At the time of preparing this report the CCG had announced that they were to hold a public exhibition at the Angel Centre on 5 July 2017 to invite the public to view their proposals for the medical centre.
- 1.5.3 Subject to obtaining the necessary planning consent, we understand that building work on site would commence during the spring of 2018.
- 1.5.4 The agreement for sale with Assura includes the smaller area of open space referred to in paragraph 1.3.2 above.

#### 1.6 1-4 River Walk

1.6.1 In accordance with the resolution of Cabinet dated 9 February 2017, Officers proceeded to instruct Hartnell Taylor Cook LLP to act on behalf of the Council in progressing the advertisement and disposal of 1-4 River Walk. However, no steps

have been taken to market the property pending the outcome of the consideration by Council of the petition.

- 1.6.2 It is intended that the disposal of this site will take place via tender, so as to achieve the best price available on the open market (see paragraph 1.7 below for the duty to obtain best value). It will therefore be perfectly possible for any interested party to bid for the land, including any social housing provider. Subject to obtaining planning permission, a social housing provider would be able to develop the site for either a mix of private and affordable housing or solely for affordable housing should it wish to do so. The disposal of the site does not preclude a number of possible uses being pursued, subject of course to obtaining the appropriate planning consent.
- 1.6.3 Should Council decide not to make any recommendations to Cabinet for further action in response to the petition then the marketing of the site would commence without further delay.
- 1.6.4 It is not proposed to repeat in this report the rationale for disposal of 1-4 River Walk, this having been set out in the previous report to Cabinet dated 9 February 2017. The supporting development appraisal for disposal was included in a private annex to that report (Annex 7).

#### 1.7 Financial and Value for Money Considerations

- 1.7.1 In accordance with Section 123 of the Local Government Act 1972, the Council must not, except with the consent of the Secretary of State, dispose of land (other than by way of a short tenancy) for a consideration less than the best that can reasonably be obtained. The overriding consideration in determining what constitutes the best consideration that can reasonably be obtained is the commercial value of the disposition to the authority.
- 1.7.2 The specific financial considerations arising from the proposals were set out in a private annex to the report to Cabinet (Annex 4 to the report dated 9 February 2017).
- 1.7.3 It is intended that any capital receipts obtained from the sale of the land detailed in this report would be re-invested into property investment funds, so as to provide a long term revenue stream to support the continued delivery of services. The use of property funds for long term investment was previously considered and endorsed by the Audit Committee, Cabinet and Council during January and February of this year, with the use of such funds authorised for inclusion in the Annual Investment Strategy for 2017/18.
- 1.7.4 Members will also be aware that 'Asset Management' is one of the themes of the adopted Savings and Transformation Strategy 2016/17 to 2020/21 (which sits alongside the Medium Term Financial Strategy). A key consideration for the Council in the delivery of this theme is to consider the opportunities to realise capital and/ or increased income streams from our existing asset base. The

proposals in relation to River Lawn and River Walk are therefore directly relevant to this theme.

#### 1.8 Legal Considerations

1.8.1 Cabinet is required to consider the objections received in response to the statutory notices relating to the proposed sale of the larger area of open space at River Lawn Road (as set out in paragraph 1.3.7). This must be done before any final decision is taken on the disposal.

#### 1.9 Risk Assessment

1.9.1 Any financial risks arising in connection with the proposals were considered in Annex 5 to the report to Cabinet dated 9 February 2017.

#### 1.10 Equality Impact Assessment

1.10.1 The proposed medical centre scheme will deliver considerable benefits to the community. As such, the scheme will provide a positive contribution to promoting equality. As specific elements of the development programme are taken forward, detailed consideration will be given to ensure potential impacts are identified and, where appropriate, action is taken to mitigate them in accordance with the Equality Act 2010 and supporting guidance.

#### 1.11 Recommendation

1.11.1 Members are requested to consider the petition at Annex 1 and decide whether they wish to make any recommendations to Cabinet.

### **Tonbridge and Malling Borough Council – Petition Scheme**

The Borough Council welcomes petitions and recognises that petitions are one way in which people can let us know their concerns. All petitions sent or presented to the Council will receive an acknowledgement from the Council within 10 working days of receipt. This acknowledgement will set out how the petition is to be dealt with. We will treat something as a petition if it is identified as being a petition or if it seems to us that it is intended to be a petition.

Paper petitions can be sent to:-

Or, from 15 December 2010, in electronic form if created, signed and submitted online by following a procedure to be introduced for the purpose and to be set out on the Council's website.

Petitions can also be presented to a meeting of the Council. These meetings take place on a regular basis and dates and times are published by Notice and on the Council's website. To present a petition to the Council in person, or to request your Councillor or someone else to present it on your behalf, please contact our Democratic Services team on 01732 876025 at least 10 working days before the meeting and they will talk you through the process.

If your petition has received 1500 signatures or more it will be scheduled for debate at Full Council in any event. If this is the case we will let you know whether this will happen at the same meeting you present your petition or at a later meeting of the Council.

#### What are the guidelines for submitting a petition?

Petitions submitted to the Council must include:-

- a clear and concise statement covering the subject of the petition . It should state what action the petitioners wish the Council to take
- the name and address and signature of the persons supporting the petition

Petitions should be accompanied by contact details, including an address, for the petition organiser. This is the person we will contact to explain how we will respond to the petition. The contact details of the petition organiser will not be placed on the Council's website.

If the petition does not identify a petition organiser, we will contact signatories to the petition to agree who should act as the petition organiser.

Petitions which are considered to be vexatious, abusive or otherwise inappropriate will not be accepted.

In the period immediately before an election or referendum we may need to deal with your petition differently – if this is the case we will explain the reasons and discuss the revised timescale which will apply.

If a petition does not follow the guidelines set out above, the Council may decide not to do anything further with it. In that case, we will write to you to explain the reasons.

#### What will the Council do when it receives my petition?

An acknowledgement will be sent to the petition organiser within 10 working days of receiving the petition. It will let them know what we plan to do with the petition and when they can expect to hear from us again. It will also be published on our website.

If we can do what your petition asks for, the acknowledgement may confirm that we have taken the action requested and the petition will be closed. If the petition has enough signatures to trigger a Council debate, or a senior officer giving evidence, then the acknowledgment will confirm this and tell you when and where the meeting will take place. If the petition needs more investigation, we will tell you the steps we plan to take.

If the petition applies to a planning or licensing application, is a statutory petition (for example requesting a referendum on having an elected mayor), or on a matter where there is already an existing right of appeal, such as Council tax banding and non-domestic rates, other procedures apply and the matter will be dealt with accordingly. Further information on all these procedures and how you can express your views is available on our website.

We will not take action on any petition which we consider to be vexatious, abusive or otherwise inappropriate and will explain the reasons for this in our acknowledgement of the petition.

To ensure that people know what we are doing in response to the petitions we receive, the details of all the petitions submitted to us will be published on our website, except in cases where this would be inappropriate. Wherever possible we will also publish all correspondence relating to the petition (all personal details will be removed). When you sign an e-petition you can elect to receive this information by email. We will not send you anything which is not relevant to the e-petition you have signed, unless you choose to receive other emails from us.

#### How will the Council respond to petitions?

Our response to a petition will depend on what a petition asks for and how many people have signed it, but may include one or more of the following:-

- taking the action requested in the petition
- considering the petition at a Council meeting
- holding an inquiry into the matter
- undertaking research into the matter
- holding a public meeting
- holding a consultation

- holding a meeting with petitioners
- referring the petition for consideration by the Council's Scrutiny Committee\*
- calling a referendum
- writing to the petition organiser setting out our views on the request in the petition

\*The Scrutiny Committee is a committee of Councillors who are responsible for scrutinising the work of the Council – in other words, the Scrutiny Committee has the power to hold the Council's decision makers to account.

In addition to these steps, the Council will consider what specific actions are available to address the issues highlighted in a petition.

The Council's response to a petition will set out the steps we intend to take and the reasons for taking this approach.

If the petition is about something over which the Council has no direct control we will consider making representations on behalf of the community to the relevant body. The Council works with a large number of local partners and where possible will work with these partners to respond to the petition. If we are not able to do this for any reason (for example if what the petition calls for conflicts with Council policy), then we will set out the reasons for this to you. You can find more information on the services for which the Council is responsible on our website.

If the petition is about something that a different Council is responsible for we will give consideration to what the best method is for responding to it. This might consist of simply forwarding the petition to the other Council, but could involve other steps. In any event we will always notify you of the action we have taken.

#### Full Council debates

If a petition contains more than 1,500 signatures it will be debated by the Full Council unless it is a petition asking for a senior Council officer to give evidence at a public meeting.

This means that the issue raised in the petition will be discussed at a meeting which all Councillors can attend. The Council will endeavour to consider the petition at its next ordinary meeting although on some occasions this may not be possible and it will then be referred to the next following meeting.

The petition organiser will be given five minutes to present the petition at the meeting and the petition will then be discussed by Councillors for a maximum of 15 minutes.

The Council will decide how to respond to the petition at this meeting. It may decide to take the action the petition requests, not to take the action requested for reasons put forward in the debate, or to commission further investigation into the matter, for

example by a relevant committee. Where the issue is one on which the Council's Cabinet are required to make the final decision, the Council will decide whether to make recommendations to inform that decision. The petition organiser will receive written confirmation of the decision. This confirmation will also be published on the Council's website.

#### **Officer evidence**

A petition may ask for a senior Council officer to give evidence at a public meeting about something for which the officer is responsible as part of their job. For example, the petition may ask a senior Council officer to explain progress on an issue, or to explain the advice given to elected members to enable them to make a particular decision.

If your petition contains at least 750 signatures, the relevant senior officer will give evidence at a public meeting of the Council's Scrutiny Committee. The senior officers that can be called to give evidence are those officers who are members of the Council's Management Team. Their details can be found on the Council's website.

The Scrutiny Committee may decide that it would be more appropriate for another officer to give evidence instead of any officer named in a petition, for instance if the named officer has changed jobs. The committee may also decide to call the relevant Portfolio Holder to attend the meeting. Committee members will ask the questions at this meeting, but the petition organiser will be able to suggest questions to the Chairman of the Committee by contacting the Democratic Services team at the above address or on 01732 876025 up to three working days before the meeting.

#### **E-petitions**

The Council intends to introduce e-petitions by 15 December 2010. These will be created and submitted through the Council's website. E-petitions will follow the same guidelines as paper petitions.

The petition organiser will need to provide us with their name, postal address and email address and will also need to decide how long the petition is to be open for signatures. Most petitions are expected to run for six months, but you will be able to choose a shorter or longer timeframe, up to a maximum of 12 months.

We expect the following to apply to our e-petitions;

When you create an e-petition, it may take five working days before it is published online. This is because we have to check that the content of your petition is suitable before it is made available for signature. If we feel we cannot publish your petition for some reason, we will contact you within this time to explain. You will be able to change and resubmit your petition if you wish. If you do not do this within 10 working days, a summary of the petition and the reason why it has not been accepted will be published under the 'rejected petitions' section of the website. When an e-petition has closed for signature, it will automatically be submitted to our Democratic Services team. In the same way as a paper petition, you will receive an acknowledgement within 10 working days. If you would like to present your e-petition to a meeting of the Council, please contact Democratic Services as above within 10 working days of receipt of the acknowledgement.

A petition acknowledgement and response will be emailed to everyone who has signed the e-petition and elected to receive this information. The acknowledgment and response will also be published on this website.

All the e-petitions currently available for signature will be on our website.

When you sign an e-petition you will be asked to provide your name, your postcode and a valid email address. When you have submitted this information you will be sent an email to the email address you have provided. This email will include a link which you must click on in order to confirm the email address is valid. Once this step is complete your 'signature' will be added to the petition. People visiting the e-petition will be able to see your name in the list of those who have signed it but your contact details will not be visible.

#### What can I do if I feel my petition has not been dealt with properly?

If you feel that we have not dealt with your petition properly, the petition organiser has the right to request that the Council's Scrutiny Committee review the steps that the Council has taken in response to your petition. The petition organiser must give a short explanation of the reasons why the Council's response is not considered to be adequate.

The Committee will endeavour to consider the request at its next meeting, although on some occasions this may not be possible and consideration will take place at the following meeting. Should the committee determine the Council has not dealt with the petition adequately, it may use any of its powers to deal with the matter. These powers include instigating an investigation, making recommendations to the Cabinet and arranging for the matter to be considered at a meeting of the Full Council.

Once the appeal has been considered the petition organiser will be informed of the results within 5 working days. The results of the review will also be published on our website.

#### **Executive Key Decisions**

#### 1 <u>TONBRIDGE TOWN CENTRE – STRATEGIC ASSET REVIEW</u>

#### Summary

This report updates Members on a strategic review of the Council's principal property assets to the west of Tonbridge High Street and seeks the approval of Members to proceed with proposals to regenerate this area through (1) the sale of land and buildings within the River Lawn area for the purposes of creating a new medical centre and residential accommodation (2) the sale of vacant offices/ land at River Walk.

### 1.1 Introduction

- 1.1.1 Members will be aware that Officers have been conducting a review of Council owned assets within Tonbridge Town Centre with the intention of identifying a range of potential redevelopment opportunities. The aim of the review was to utilise these assets to help add vitality to the town centre as well as optimising their use in terms of service delivery, community benefit and financial return.
- 1.1.2 At a previous meeting of Cabinet on 24 March 2015, Members approved a proposal to progress negotiations for disposal of land within Tonbridge Town Centre following an approach by the Tonbridge Medical Group and developers acting on their behalf to purchase the land for the purposes of constructing a new medical centre.
- 1.1.3 This report updates Members on the progress of these negotiations and seeks approval to complete an agreement for sale of land at River Lawn Road for the development of a new medical centre.
- 1.1.4 The proposed sale of land for the purposes of a medical centre provides an opportunity to use this for community benefit in terms of new healthcare facilities for the town. It will also bring about an improvement to the visual and environmental quality and act as a catalyst for redevelopment of other areas of land within the ownership of the Borough Council in the immediate vicinity. The report also therefore outlines further proposals to dispose of land adjacent to the proposed medical centre and also vacant office land at River Walk, both for the purposes of facilitating the construction of new residential accommodation.

1.1.5 Taken together, the proposals within this report represent an important regeneration opportunity by making beneficial use of land in the heart of Tonbridge Town Centre that can contribute to the economic and community well-being of an area very close to the High Street. They also serve to deliver the following core values within the Council's Corporate Strategy for 2017-2019 –

*Embracing Effective Partnership Working* – achieving more by working and engaging effectively with a wide range of local partners from the private, public, voluntary and community sectors.

*Valuing our environment and encouraging sustainable growth* – keeping our towns, villages and countryside clean and well maintained, planning for our future homes and jobs and seeking investment in economic regeneration and infrastructure.

1.1.6 Due to the commercial nature of the proposals set out in the report, details of the financial considerations and the terms of any proposed agreements are set out in private annexes under Sch 12A to the Local Government Act 1972.

#### 1.2 River Lawn Road

1.2.1 A plan identifying the land owned by the Borough Council within this area is attached as **Annex 1**. The plan identifies 3 separate land holdings as follows –

River Lawn Car Park (Marked '1' on the plan)

The Teen and Twenty Club (Marked '2')

River Lawn Land (Marked '3')

The Council also owns the freehold to the Lamberts Yard Car Park (marked as '4'), although this is not the subject of the proposals within this report. Indeed, it is intended to retain this land for the purposes of car parking.

- 1.2.2 The River Lawn Car Park is operated by the Borough Council, and during the financial year 2015/16 provided an income of £35,000.
- 1.2.3 The Teen and Twenty Club is leased to the Trustees of the Tonbridge Teen and Twenty Club. The lease permits use of the premises as a headquarters for a youth club and youth centre and for social purposes organised for benefit of the members. The most recent lease was entered into on 24 March 2009 for a period expiring on 31 March 2013. The rent payable under the lease is £100 pa. The Club have leased the Site since 1966.
- 1.2.4 Whilst the lease has now expired, the Teen and Twenty Club continue to occupy the premises. The Club are 'holding over' under the terms of the lease under the provisions of the Landlord and Tenant Act 1954.

- 1.2.5 The building occupied by the Teen and Twenty Club is generally regarded as being of poor appearance and amenity value, adding little to the character and appearance of the surrounding area. It is also not easily convertible to alternative uses. There are therefore aesthetic and practical benefits of demolishing the existing building to allow for a redevelopment of the area for a use that will itself bring an improvement to community health care provision. It is also important to note that the County Council has opened a Tonbridge Youth Hub in the Library facilities in Avebury Avenue. This means that there are now two facilities serving the same purpose in very close proximity to each other. Furthermore, the Tonbridge Central Area Action Plan (TCAAP) identifies this site as suitable for a mixed use development subject to the identification and provision of an alternative facility for the Teen and Twenty Club and other users of the building.
- 1.2.6 The River Walk Land is identified in the TCAAP as being underused and potentially threatening, particularly during the evening and at night. The TCAAP notes that it is important to improve this riverside location, providing opportunities for mixed infill to enhance the built form, making a clear distinction between the public front of buildings and the private backs and extend the time the area is used. The area is relatively poorly used and there is potential opportunity for a high quality development to include an attractive treatment and landscaping of the riverside path area. Most latterly the site has been used as a compound for the river related works by the Environment Agency.

## 1.3 **Proposal from Assura Medical Group Ltd**

- 1.3.1 Tonbridge Medical Group currently occupies premises in Pembury Road and Higham Lane, Tonbridge. With the continued expansion of the practice, the existing premises are no longer fit for purpose and NHS England has granted the practice approval to acquire the site of the Teen and Twenty Club at River Lawn and a small part of the adjoining River Lawn Land for the purposes of constructing a new medical centre.
- 1.3.2 The acquisition of suitable premises for a new practice is being taken forward by Assura, who are property developers specialising in acquiring and constructing sites for new medical centres. It is proposed that Assura will acquire the site and construct the medical practice, thereafter leasing the same to Tonbridge Medical Group.
- 1.3.3 The proposed medical centre would be arranged over 3 storeys -

Ground Floor – car parking, main entrance foyer and pharmacy

First Floor – GP reception, waiting and clinical accommodation

Second Floor - staff meeting/ offices/ conference

1.3.4 The proposed gross floor area would be approximately 1400 sqm/ 15000 sqft.

- 1.3.5 It is not proposed to dispose of the River Lawn Car Park to Assura. This would be retained as a public car park, protecting the valuable income stream to the Council. However, Assura would be granted a lease of 5 spaces within the car park for use in connection with the medical practice. These 5 spaces would be delineated in order to ensure a clear separation from those spaces available for public use.
- 1.3.6 The agreement also provides for a contracted out lease to be granted of land at the River Lawn Road car park for a period of up to 2 years for use as a site compound. If a further period is required due to bona fide delays to the construction period then the parties agree to the grant of a further contracted out lease for a maximum period of 1 year.
- 1.3.7 Assura has confirmed that the proposal for a new practice at River Lawn has the full support of the partners of the existing practice.

## 1.4 Terms of the agreement

- 1.4.1 In consultation with the Council's appointed surveyors, Hartnell Taylor Cook (HTC), Heads of Term for the proposed disposal were agreed with Assura on 6 June 2016 (attached as **Annex 2**). These were agreed by the Director of Central Services and the Director of Planning, Housing and Environmental Health in consultation with the Leader and Deputy Leader (as delegated by Cabinet on 24 March 2015).
- 1.4.2 Both the Council and Assura have subsequently instructed Solicitors to negotiate the terms of the contract for sale of the property. These negotiations are now at an advanced stage and a copy of the draft agreement is attached at **Annex 3** together with the supporting Car Parking Lease, Compound Lease and Agreement for Lease between Assura and the Tonbridge Medical Group.
- 1.4.3 The key provisions of the agreement are set out in the private **Annex 4**.

## 1.5 Liaison with the Teen and Twenty Club

- 1.5.1 As Members would expect, we have been in close liaison with the Trustees of the Teen and Twenty Club about the redevelopment proposals.
- 1.5.2 The Director of Street Scene, Leisure and Technical Services and the Estates Service Manager have met regularly with the Committee and Trustees of the Teen and Twenty Club, appraising them of the proposed disposal to the Medical group. The Trustees and Committee have been understanding of the proposals and have agreed to surrender the lease of the Teen and Twenty Club on 31 March 2017, accordingly they have informed the hirers of the club that no further bookings will be available after this date.
- 1.5.3 The Council has offered support to community hirers to assist them in finding alternative and suitable facilities to relocate to in the town centre. New premises

have already been secured by some of the existing hirers, including the new youth hub in Avebury Avenue. The Council will continue to offer this support up until the closure of the club and beyond this time if necessary.

## 1.6 Consultation

- 1.6.1 Members will appreciate that should it be decided to proceed with all or any of the initiatives described in this report, development proposals arising from them will, of course, be need to be the subject of conventional planning applications, including public consultation in the normal way and any applications will be determined by the Area Planning Committee
- 1.6.2 Assura have confirmed that the Medical Group/ Clinical Commissioning Group (CCG) will be undertaking a consultation with patients of the practice prior to submission of the planning application.

## 1.7 River Lawn Land

- 1.7.1 HTC have identified the land adjacent to the site of the proposed Medical Centre as a suitable site for residential development. This could, for example comprise high quality apartments or mews type properties of a design appropriate to this locality or perhaps a scheme aimed at the retirement age group market. The river front nature of the site lends itself to a high quality designed development to complement the proposed medical centre. It might also incorporate improvements to the riverside walk in this vicinity and provide some well landscaped space around the buildings. Its location is likely to create a high capital value, particularly if combined with a mixed use development incorporating a medical centre or other facilities.
- 1.7.2 If Members were minded to pursue a disposal of this land, it is recommended that such a disposal would take place via tender or public auction, so as to achieve the best price available on the open market. Such a disposal process could include some overall design pointers, not to constrain matters but to provide encouragement for suitably high design quality which could actually assist in the marketing attraction. Given the interrelationship between this land and the site of the proposed Medical Centre (particularly because it is proposed that a small area of the River Lawn Land be included in the land to be disposed of to Assura for the purposes of the Medical Centre), it is not recommended that any such disposal is pursued unless and until completion of the agreement with Assura for redevelopment of the Teen and Twenty site.

## 1.8 River Walk Offices Site

- 1.8.1 A plan identifying the land owned by the Borough Council is attached as **Annex 5**.
- 1.8.2 The site is located in the centre of Tonbridge, fronting the River and opposite Tonbridge Castle. It may be accessed on foot via River Walk or New Wharf Road or by vehicle from New Wharf Road.

- 1.8.3 The building covers only a limited part of the plot, with the Council's ownership extending to River Walk to the north and east of the site.
- 1.8.4 Members may be aware that the building was formerly let to the Citizens Advice Bureau (CAB) and a private business (Jawatte), both of whom vacated the site during 2016. The CAB are now based in the Castle offices, with the private business having relocated to the Council offices at Kings Hill.
- 1.8.5 Within the Tonbridge Central Area Action Plan, the site is identified as suitable for residential development. It occupies a prime 'corner' location at a particularly attractive point in the town close to the River, Castle and Racecourse ground. It is also adjacent to Riverwalk itself where environmental improvements are being undertaken. All these aspects increase the scope for a high quality residential development which, with imaginative design, can add considerably to the 'aspect' of the locality and potentially achieve a high value relative to the size of the site.
- 1.8.6 If Members were minded to pursue a disposal of this land, it is recommended that such a disposal would take place via tender or public auction, so as to achieve the best price available on the open market. As with the River Lawn Land, such a disposal process could include some overall design pointers, not to constrain matters but to provide encouragement for suitably high design quality which could actually assist in the marketing attraction.

## **1.9** Financial and Value for Money Considerations

1.9.1 The financial considerations are set out in the private **Annex 4**.

## 1.10 Legal Considerations

1.10.1 The River Lawn Land is held by the Borough Council as public open space. In the event that Members were minded to proceed with the disposal of this land we would need to advertise our intention to do so in accordance with the requirements of sections 123(2A) and 127(3) of the Local Government Act 1972 and Section 233(4) of the Town and Country Planning Act 1990 and to thereafter consider any objections. This must be done before any final decision is taken on the disposal.

## 1.11 Risk Assessment

- 1.11.1 A critical part of this project will be in ensuring that the Teen and Twenty Club is able to find alternative premises for the facilities provided at the Club. Detailed liaison will continue with the Club to ensure that this takes place.
- 1.11.2 Any financial risks arising in connection with the proposals are considered in Annex 5.

## 1.12 Equality Impact Assessment


1.12.1 The proposed medical centre scheme will deliver considerable benefits to the community. As such, the scheme will provide a positive contribution to promoting equality. As specific elements of the development programme are taken forward, detailed consideration will be given to ensure potential impacts are identified and, where appropriate, action is taken to mitigate them in accordance with the Equality Act 2010 and supporting guidance.


### 1.13 Recommendation

- 1.13.1 It is **RECOMMENDED** that the Director of Central Services be authorised to
  - (a) complete the contract for the sale of freehold land with Assura on terms substantially as set out at **Annex 3** together with all other necessary agreements in order to implement the proposals, including the Car Parking Lease and the Compound Lease. Any amendments to the documents at **Annex 3** to be agreed in consultation with the Leader and Deputy Leader;
  - (b) advertise the intention of the Borough Council to dispose of the River Lawn Land;
  - (c) Subject to the completion of the agreement(s) with Assura under (a) above and the receipt of no objections in response to (b) above, proceed with the disposal of the River Lawn Land (shown edged in red and marked '3' on the plan at **Annex 1**) as set out in paragraph 1.7 of the report, such authority to include (but not be limited to) advertisement of the land, negotiation of terms and completion of any necessary legal agreements; and
  - (d) Proceed with the disposal of land at River Walk (shown edged in red on the plan at Annex 5) as set out in paragraph 1.8 of the report, such authority to include (but not be limited to) advertisement of the land, negotiation of terms and completion of any necessary legal agreements.






## 1 HUMAN RESOURCES STRATEGY UPDATE

The Human Resources Strategy (HR Strategy) provides an overview of the Council's approach to managing its employees. It is updated annually to identify "improvement priorities", such as changes to the Council's personnel policies.

The updated Hr Strategy attached as Annex 1 to this report advises the Committee on progress in achieving the improvement priorities in the Human Resources Strategy (HR Strategy) for April 2016 – March 2017, and identifies actions to be implemented in the period April 2017 – March 2018. The updated Strategy in Annex 1 also contains the statutory equality monitoring required by the Equality Act 2010.

## 1.1 Overview of updates to the HR Strategy

- 1.1.1 Section 3 of the updated HR Strategy lists progress against the improvement priorities identified in 2016/17. The Committee will note that actions have been identified and achieved.

# HUMAN RESOURCES STRATEGY (incorporating the Pay and Workforce Strategy)

## 1 The Council's Vision

The Council's vison for the next two years is:

To be a financially sustainable Council that delivers good value services, provides clear leadership and, with our partners, addresses the needs of the Borough.

## 2 Human Resource Strategy

The Human Resources Strategy is about recognising and developing the crucial contribution of every employee. This is prompted by the expectation/aspiration that all employees will:

- be customer focused
- be corporately aware
- demonstrate a "can do" approach to work
- > appreciate the Council as a good employer
- consider themselves as colleagues in a joint endeavour to achieve the corporate vision.

Working with partners, external service providers, and other authorities, the Council will give ongoing consideration to the further development of the Strategy. The Strategy will be updated annually and will identify improvement priorities for the year ahead. The annual update will also report on the achievement of the improvement priorities identified the previous year.

Four key "building blocks" are used to inform and direct human resource activities. These are:

- Leadership and Management
- > Effective Recruitment and Retention
- Communication and Team Working
- Workforce Development.

The Sections below provide an overview of the Council's current approaches to developing these "building blocks".

## Leadership and Management Development

We want managers and supervisors throughout Tonbridge & Malling Borough Council to meet their responsibilities to their colleagues by providing leadership, direction, purpose and support.

- Managers and supervisors will be expected to proactively seek out opportunities for service transformation and to set standards.

- Throughout their careers with the Council managers and supervisors will have opportunities to attend training and development events that reflect their responsibilities.

## **Effective Recruitment & Retention**

We want an employment package that attracts and retains capable people who are committed to delivering excellent services to the community.

- We will balance internal progression with external recruitment so that the Council continuously reinvigorates its talent pool, and that appropriate succession planning ensures an appropriately skilled workforce for the future.
- We will endeavour to attract suitable applicants by clear job descriptions, person specifications and advertisements.
- There will be a fair and consistent recruitment and selection framework that supports diversity within the workforce and that is regularly inspected by our internal audit team. Our workforce broadly reflects the ethnic and gender distribution of the residents of the borough.

- We will ensure that working environments are safe and healthy. The Council is currently accredited with the ROSPA Gold Award.
- We will foster a supportive management ethos that recognises and values everyone's contribution.
- > We will offer employees suitable training and development opportunities.

## **Communication and Team Working**

We want to create a climate of trust, honesty and involvement. We recognise the need for open and honest two-way communication.

- We will maintain a system of annual individual appraisals and regular team briefings across the organisation.

Matters for Recommendation to Cabinet - Council Decision

## 1 <u>REVENUES AND BENEFITS – SHARED SERVICE</u>

Members are advised of the progress with the implementation of the Shared Service, and are invited to recommend to Cabinet and then Full Council that the evaluation of IT and digital solutions be approved.

#### 1.1 Introduction

- 1.1.1 At the meeting of the Cabinet on 21 March 2017, Members considered a report in respect of the potential shared service for revenues and benefits. The Cabinet resolved that:
  - the establishment of a Shared Service for Revenue and Benefits between Tonbridge and Malling Borough Council and Gravesham Borough Council be approved as set out in the report;
  - the Director of Finance and Transformation, in liaison with the Cabinet Member for Finance, Innovation and Property and Leader, be authorised to progress detailed negotiations with Gravesham Borough Council (GBC) accordingly;
  - 3) Tonbridge and Malling Borough Council would prefer to be considered as the lead authority (and site provider) for the Shared Service and the Overview and Scrutiny Committee be advised accordingly for the purposes of the accommodation review;
  - 4) the Director of Finance and Transformation be authorised to commence consultation and discussion with staff as appropriate;
  - 5) the target implementation date of July 2018 be noted; and
  - further progress reports setting out detailed proposals for the implementation of the shared service be presented to either Finance, Innovation and Property Advisory Board, General Purposes Committee or directly to Cabinet as appropriate.

- 1.1.2 Since the report to Cabinet, staff briefings have taken place at both authorities and a Revenues & Benefits Shared Service Development Project Board has been set up consisting of key staff from both TMBC and GBC. Sub-groups undertake detailed investigative work on specific areas (e.g. property, HR etc) and report directly into the Project Board. A staff portal is being set up to keep staff informed as to progress; including reports to Members.
- 1.1.3 The Project Board agreed that the key 'initial' decisions that are required in order to lay the foundations for the Shared Service relate to the 'host' site, and some IT and 'digital' transformation related matters.
- 1.1.4 It is intended that a report will be presented to the General Purposes Committee on 26 June setting out the recommendations from the Project Board in respect of the hosting of the shared service. This report focuses on issues relating to IT and digital services.

## 1.2 IT Services and Digital Transformation

- 1.2.1 As was explained in the report to Cabinet on 21 March, both authorities operate the same key systems (Northgate and information@work) for the delivery of revenue and benefits services which provides a good foundation for the shared service. Both authorities need to invest in digital customer platforms to assist with the transformation of service delivery as was explained in the report, and Members were reminded that the Capital Plan List C already carries a potential scheme for evaluation entitled "Revenues and Benefits Citizen's Access" in this regard.
- 1.2.2 However, in terms of how relevant information is (or is planned to be) presented to the public via our website, the two authorities are at different points and as such there is a need to harmonise the approaches across the two sites.
- 1.2.3 Looking to the future, both authorities want to be able to offer more digital options to the public through the website including the opportunity for customers to complete their own template 'forms' for specific requests, applications or provision of information. Ultimately, as part of a <u>full</u> transformation process, in time, we would want to be able to deliver 'back office integration' maximising opportunities for efficiency. However this is a much later stage and would be subject to a separate evaluation in the future.
- 1.2.4 What is important to note is that many of these developments are strongly desirable irrespective of the implementation of a shared service. However, given that a shared service is to be implemented, it will be necessary to work with our partner GBC to ensure that IT and digital provision is harmonised. Having a shared IT manager with GBC is extremely helpful in this regard.
- 1.2.5 The IT and digital transformation plan can be split into phases. 3 phases need to take place prior to the shared service going live and there is a potential further phase, subject to separate future evaluation, which could occur at a later date.

- 1.2.6 In accordance with the Council's budget process, it is necessary to bring forward a 'fast-track' capital plan evaluation for approval to enable the work above to progress. This report sets out that evaluation for phases 1 and 2. The evaluation for phase 3 is still being undertaken and will be reported to Members of this Advisory Board as soon as it is available.
- 1.2.7 Members should note that funding for IT and digital transformation has been set aside in an earmarked reserve, so any decisions involving capital investment will not impact on the Council's capital allowance available for other capital projects. Any one-off revenue costs are also to be met from the earmarked reserve.

## 1.3 Evaluation

- 1.3.1 A capital plan evaluation template can be found at **[Annex 1]**.
- 1.3.2 Members will note that in respect of phase 2, an 'in house' option versus a 'third party supplier' option is being considered. Details of the functionality considerations that are being considered are attached at **[Annex 2]** for completeness.

## 1.4 Legal Implications

1.4.1 Any procurement of a digital IT solution will, of course, need to follow appropriate procurement requirements and legal colleagues are engaged in providing advice in this regard. If a full EU tendering process is required, the timescales for implementation will be more extensive.

## **1.5** Financial and Value for Money Considerations

- 1.5.1 The estimated capital and revenue costs to TMBC of implementing phases 1 and 2 in readiness for the 'live' Shared Service is set out at **[Annex 1]**. An in-house development in respect of phase 2 would be more cost effective, but the feasibility of this is presently being evaluated taking into account other IT priorities and pressures. Therefore for this purpose it is recommended that the costs based on third party support for phase 2 are approved. If in house development proves to be feasible, then this will mean that less funding needs to be provided and a saving can be achieved.
- 1.5.2 Funding is set aside in an earmarked reserve for this purpose and therefore will not impact on the Council's capital allowance available for other capital projects. One-off revenue costs are also being met from this earmarked reserve.
- 1.5.3 Ongoing revenue costs/savings will be factored into the overall Shared Service cost framework. Members are reminded that, as reported to Cabinet, we envisage that savings of circa £100k to £150k per annum are achievable after the initial 'bedding in' has taken place.

## 1.6 Risk Assessment

1.6.1 Delays in making decisions about IT solutions could mean that the implementation of the shared service does not happen in accordance with our anticipated timescales.

## 1.7 Equality Impact Assessment

1.7.1 The decisions recommended through this paper have a remote or low relevance to the substance of the Equality Act. There is no perceived impact on end users.

## 1 LOCALISM ACT 2011 – APPOINTMENT OF INDEPENDENT PERSONS

## 1.1 Introduction

- 1.1.1 The Localism Act 2011 requires that the Council adopt 'arrangements' for dealing with complaints of breach of the Code of Conduct both by Borough Council members and by Parish/ Town Council members.
- 1.1.2 The 'arrangements' adopted by the Council must include provision for the appointment by the Council of at least one Independent Person.
- 1.1.3 The Independent Person must be appointed through a process of public advertisement, application and appointment by a positive vote of a majority of members of the Borough Council.
- 1.1.4 The functions of the Independent Person(s) are
  - (i) They *must* be consulted by the authority (and their views taken into account) before it makes a finding as to whether a member has failed to comply with the Code of Conduct or decides on action to be taken in respect of that member (this means on a decision to take no action where the investigation finds no evidence of breach or, where the investigation finds evidence that there has been a breach, on any local resolution of the complaint, or on any finding of breach and on any decision on action as a result of that finding);
  - (ii) They *may* be consulted by the authority in respect of a standards complaint at any other stage; and
  - (iii) They *may* be consulted by a member or co-opted member of the Borough Council or of a Parish Council against whom a complaint has been made.
- 1.1.5 On 12 June 2012 Council resolved to appoint two Independent Persons, for a period expiring on 30 June 2017. The 2 appointed persons, namely Mr David Ashton and Mr John Gledhill, both indicated that they did not intend to seek reappointment to their posts at the expiry of their terms of office so it has been necessary to recruit 2 new Independent Persons.

- 1.1.6 The Council has been well served by Mr Ashton and Mr Gledhill, both of whom have served the Council for a number of years as either Independent Persons (2012 to 2017) or as Independent Members under the previous standards regime (2008 to 2012). Their assistance to the Council in discharging its ethical standards responsibilities has been invaluable and I am sure Members will wish to join me in offering their gratitude.
- 1.1.7 As with the previous appointments, a Panel comprising the Chairman and Vice-Chairmen of the Joint Standards Committee, together with the Group Leaders was set up to interview candidates and make a recommendation to Council for appointment.
- 1.1.8 The necessary advertisement was placed on 27 February 2017, with a closing date of 31 March 2017.
- 1.1.9 At the time of preparing this report three applicants had been shortlisted for interview on 7 July 2017. I shall update Members further on the outcome of these interviews in a supplementary report.

## 1.2 Financial and Value for Money Considerations

1.2.1 The Independent Person receives an annual allowance for performance of their role, currently £513 pa.

## 1.3 Risk Assessment

- 1.3.1 It is important that a robust system exists for promoting and maintaining high standards of conduct. The absence of such a framework will lower public confidence in the democratic process.
- 1.3.2 The role of 'Independent Person' is an important element of the standards regime, and will provide independent advice to the Council and members in connection with complaints.

#### GP 17/16 **REVENUES AND BENEFITS - SHARED SERVICE**

(LGA 1972 Sch 12A Paragraph 5 – Information in respect of which a claim to legal professional privilege could be maintained in legal proceedings)

Further to Decision No D170030CAB, the report of the Management Team advised the Committee of progress with the implementation of the Shared Service for Revenues and Benefits. Details were given of the outcome of discussions of the Project Board, comprising key staff from both Tonbridge and Malling and Gravesham Borough Councils, regarding the hosting of the Service. Reference was also made to representations received from staff and Unison. This resulted in a recommendation that the Service should be located at Kings Hill with Tonbridge and Malling designated as the lead authority. Members were advised that, pending the formulation of the Legal Agreement between the two authorities, there was a working assumption that TUPE would apply for the service model proposed.

It was noted that the Finance, Innovation and Property Advisory Board had recently considered a report focusing on issues relating to IT and digital services.

#### **RECOMMENDED:** That

- (1) the location of the Service at the Tonbridge and Malling Borough Council offices at Kings Hill be agreed, noting that existing Gravesham Borough Council revenues and benefits staff will relocate to Kings Hill;
- (2) it be agreed that Tonbridge and Malling Borough Council (TMBC) will become the lead authority and, subject to the written confirmation requested from Gravesham Borough Council (GBC), noted that it is GBC's intention to delegate the revenues and benefits function to TMBC which will become the service provider to GBC;
- subject to final confirmation, it be acknowledged that TUPE will apply for the (3) service model that is proposed;
- (4) it be noted that the Legal Agreement between TMBC and GBC for this service will be progressed over the coming months; and
- thanks be recorded to all involved in the considerable amount of work in (5) progressing the Shared Service during the time of dealing with the snap General Election. \*Referred to Council
