#### 1 PARKING ACTION PLAN

#### Summary

This report updates Members on the phased approach to on-street parking management with a focus on the work in progress.

#### 1.1 Introduction

1.1.1 The Borough Council's approach to on-street parking management has been divided into phases so economies of scale can be applied and work is delivered in a timely manner. The current priorities are set out below together with future proposals.

#### 1.2 West Malling Parking Review

- 1.2.1 As part of the work of the West Malling Parking Review Steering Group we are currently carrying out informal consultation on alterations to the existing parking area codes and other parking changes in a number of areas of West Malling. We have sent consultation leaflets to all properties in West Malling asking residents for their views. We have also sent specific letters to the residents where actual changes to on-street parking layouts are proposed. The areas covered by these changes are:
  - Swan Street High Street Town Hill Offham Road Norman Road Fatherwell Avenue A20 London Road
- 1.2.2 The consultation runs until 28<sup>th</sup> December.

#### 1.3 East Malling Parking Review

- 1.3.1 We carried out a review of parking arrangements in East Malling a few years ago and have had an outstanding commitment to carry out minor alterations and adjustments to the restrictions.
- 1.3.2 Earlier this year we carried out informal consultation on parking changes in a number of areas and reported the responses back to the Board. We are now carrying out formal consultation on those parking changes.
- 1.3.3 The areas where we are currently consulting on changes are:

Stickens Lane Middle Mill Road Chapel Street Clare Lane Cottenham Close Mill Street Upper Mill Wateringbury Road The Grange The Rocks Road

1.3.4 The consultation consists of letters to residents, notices on-street and in the local press, documents on deposit at the Council Offices, and letters to the normal statutory consultees. The consultation closes on 19<sup>th</sup> December 2014.

#### 1.4 Borough Green Parking Review

1.4.1 Next in our parking programme of work is a review of the Local Parking Plan for Borough Green, including a review of on-street disabled parking in the town centre. We have recently started looking at local concerns across the town with local members and the Parish Council and will bring back to the Board any proposals for changes.

#### 1.5 Hadlow – Local Parking Plan

1.5.1 Following on from the above reviews we will be in contact with Hadlow Parish Council and the local Borough Councillors to consider the development of a Local Parking Plan for the community and we will address requests by traders for some restricted local short stay parking to encourage turnover.

#### 1.5.2 Other Minor Changes

1.5.3 Further to an unresolved request to make some minor adjustments to the restrictions in Royal Avenue/Goldsmid Road area of Tonbridge we are currently consulting with local residents on some adjustments to the current restrictions.

Any changes which we feel are appropriate will be brought to the Board for approval.

#### 1.6 Local Parking Plan - Phase 8

- 1.6.1 We are now compiling a list of locations which may form Phase 8 of the Local Parking Plan.
- 1.6.2 The locations currently on the list for consideration or investigation are listed below and we will start to look at these as soon as resources permit.

1.7.1 The on-street parking service is undertaken by the Borough Council on behalf of the County Council under the terms of the formal legal agreement.

#### **1.8** Financial and Value for Money Considerations

1.8.1 Funding to implement the parking action plan is provided within existing approved Borough Council Budgets

#### 1.9 Risk Assessment

- 1.9.1 The assessment and consultation process applied to parking management should provide the assurance that the Borough Council has the will and ability to adapt the Parking Plans, in the light of comment and circumstances, to ensure that it achieves a best balance of local parking needs. A regular review of the schemes is crucial to ensure that we can correctly and effectively manage on-street parking in these areas as the proposals are either introduced for safety reasons or to provide a more appropriate balance of parking needs.
- 1.9.2 A major risk is that scheme proposals encounter significant lack of local support. This risk is mitigated by the considerable effort devoted to ensuring there is widespread consultation on proposals through two stages of informal consultation before any formal stage of consultation is reached. There is also care given to ensuring that schemes are adjusted and adapted in the light of comments and observations received from the local community, without compromising safety or the Council's commitment to deal appropriately with identified safety concerns.

#### 1 LOCAL GROWTH FUND PROJECTS

#### Summary

This report provides an update on the awards via the South East Local Enterprise Partnership (SELEP) Strategic Economic Plan (SEP).

#### 1.1 Funding for Transport Schemes

- 1.1.1 In July 2014 awards made to each of the 39 Local Enterprise Partnerships (LEPs) in England were announced. The **Tonbridge town centre regeneration scheme** was awarded a share of the Government's Single Local Growth Fund (SLGF) allocation of £2.37 million. It should be noted that receipt of the SLGF award of £2.37 million is subject to the scheme business case being accepted by the LEP. KCC will be leading the implementation of this project as Highway Authority but the Borough Council will of course maintain a strong input, continuing the partnership approach we have adopted for the scheme. At the time of writing this report it is understood that the project may have to be completed by March 2016 but as soon as a programme is formed further advice will be provided to Members. This is likely to include a further briefing session for local Members in advance of any agreed public engagement.
- 1.1.2 In addition to this there are funding streams for West Kent available through the Local Sustainable Transport Fund (LSTF). This funding totalling £4.5m (but subject to additional match funding) is available for the West Kent Authorities of Tonbridge & Malling, Sevenoaks and Tunbridge Wells together with Maidstone Borough Council (for the purpose of this award) between 2015 and 2021. Meetings are being held at a senior level between each authority and KCC to coordinate how this money should be allocated to ensure we deliver some high-impact schemes with clear objectives.
- 1.1.3 TMBC are likely to be looking for funding to support improvements to the bus, car and pedestrian interface at some of our key railway stations. Southeastern is currently developing plans for some improvements to the facilities for buses, pedestrians and cyclists serving **Snodland station** together with additional parking. Although Southeastern have access to some funding streams a contribution from the LSTF would ensure we achieve prompt delivery of a quality

scheme here which would support the "High Speed" service stopping at Snodland in the New Year. We are also in contact with the bus operators to try and ensure that appropriate bus links are provided to the station to meet the High Speed trains which should, hopefully, minimise any on-street parking problems which might materialise should this service prove popular with commuters travelling from further afield. We are also looking to bring forward some proposals for improvements at **Tonbridge station** and possibly another station location depending on the final availability of funding and the deliverability of projects.

#### **1.2** Junction 4 of the M20

1.2.1 This is also the subject of an award from the Single Local Growth Fund. £2.19m has been allocated pending approval of the business case. With 'match' contribution of £2.25m the total amount expected for the scheme is £4.5m. The scheme will be progressed by the KCC Major Projects team with a start date programmed for March 2016.

#### 1 A20 LONDON ROAD, WROTHAM HILL, WROTHAM

#### 1.1 Background

1.1.1 This report seeks to inform members of action undertaken in response to a recent fatal motorcycle crash on the A20 London Road Wrotham Hill. This matter was raised at the last meeting of this board.

#### 1.2 **Progress to Date**

- 1.2.1 Officers from KCC Highways and Transportation met with the Vice-chairman of Wrotham Parish Council, Mr Harry Rayner, on 5<sup>th</sup> November 2014. An officer from KCC Road Safety provided specific motorcyclist insight.
- 1.2.2 The current crash history for the site is currently good. The site is not currently being investigated as a crash cluster site. Initial investigations from Kent Police following the recent tragic incident did not recommend any changes to the highway.
- 1.2.3 The recent crash and tragic fatality will be subject to a Coroner's Inquest in due course and Kent County Council will of course take consideration of any recommendations made at that time.

#### 1.3 Work to be undertaken

1.3.1 Notwithstanding the findings of any future inquest, Kent County Council does feel there is merit in improving some highly visible chevron signage at the site. The site is close to a number of motorcycling trip generators and as such a minor, cost effective measure such as this may be prudent.

1.5.1 The site currently has a good safety record; however it is clear that due to the high numbers of motorcyclists present at times, a relatively low cost measure such as this represents good value.
