MATTERS FOR THE BOROUGH COUNCIL

JTB 25/10 PARKING ACTION PLAN - PHASE 15 (INFORMAL CONSULTATION)

(Decision Notice D250069MEM)

The report of the Director of Street Scene, Leisure and Technical Services provided an update on the progress of Phase 15 of the Borough Council's Parking Action Plan and detailed the outcomes arising from the informal consultation, undertaken between 18 February and 16 March 2025.

A list of all the locations, the issues raised and a summary of the responses received were attached at Annex 1 and the plans for each location were attached at Annex 2. A location summary and a more detailed response rate and analysis, and recommendation for each location were attached at Annex 3.

The views of local members were sought and where appropriate and/or practical these would be reflected in the final proposals.

In addition, reference was made to the proposal to reintroduce single yellow line parking restrictions at Common Road, Blue Bell Hill, as part of Phase 14 of the Council's Parking Action Plan. It was noted that no objection had been received following a full public consultation and therefore the scheme would proceed to implementation subject to a decision being taken by the Cabinet Member.

RECOMMENDED*: That

- (1) the recommendations in respect of locations Phase 15-01, 15-03, 15-06, 15-07, 15-09, 15-10, 15-14, 15-15, 15-16, 15-21 & 22, 15-24 and 15-30 for Phase 15 (as set out in Annex 1) be taken forward for investigation and formal consultation;
- (2) the views of local Members having been sought, the following revised recommendations be taken forward for investigation and formal consultation:
 - (i) location Phase 15-08 (The Rocks Road (near Paris House), East Malling) introduction of 'No waiting at any time' parking restrictions (double yellow lines) based on a revised plan in order that small gaps could be retained for residents parking and parking at access locations could be restricted:
 - (ii) location Phase 15-18 (Charles Close, Snodland) extension of the proposed double yellow lines to one end of the road, taking into account any highway boundary issues;

- (iii) location Phase 15-27 (Robin Hood Lane, Walderslade) amendment of the proposed restriction to single yellow line, extended to the far cul-de-sac end of the road; and
- (iv) location Phase 15-29 (Worrall Drive, Wouldham) restrictions to manage parking at Peters Village, subject to further discussion between Officers and the local Members to agree a revised plan for formal consultation, taking into account proposals for restriction in the area by Kent County Council and highway boundary issues;
- (3) the recommendations in respect of locations Phase 15-02, 15-04, 15-05, 15-11, 15-12, 15-13, 15-17, 15-19, 15-20, 15-23, 15-26 and 15-28 for Phase 15 (as set out in Annex 1) be abandoned; and
- it be noted that the parking restriction proposed for location Phase 15-25 had already been completed in Phase 14.

JTB 25/11 HILDENBOROUGH PARKING REVIEW

(Decision Notice D250070MEM)

Members received an update on the outcome of the formal consultation on the Hildenborough Parking Review and considered whether proposals should be implemented or abandoned.

Due regard was given to the responses received and it was noted that whilst there might have been a need for a wide scale parking review prior to the coronavirus pandemic, the need for intervention had significantly diminished as working from home arrangements and the desire to commute by train had altered. As a result the proposals had been revised significantly at informal consultation stage in respect of reducing residential parking permits and elements of on-street pay parking, prior to a formal consultation undertaken in January 2025.

RECOMMENDED*: That

- (1) the objections received for proposals shown for Riding Lane (North) (Location 2), Stocks Green Road (East) (Location 9) and Watts Cross Road and B245 London Road (Location 12) be set aside and parking restrictions at these locations proceed for implementation, subject to the effect of the agreed reduced restrictions set out as follows:
 - (i) Riding Lane / Riding Park junction new "junction protection" double yellow lines for 15m in each direction;

- (ii) Leigh Road (opposite Stocks Green Road) replacing existing single yellow lines with double yellow lines; and
- (iii) Watts Cross Road and B245 London Road new double yellow lines at the junction of Watts Cross Road and B245 London Road, extending southeastwards to the northwestern side of Foxbush (on the northeast side) and to the northern side of Noble Tree Road (on the southwest side).
- (2) the objections at all other locations be upheld and those parking restriction proposals be abandoned, including Ashley Road (Location 3) which was originally recommended for implementation by Officers.

MATTERS SUBMITTED FOR INFORMATION

JTB 25/12 HIGHWAYS FORWARD WORKS PROGRAMME 2025/26

The report of the Kent County Council Highways and Transportation summarised schemes programmed for delivery in 2024/25 and 2025/26. The report provided an update on Road, Footway and Cycleway Renewal and Preservation Schemes (Appendix A), Drainage Repairs and Improvements (Appendix B), Street Lighting (Appendix C), Transportation and Safety Schemes (Appendix D), Developer Funded Works (Appendix E), Bridge Works (Appendix F), Traffic Systems (Appendix G), Combined Members Grant (Appendix H) and Road Markings (Appendix I).

A clarification was sought on the road names where street lighting column replacements had been identified in Borough Green by way of a map to be provided by Kent County Council.

Members were provided with details about the methodology used in the micro resurfacing and surface dressing, in response to a query raised on inconvenience caused to the users during the surface settlement period and any specific concerns regarding pre-patching were invited to be raised with Kent County Council Highways directly.

Planned footway improvements in Vauxhall Ward were welcomed by ward Members and it was suggested that consideration should be given to sequencing the work on the plan and avoiding working on Deakin Leas during school term time.

Lastly, a query was raised in respect of the A20 London Road/Hall Road Aylesford Junction Improvement Scheme and it was noted that Kent

County Council had decided not to proceed with this scheme but to use the funding to support other schemes.

Parking Update Report

1 Summary and Purpose of Report

1.1 This report covers progress with current parking work and reviews, including the larger area Parking Reviews and updates on the phased Parking Action Plan.

2 Corporate Strategy Priority Area

- 2.1 Efficient services for all our residents, maintaining an effective council.
- 2.2 Parking provision and management is a key part of maintain the free flow of traffic on the roads and needs to be balanced to provide different users amenity parking.

3 Recommendations

3.1 Members of the Board note the current position of the phased parking action plan and timescale for the Hadlow Review.

4 Introduction and Background

- 4.1 The Borough Council has for many years divided requests for changes to parking restrictions into separate Phases of the "Parking Action Plan", or for wider areas as discrete "Parking Reviews".
- 4.2 The current procedure for requesting and progressing changes to parking restrictions is as follows:-
 - Request received and added to waiting list.
 - Sites collated into manageable phases

- Approval for the next phase reported to Joint Transportation Board with recommendation to move to informal consultation.
- Report to Joint Transportation Board on the outcome of informal consultation with recommendation to alter/adjust proposals if appropriate and to move to formal consultation.
- Report to Joint Transportation Board following formal consultation with recommendations to approve/abandon proposals.
- Install approved schemes.
- Review of impact of proposals after 12 months if required.

5 ParkMap

- 5.1 The way in which the Borough Council can make Traffic Regulation orders has changed. Kent County Council require that as of April 2025, all proposals for changes to parking be administered through a software package called ParkMap.
- 5.2 ParkMap uses a map-based system to record proposals along with the Traffic Regulation Orders that are in place. In time this should make things easier in terms of processing changes but at this point the Parking Service is still working through transferring proposals to ParkMap that have been developed partly using our previous processes. This is currently taking more time than anticipated as the team builds familiarity with the ParkMap systems and functionality.

6 Phase 15

6.1 The sites within Phase 15 (Annex 1) have been to informal consultation and were reported to the Board last June. The proposals are in the process of novation to the Kent County Council's ParkMap system, for preparation for formal consultation in the spring of next year, which will be reported back to a future meeting of the Board.

7 Future Phases

7.1 A further list of requests is shown in Annex 2 which is the Holding List for consideration in future phases of the Plan.

8 Parking Reviews

- 8.1 In addition to the Phased Parking Action Plans, the Borough Council has an agreed programme of Parking Reviews, where more complex issues or packages of measures can be addressed.
- 8.2 The formal consultation for the Hildenborough Parking Review was discussed at the June 2025 meeting of this Board and it was decided that the proposals be

- significantly reduced and would be re-circulated to the local Members for their confirmation prior to implementation. Plans indicating the reduced restrictions are included in Annex 3 for information.
- 8.3 The Council has already informally consulted on proposals for the Hadlow Parking Review and intends to carry out the formal consultation early next year and there is a future review programmed for Snodland once capacity allows.

9 Financial and Value for Money Considerations

9.1 Funding for the development of the Parking Plans is provided within existing revenue budgets.

10 Risk Assessment

10.1 The comprehensive assessment and consultation process applied to Parking Action Plans provides the assurance that the Borough Council has the will and ability to adapt proposals brought forward, in the light of comment and circumstances, and to ensure that it achieves a best balance of local parking needs. A regular review of the schemes is crucial to ensure that the Council correctly and effectively manages on-street parking in these areas, as the proposals are either introduced for safety reasons or to provide a more appropriate balance of parking needs. Proposal

11 Legal Implications

- 11.1 The powers allowing the Borough Council to carry out parking management activity are contained in the Road Traffic Regulation Act 1984, supplemented by formal agreement with Kent County Council as the Local Highway Authority, in respect of its powers under the Traffic Management Act 2004. In particular section 122 of the Road Traffic Regulation 1984 Act imposes a general duty on local authorities exercising functions under the Act to secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) and the provision of safe and adequate parking facilities on and off the highway.
- 11.2 The Borough Council carries out parking enforcement under an Agency agreement with Kent County Council by way of a Traffic Regulation Order, under the terms of the Road Traffic Act 1988 (and its amendments), the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004.
- 11.3 Changes to parking charges are made via an Amendment Orders to the Council's on and off-street parking Traffic Regulation Orders, using the procedures set out in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 and will reflect any temporary amendments to procedures introduced to address Covid-19 restrictions. The proposals have followed and exceeded the requirements of the Local Authorities' Traffic Orders (Procedure) (England & Wales) Regulations 1996.

12 Cross Cutting Issues

- 12.1 Climate Change and Biodiversity
- 12.1.1 A moderate source of emissions is likely to be maintained at current levels or increased. Use of private motor vehicles remains a major source of carbon emissions.
- 12.1.2 Climate change advice has not been sought in the preparation of the options and recommendations in this report.

13 Equalities and Diversity

13.1.1 The decisions recommended through this paper have a remote or low relevance to the substance of the Equality Act. There is no perceived impact on end users.








Riding Lane & Riding Park, Hildenborough

Summary: This report updates Members on the identified schemes approved for construction

1. Introduction

This report provides an update and summarises schemes that have been programmed for delivery in 2024/25 and 2025/26.

In summer 2021 Kent County Council published a Highways Asset Management Plan (HAMP), which included, as Appendix C, a five-year Forward Works Programme for the years 2021/22 to 2025/26. this reflected the need to move away from annual programmes and to consider asset management activity a multi-year one.

The first part of the programme concerned the two years 2021/22 - 2022/23. In October 2022 we replaced this with a programme covering the years 2022/23 - 2023/24, and we have now produced a new two-year programme covering the years 2024-25 – 2025-26. As before, most of the sites included in this programme have already been verified by our engineers.

The second part of our programme related to years three to five of our five-year programme (2023/24 - 2025/26). This too is in need of revision to cover the years 2026/27 - 29028-29 and the work required to do this is currently in progress. As before, our new years three to five programme will be largely based on data from our asset management systems, so may be subject to more changes as the schemes are verified.

This programme is subject to regular review and may change for a number of reasons including budget allocation, contract rate changes, inflationary pressures such as material price increases, conflicting works, and to reflect our changing priorities. The programme and extent of individual sites within the programme may also be revised following engineering assessment during the design phase, and additional sites may be added or others advanced if their condition deteriorates rapidly so that we need to react in order to keep the highway in a safe and serviceable condition.

This year will see the commencement of a multi-year strategic lining programme for the renewal of road markings, focusing initially on the Resilient Highway Network and A road network, with a view to expanding this to the B road network in time (dependent on funding).

A five-year programme has been developed, and will be reviewed and sense checked annually, with input from local district teams to ensure this programme remains sensitive to local requirements.

The delivery of these schemes is weather dependent; should it prove not possible to carry out these works on the planned dates, new dates will be arranged.
