Application to vary a premises licence at One Stop, 50 New Road, Ditton, Kent ME20 6AD

1 Summary and Purpose of Report

- 1.1 The Licensing and Appeals Committee sitting as a Panel is asked to consider an application to vary the premises licence after a number of objections were received during the 28-day consultation period.
- 1.2 During the 28-day consultation period, the Licensing Department has received twelve representations from interested parties and no objections from the statutory consultees.
- 1.3 The premises is seeking to vary its current licence to sell alcohol from 06:00 23:00 to 24 hours per day with the condition that sales during the extended period of the licence will take place through a hatch or online and the existing Operating Schedule will be replaced by the one which is set out in the application at **Annex 1**.

2 Corporate Strategy Priority Area

- 2.1 Efficient services for all our residents, maintaining an effective council.
- 2.2 Licensing Services ensure that all licensable activities taking place within the borough are granted the appropriate permissions under the relevant legislation.

3 Recommendations

3.1 That Members determine the application carefully, considering the application along with any representations made and take such steps as the Panel consider appropriate for the promotion of the Licensing Objectives.

4 Introduction and Background

- 4.1 The application was validated on 7th May 2025, with the 28-day consultation running from 1st May until 29th May 2025.
- 4.2 At any stage, during the 28-day public consultation period, a responsible authority, or other person, may make representations in connection with any of the four licensing objectives namely: -
 - Prevention of crime and disorder
 - Prevention of public nuisance
 - Public safety
 - Protection of children from harm

Provided that the grounds for the request are relevant to the promotion of the licensing objectives and, in the case of requests by other persons are not vexatious, frivolous or repetitive, a hearing must be held to consider the application.

- 4.3 The Licensing Act 2003 requires the Council to publish a 'Statement of Licensing Policy' that sets out the policies the Council will generally apply to promote the licensing objectives when making decisions on applications made under the Act. The Council's Draft Statement of Licensing Policy is due to be published in 2025 and will remain in force until 2030. The Policy will be available at the hearing, for reference purposes.
- 4.4 Under the 2003 Act, it is the duty of all licensing authorities that, in carrying out their functions, they must have regard to Guidance issued by the Secretary of State under section 182. The Guidance cannot anticipate every possible scenario or set of circumstances that may arise. Provided that the licensing authority has properly understood and considered the guidance, it may depart from it when it has reason to do so. However, as the licensing authority is under a duty to have regard to the Guidance, it will need to give full reasons for its departure from it. The Guidance will also be made available at the hearing for reference purposes.

5 Proposal

- 5.1 The applicant is Henley Retail DT Limited, Bridge House, 9-13 Holbrook Lane, Coventry, CV6 4AD
- 5.2 A copy of the application form and operating schedule can be seen at **Annex 1.**The application proposes the extension of the hours for the sale of alcohol to the public for 24 hours per day with the condition that sales from 23:00 to 06:00 hours takes place through a hatch at the premises or online and to replace the existing Operating Schedule with that set out in the application.
- 5.3 The proposed conditions outlined in the operating schedule are available in **Annex 1.**

7 Other Options

- 7.1 The steps an authority may take are
 - 1. Grant the licence subject
 - to such conditions as are consistent with the operating schedule accompanying the application modified to such extent as the authority considers appropriate for the promotion of the licensing objectives, and
 - ii. any conditions which must under section 19, 20 or 21 of the Licensing Act 2003 be included in the licence (the mandatory conditions).

- 2. Exclude from the scope of the licence any of the licensable activities to which the application relates.
- 3. Reject the application.

8 Financial and Value for Money Considerations

8.1 None unless there is a successful appeal against the Panel decision to the Magistrates' Court. This could result in costs being awarded against the Council.

9 Risk Assessment

9.1 Departure from the Guidance and Policy could lead to an increased risk on an appeal. Similar risks arise if any decision made is not evidence based and proportionate.

10 Legal Implications

- 10.1 Section 4 of the Licensing Act 2003 requires the Licensing Authority to carry out its functions with a view to promoting the following Licensing Objectives
 - a) The prevention of crime and disorder
 - b) Public safety
 - c) The prevention of public nuisance
 - d) The protection of children from harm

Having regard to the relevant representations, the Panel must take such of the steps set out, as it considers appropriate, for the promotion of the licensing objectives.

- 10.2 Section 4(3) of the Licensing Act also requires the Licensing Authority to have regard to the published statement of Licensing Policy and any guidance issued by the Secretary of State under section 182.
- 10.3 An application to vary a premises licence has to be made under s.34 of the Act and is determined in accordance with s.35 of the Act.

The options open to the panel are:

- a. To modify the conditions of the licence;
- b. To reject the whole or part of the application;

and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.

10.4 The Licensing Act 2003 section 181 and Schedule 5 makes provision for appeals to be made by the applicant and those making representations, against decisions of the Licensing Authority to the Magistrates Court.

11 Consultation and Communications

11.1 The Licensing Act 2003 requires all new application to undergo a 28-day consultation. During this consultation period, a blue public notice was displayed at the premises and an advert was place in a local newspaper.

12 Implementation

12.1 Decision of Licensing Panel will have immediate effect if granted, all parties may challenge the decision in the form of an appeal at the Magistrates Court.

13 Cross Cutting Issues

- 13.1 Climate Change and Biodiversity.

 - Climate change advice has not been sought in the preparation of the options and recommendations in this report.
- 13.2 Equalities and Diversity.



Operating Schedule

- 1. A person who appears to be intoxicated or who is behaving in a disorderly manner shall not be allowed entry to the premises.
- 2. The premises will be closed to the public from 23:00 with any sales made via the hatch at the premises or through an online delivery services.
- 3. All alcohol orders after 23:00 hours must be taken through the company's website and must only be delivered directly to the purchaser.
- 4. Warnings must be displayed on the company website reminding purchasers that they must be aged 18 or over to purchase alcohol.
- 5. All deliveries of alcohol must be made to a bona fide address.
- 6. All spirits will be displayed behind the counter only.
- 7. No customers carrying open bottles shall be allowed to enter the premises at any time that the premises are open to the public.
- 8. An Incident Log (which may be electronically recorded) shall be kept at the premises for at least six months and made available upon request to an officer of the Police or an authorised officer of the Licensing Authority.
- 9. The premises shall install and maintain a comprehensive digital CCTV system. All public areas of the licensed premises will be covered, including entry and exit. The CCTV cameras shall continually record while the premises are open to the public and recording shall be kept available and unedited for a minimum of 28 days with the date and time stamping. Footage to be provided to a member of the Police or an authorised officer of the Local Authority upon request and within a reasonable time.
- 10. All instances of Crime and Disorder shall be reported to the Police.
- 11. All firefighting equipment to be serviced and inspected in line with the manufacturer's recommendations.
- 12. The premises and immediate surrounding area shall be kept clean and free from litter at all times the premises are open to the public.

- 13. The pavement from the building line to the kerb edge immediately outside the premises shall be cleaned at the close of business each day.
- 14. The premises shall display prominent signage in all areas where alcohol is located that it is an office to buy, or attempt to buy, alcohol for a person under the age of 18.
- 15. The Challenge 25 Scheme will be operated to ensure that any person who appears to be under the age of 25 shall provide documented proof that he/she is over the age of 18 years. Proof of age shall only comprise a passport, photo card driving licence, an EU/EEA national ID Card or similar document, an HM Forces warrant card, or a card bearing a PASS hologram.
- 16. All staff shall be trained in how to refuse service, how to recognise proxy sales, relevant age restrictions in respect of products, and how to deal with those who may have a vocal restriction. Documented records of training shall be kept for each member of staff. Training shall be regularly refreshed. Training records shall be made available for inspection upon request by Police or an authorised officer of the Licensing Authority.
- 17. Signs shall be displayed warning adults that it is an offence to buy alcohol on behalf of anyone under the age of 18.
- 18. A log (which may be electronically recorded) shall be kept detailing all refused sales of alcohol. The log should include the date and time of the refused sale and the name of the member of staff who refused the sale. The log shall be available for inspection upon request by an Officer of the Police or an authorised officer of the Local Authority.

Dear Sir

Objection to 24 hour serving hatch at One Stop Shop New Road Ditton

I live in Ditton and I am writing to object to this serving hatch.

New Road is a family residential area, with a supported living facility housing older people and as such is entirely unsuitable for a 24 hour shop.

The noise regardless of whether the shop is physically open to the public or not with increased traffic as drivers collect orders all through the night will be disruptive to anyone living in New Road as cars and motor bikes will be roaring up and down the road all night in an attempt to deliver their goods as quickly as possible. There will be an additional 300 homes in the new housing estate at Ditton Edge which may lead to more people wanting to make use of 24 hour shopping at One Stop and this would directly impact all those who live on New Road with cars and other vehicles stopping/starting and the revving of engines - preventing local people and children from sleeping at night and there may be a detrimental impact on wildlife with more vehicle movements.

This 24 hour opening could easily add to the stress and anxiety of both young and old who live in Ditton.

The temptation for young underage drinking to increase and the further growth of anti social behaviour needs careful consideration.

It is possible alcohol could be obtained through an on line app without

scrutiny of the customer as a delivery driver could collect from the hatch and then deliver alcohol/cigarettes to under age people - this is a real concern, and could be impactful on public health and the growth of anti social behaviour both in Ditton and the wider area.

If this 24 hour serving hatch were permitted this may set a precedent for other shops in the area including at Ditton parade. This is detrimental to the whole of Ditton on the New Road side of the A20. It is a residential area and the disturbances for those of all ages living in the area is not acceptable.

This is not a vital service it is not serving the best interests of the community and may in fact be harmful.

There will be families in Ditton who are living with alcohol problems and 24 hour hatch could be too tempting for those people. This is why licensing laws are so strict in the first place yet here someone is trying to circumvent In a variety of ways the health and safety of those who live in Ditton.

I am sure TMBC would think very carefully if the request was for a public house in a residential area to be open all night so it seems very foolish to allow a 24 hour hatch for delivery vehicles such as Eat/Uber etc to collect goods (which can include alcohol)

The problem of litter and broken glass and tins needs to be discussed also as it is likely people will leave litter around for 24 hours a day if the shop can serve 24 hours a day.

I am worried that youngsters - and older people too may end up taking alcohol /food/crisp packets etc onto the community centre grounds - at all hours of the night - leading to anti social behaviour and litter - a problem which would extend from one end of New Road at the London Road And possibly onto the Recreation Ground - right up to the community centre and beyond Kiln Barn Road.

I believe this application for a serving hatch to be available 24 hours a day would be highly detrimental to all those who live in Ditton.

We need to set an example to all in our community and put an end to this application.

I am writing to submit a formal representation in response to the above application to extend the licensed hours of sale under the Licensing Act 2003. As a local resident living near the premises, I strongly object to this application on the grounds that it will undermine multiple licensing objectives and negatively affect the wellbeing of those living in the area.

The One Stop is situated on a residential road, surrounded by family homes. Extending the hours of sale will significantly disrupt the peace and safety of the neighbourhood and negatively impact a large number of people, particularly children, the elderly, and those with health conditions or shift work who rely on quiet during late and early hours.

The extension of hours is highly likely to increase noise from customers, car engines, loud conversations, and loitering; especially at unsociable hours when ambient noise is low and disturbances carry further. Residents already experience late-night disruption, and these new hours would worsen the situation.

Additionally, there is already a notable issue with litter around the premises, including food packaging, alcohol containers, and other waste. Increased trading hours will result in higher foot traffic and more rubbish, further damaging the cleanliness and visual amenity of the neighbourhood. This clearly undermines the licensing objective of preventing public nuisance.

There are growing concerns within the community about drug use and anti-social behaviour near the premises, particularly after dark. The proposed extended hours may increase the likelihood of the area becoming a late-night gathering point, heightening the risk of drug-related activity and public disorder. This poses a safety risk to residents and undermines efforts to keep our area safe and family-friendly.

The Licensing Act 2003 clearly sets out the importance of preventing crime and disorder. Extending hours without clear measures to address these risks would be contrary to this objective.

This is a family-oriented area, with many children walking past the shop daily. Extending alcohol sale hours increases the risk of children and young people being exposed to intoxicated individuals or inappropriate behaviour, particularly in the evenings. There is also concern that later trading hours could make it easier for alcohol to be obtained by underage persons, especially if staffing levels are reduced at night.

This proposal does not take into account the significant impact it will have on a densely populated residential area. The extension of licensing hours is not aligned with the Licensing Act 2003 objectives and will contribute to an increase in noise, public nuisance, crime, and harm to children.
I respectfully urge the licensing committee to reject this application in the interest of protecting our community and upholding the core principles of the Licensing Act.
