#### **Functions of The Board**

- S Advising Cabinet and Cabinet Member
- S Long term and short term 'place shaping' in the Borough
- Strategic and local planning, strategic and local transport and technical issues
- S Different roles statutory remit (Local Plan), community advocacy
- S Liaison with other agencies (KCC, EA)
- S Cross working affordable housing, health, economic development



#### **P&TAB** main areas of work

- S Planning and Development
  - National and strategic overview
  - LPA responsibilities local plan
  - Overall Development Control approach
- § Transportation
  - Strategic policy and projects
  - Local advocacy (not the Highway Authority)
  - Parking
- S Land Drainage, Flood Attenuation and Technical Services
  - Local intervention projects
  - Security and emergency planning



## **Strategic Planning**

- S National policy shift NPPG, NPPF
- S Influence (lobbying) and setting the scene for what we do locally
- S Implication of constant change Development control 'rules', Green Belt
- S Gypsy and Traveller policy
- S Plan for London
- S Future role of Local Enterprise Partnership
- S KCC minerals and waste planning



#### **Local Planning**

- § The Local Development Framework and the new Local Plan;
- S Community Infrastructure provision;
- S Neighbourhood Plans (also Parish Plans and Village Design Statements);
- S Countryside planning and transport initiatives;
- **S** Conservation and Character Area appraisals.



#### **Planning – The Local Plan**

- S New planning system introduced in 2012 by the National Planning Policy Framework (NPPF);
- S Local Plans to replace Local Development Frameworks
- S The T&M Local Plan is at the evidence gathering stage
- S Key pieces of evidence include:
  - Strategic Housing Market Assessment (SHMA);
  - Strategic Housing Land Availability Assessment (SHLAA);
  - Employment Land Review (ELR);
  - Strategic Flood Risk Assessment (SFRA);
  - Infrastructure Delivery Plan (IDP).



#### **Planning – The Local Plan**

- S The importance of having an up to date and robust development plan – taking control;
- S Identifying Objectively Assessed Needs for housing, employment and other types of development;
- S Demonstrating a 5 year housing land supply (plus 5%);
- S Balance with planning constraints
- § The Duty to Cooperate.



#### **Planning - Local Plan next steps**

- S Completing the evidence base
- S Issues and Options Public Consultation and working with local communities
- S Deciding on the land allocations strategy challenging times!
- S Adoption − during 2017



## Making development happen

- S A positive role
- S Development and design briefs
- § Town centre focus
- S Brokering solutions on difficult sites
- S Brownfield land focus
- Support for Economic development role
- S Business focus to planning and plan making



#### **Development Management**

- S The Board does not determine planning applications but has wider role
- S Review of overall approach and policy
- S Performance monitoring
- S Design and procedural guidance
- S Championing development quality and heritage conservation
- S Building Control Overall direction and approach



## **Transport Policy**

- S Responding to strategic and regional transport policy
- S Involvement in strategic proposals (e.g. Lower Thames Crossing; Airports Commission);
- S Local Transport Projects (e.g. Tonbridge Transport Strategy; A228/A20 corridor);
- S Involvement in transport activities undertaken by the Highways Authority and Highways England;
- S Public Transport initiatives (rail manifesto, Bus operators);
- S Promoting improvement schemes through KCC, LEP
- S HGV strategy/Cycling/links with Air Quality



## **Parking**

- S Off street parking managing and maintaining the car parks
- S On street parking responsibility
- S Local Parking Plans:
  - Highly consultative
  - Locally difficult balances between competing demands
  - Future programme
  - Phased programme outside of LPPs
- S Parking enforcement



#### **Technical Services**

- Support across the Council and to other agencies
- S Responding and taking account of Government changes to land drainage and flood attenuation (e.g. Sustainable Urban Drainage Systems (SUDS)
- S Land drainage interventions (permissive powers)
- § Flood improvement measures
- S Capital Projects (e.g. Town Lock)
- S Review of flood recovery operations
- § Emergency planning readiness
- S CCTV operations partnership and links with other agencies



## **Summary**

- § A vital collection of front line services
- S Ranging from national/ strategic to local interventions
- S Often controversial
- S Good track record across the board
- S The next few years a challenging scene
