It has come to my attention that Tonbridge and Malling Borough Council plan to sell off the land they own at River Lawn and at River Walk. I understand that this is being done without the consent of townspeople and that there has been no attempt at public consultation. I believe there may have been an announcement in a local paper, which would only reach those people who read it cover to cover.

Since moving to Tonbridge we have been impressed with the amount of open spaces for people to enjoy. I have often walked through this stretch of land with my grandchildren on our way to or from the park.

I understand that this area and the old CAB site are within the Tonbridge Conservation Area and any development is supposed to 'enhance that character and the appearance of the Conservation Area.

It is also my understanding that other Borough Councils in the area have taken a different approach to solving the funding gap. Apparently Sevenoaks is now self-sufficient. Can our councillors not learn from them?

We moved here five years ago and during in that time there has been a proliferation in building of flats. Do we really need more on this particular area of recreational space? Personally, I think not and would object to any such scheme.



Dear Ms Iggulden,

I object to Tonbridge & Malling Borough Council's plan to sell off the land they own at River Lawn and at River Walk. I am concerned that I only knew about this because my children attended clubs at the Teen and Twenty and that they were given notice to quit because of the intended doctor's surgery.

Land belonging to the council and ultimately the people of Tonbridge should not be sold off without the consent of constituents. I note that there have been no planning notices up in the surrounding area nor in the local newspaper, The Tonbridge Courier. It has been brought to my attention that notices were put in the Kent Messenger. As far as I am aware this is unavailable to buy in the Tonbridge area and certainly does not have a broad readership as the Tonbridge Courier does. Council owned land, within a conservation area, should not be sold off, underhand, without a formal public consultation.

I am against the sale of the land within these areas because they are public open spaces and used by the public. Both sites are susceptible to flooding. The parking is inadequate in both areas — you only need to take a look at the new blocks of flats in New Wharf Road to see what a huge problem it is. This is publically owned land. The council are only the guardians of it and I believe you should not be entitled to sell it off to the highest bidder against the unheard voices of the Tonbridge residents.

The River Lawn area would benefit from improvement and has been neglected for a long time -1 wonder if this is the reason. Once this and the River Walk area is sold, you can never get it back so you should really think very carefully about who would benefit from such a sale.

Neglected areas need to bought back to life and improved for the benefit of everyone. Improved lighting, benches and perhaps a small childrens play area would be more suitable.

This area and the old CAB site are within the Tonbridge Conservation Area and any development is supposed to 'enhance that character and the appearance of the Conservation Area'. I cannot accept that building flats on these sites will be an improvement and selling them with this intention is against my wishes.

Hi Katie,

I understand there is currently a proposal for TMBC to sell off the River Lawn site and the former CAB building to private parties. I therefore wanted to write to express my objection to this proposal.

I believe the council would be making a grave mistake by selling these public assets for a one-off financial gain. The high street already suffers from high levels of pollution, and so the ability for pedestrians and cyclists to use these sites to walk through and for leisure is especially valuable. Over the last few years we have seen more and more sites next to the river in the town sold to private owners, mainly for residential development, which means that the community is losing the right to access this land. The sites proposed for sale are attractive nature areas which provide habitat for birds and other wildlife, and the existing buildings are in keeping with the look and feel of our traditional market town. Many residents enjoy using these areas and are very concerned about the proposals, as well as the lack of consultation by the Council / Cabinet about them. This area also suffered badly from flooding in recent years, and so it is far from clear whether building is even safe or recommended.

I would prefer the council to adopt the successful strategy of Sevenoaks council who have invested in their assets for a sustainable financial return for the future. In contrast, TMBC have a poor track record in achieving commitment to affordable elements and other community benefits of developments, and of enforcing these commitments down the line. TMBC should be investing to improve the facilities available at these assets to increase their value to the community - by installing more benches, litter bins and ensuring the lighting is turned on in the evenings so that the bike paths can be safely used. If any further development were to be deemed suitable, then TMBC should be funding this themselves so that they retain control over this land and any future financial benefits would be for TMBC and our community - not a private owner.

I would appreciate a response to indicate you have received this message and registered this objection. I would also like to understand when and how the council next plan to communicate their intentions regarding this proposal.


I object strongly to the sale of the adjacent River Lawn site - this is a valuable green space, linking the High Street to the river. It has clearly been neglected and could be improved at relatively little cost.

To sell it off for the development of riverside apartments would be a dereliction of duty. The river is perhaps Tonbridge's greatest asset - lining it with apartment buildings will further damage the town's character.

The building and site previously occupied by the CAB, nearer the castle, is also I understand proposed for sale. This is a building that adds character to the local scene and has potential as a riverside cafe or for another community use such as a town museum. Again, to sell the site for housing would be a terrible mistake.

Objection to TMBC's plan to dispose of land at River Lawn and River Walk

Dear Katie

I understand that you are the person with whom to lodge an objection to Tonbridge and Malling Borough Council's proposal to sell off the land they own at River Lawn and at River Walk. I am very concerned that this is being done without the consent of townspeople and that there has as far as I can tell been little to no attempt at public consultation.

There are a few specific reasons for my objection, beyond the general principle of selling off valuable community assets for short term gain:

Scouting

I am a lifelong resident of Tonbridge and have experienced first hand the benefits River Lawn gives to the town. I was a member of the 1st Tonbridge scout group, whose HQ is in Lambert's Yard a few yards from River Lawn, from the age of 6 to 21. Throughout that time I regularly and consistently made use of the Lawn for a wide range of activities: games, pioneering, tent pitching practice and perhaps most importantly fundraising fairs, especially our annual May Fair. My son is now a member of the 1st Tonbridge too and I am pleased to see they still make just as much use of the space as they ever did. The loss of River Lawn would be hugely detrimental to the three scout groups located nearby (the 5th and the 14th being the other two).

Building massing

Should the land at River Lawn be sold, it will inevitably be for flats to be built there. Due to the risk of flooding the ground level of these flats will necessarily be a car park, meaning the building itself will be multi-storey and higher than anything in close proximity to it. This is ok east of the High St where there are more buildings of this nature, but at this location it would be overbearing.

River Lawn, as well as the old CItizen's Advice Bureau site, which I would also like to object to the sale of, is within the Tonbridge Conservation Area and any development is supposed to 'enhance that character and the appearance of the Conservation Area'. As an Architect, I am unconvinced that any development of the size that will bring a return high enough to entice a developer can satisfy that requirement.

Trees

River Lawn, and the path alongside the River, contains at least 15 established and mature trees. It acts as a buffer zone between the activity of the high street and the openness of the park. The replacement of these trees with a residential development would be a huge loss to the town.


Parking

I do not know whether the plans include selling off the car park at the end of River Lawn Road/Lambert's Yard too but if they do I also strongly object to that. It is a very useful car park for short visits to the High St and Larry full. I also worry where parents will park to collect their children from the scout hut were it to go.

While I recognise the need for the council to liquidise assets to raise desperately needed capital, I strongly believe a greenfield site in the centre of town that is demonstrably a community asset is too high a price to pay and should not be lost to the people of the town forever.

Rather than selling River Lawn off to a developer who will only be interested in their bottom line, it should be recognised as the community asset that it is. With a little bit of investment (lottery money perhaps, or even private funding?) for improved lighting seating etc, in parallel with the redevelopment of the adjacent Teen & Twenty Club site into a state of the art medical centre, it could become an even more valuable asset to the residents, workers and visitors of the town.

I have rarely feel as strongly about something to write to register an objection, but this is something I cannot allow to happen if there is anything I can do to prevent it. Once River Lawn and the River Walk site are sold off, they will be lost to the Tonbridge community forever. Despite the urgent need for more funding for the council, to sell off assets like these is short-sighted and irresponsible. Were it to go ahead, I am confident it would be hugely regretted in a few years' time.

Tonbridge & Malling Green Party believes Tonbridge & Malling Borough Council has been both short-sighted and unambitious in its plans for the redevelopment of sites at River Lawn in Tonbridge. We are also concerned about a lack of transparency around the process.

TMBC has taken the decision to sell land and buildings in River Lawn Road and River Walk in Tonbridge, following a review of its assets. The Council says the review "aimed to identify potential redevelopment opportunities that would benefit the community, improve services and provide financial return." This sale will leave TMBC impoverished in the long term.

This deal is in fact a fire sale of assets to help balance the books. Rather than retain land and buildings in public ownership and explore opportunities to generate sustainable income over the long-term, TMBC has chosen to sell assets for a one-time gain.

This important site is not mentioned in The Way Forward, the document which is supposed to "guide and manage future development in the Borough up to 2031." Neither are the sites identified on the Call for Sites map, produced as part of the Local Plan process. We want this site to be subject to the same analysis as the other areas being considered for development.

TMBC also announced that it has: "... agreed to sell some adjacent land in River Lawn Road for potential residential development" and "nearby land in River Walk has also been identified as suitable for new homes and will also be put up for sale." There are currently over 900 households on TMBC's housing waiting list. We are concerned that when an opportunity presents itself to develop social housing, the council's first instinct is to sell land to the highest bidder.

We are challenging the legality of this process as you have failed to advertise your notification in a newspaper with a circulation covering the area in question.

The Council should be insisting that any housing built on these sites includes genuinely affordable homes for sale and rent but that will not be the case.



I am a resident of Tonbridge and I am writing to object in the strongest terms to the 'disposal' of public land at River Lawn in Tonbridge.

I understand from the TMBC website that the initial plan was for a parcel of land measuring 432sqm was to be disposed of, in order to "facilitate the development of a medical centre, which consists of part of an open space", according to the original plans, consultation on which closed in March 2017. Few would argue that in Tonbridge, there isn't a serious need for new public services. I know for instance that Warders Medical Practice is massively oversubscribed, and I assume the same to be true of others practices. I had no real objection to the initial plans because of this.

In the latest plans for River Lawn however (which close today) it says that the 'disposal' has been extended to 2184sqm, and will include the land right up to the river bank. If, as I understand, this means the loss of public access to that side of the river, then that is unacceptable.

There is also no longer any mention of a medical centre in these new plans; it is merely states that the land is an "intended disposal".

I would like to place on record two observations:

- 1. The fact that the plans apparently constitute an open-ended sale with no provision for a new medical centre (when the need for this was identified in the initial plan, closed 24 March 2017) is troubling. I think most people could reconcile the loss of 432sqm of public green space to provide a public good such as a medical centre, especially since the original plan retained access to a valuable patch of green space and crucial access to the river.
- II. But the new plan for River Lawn involves the loss of an area of land five times bigger than that outlined in the original proposal, with no benefit to the public for the loss of this space. If, as has been rumoured, this land could be sold for 'luxury flats' then the impact on public services would be exacerbated. Tonbridge would lose a key piece of green space one that is frequent use by local workers, as well as by my family. Furthermore, one of Tonbridge's key qualities its green spaces would be substantially diminished.

The Barden Residents' Association object in the strongest terms to the councils plans to sell the green spaces at River Lawn. Having attended a cabinet meeting on 9th February with a colleague we witnessed our ward councillors argue the case for keeping this plot of land as a 'break out area' to be enjoyed by people enjoying their lunch or to be frequented by customers of Nancy's Tea Room. We were hoping to ask for sympathetic refurbishment of this area with new picnic tables and the installation of LED lighting in the evening to make the area more welcoming at all time of the day.

It is our belief that this area has been deliberately run down since it was used as a building yard while the weir was reconstructed. The floodlighting at the nearby sports court in the Racecourse Sportsground has not worked in years and so people tend to hang around River Lawn in the dark as they have nowhere else to go. Because the area is unlit people get the impression this is an intimidating area, this would be easily remedied by illumination of both the court and the pathways at River Walk and River Lawn. With a little imagination this would be an attractive amenity area.

The proposed sale of this area with the intention to allow residential development will mean the open aspect of the grass and trees will be lost forever, certainly the view leaving the High Street via Lamberts Yard will be much diminished. The area is rich in wildlife and many people enjoy the Squirrels, Pigeons, Crows and Jackdaws some of which are hand fed visitors.

We are extremely concerned that this sale takes no account of the serious drainage and sewerage issues that plague the locality, the area was seriously flooded three years ago and there are outstanding legal matters to be settled over responsibility which will be jeopardized by premature development, as this land is within an area at risk of flooding we consider development unsuitable.

The sale of this land by TMBC is counterproductive to the council itself, it makes no financial sense to sell to a third party to build high-end apartments here. If the council is committed to destroying the natural habitat here why does it not commission its own construction of rented accommodation to ease the pressure on young families and single people who are currently being forced out of private rented housing nearby? The leader of the council himself has bemoaned the local shortage of reasonably priced rented housing and when an opportunity arises to fill the gap itself, or in a partnership, TMBC's first option is to sell for a one off payment. Where is the logic?

To illustrate our opposition we have conducted an online petition which you can access at https://www.change.org/p/tonbridge-and-malling-borough-council-halt-the-sale-of-the-river-lawn-and-property-in-river-walk-without-consultation. Including our ongoing paper petition well over 1,000 have already signed. Please also note that the Keep River Lawn Green Facebook Group has over 1,700 members and this has been achieved while TMBC has done its best to keep people unaware of its plans.

Lastly it has come to our attention that this process is invalid as TMBC listed the legal notification erroneously with the Kent Messenger newspaper. This publication does not have a Tonbridge edition and its own literature indicates that our town is well outside its delineated circulation. We refer you to the relevant legislation:

Section 123 of the 1972 Local Government Act - reads as follows:

A principal council (TMBC) may not dispose of any land consisting or forming part of an open space unless before disposing of the land they cause notice of their intention to do so, specifying the land in question, to be advertised in two consecutive weeks in a newspaper circulating in the area in which the land is situated, and consider any objections to the proposed disposal which may be made to them"

We believe that TMBC has an obligation to re-advertise this intention to dispose of the land in question.

1. This is a publicly owned green space with several mature trees. It is nice for the public to be able to walk along the river here. Mature trees are an asset both to wildlife, environment and people. These could not be quickly replaced, as they have taken many years to grow to that size.

2. It would be good to have a new medical centre in the middle of town, but it will also bring parking problems. I was present at the council meeting when this was discussed. 
I am writing to you to voice my concern about TMBC's planned disposal of the land at River Lawn and River Walk in Tonbridge.

Dear Ms Iggulden,

I was dismayed to hear of the proposed plan to sell off the River Lawn and River walk land to a developer without proper public consultation. I live on the Barden Estate and walk through the River Lawn area most days with my children. Green spaces are one of the reasons why we moved to Tonbridge from London five and a half years ago. It has been disappointing therefore to see the apparent disregard for green space in favour of quick sales for profit. I understand the need for more housing. However, I do not feel that these locations are suitable for a few reasons:

- 1. This area falls within the Tonbridge Conservation area. Building high rise flats, which I imagine is the plan given the development we are already having to endure between Barden Road and Avebury Avenue, will certainly not "respect the existing character and preserve or enhance the character and the appearance" of this area. The new build properties that have sprung up in Tonbridge in the past few years since I moved here are unimaginative, imposing new-build flats that do not gel in any way with the character of this market town.
- 2. The land around this area is already subject to many pressures. One of those is related to flooding. My home was flooded in 2013 which was a distressing time for my family and for all of those affected in the Barden area. Building more large properties on this land seems ill-advised, should we be subject to the same weather conditions as we experienced that Christmas Eve.

The second pressure is on parking. As resident of D1, with 2 small children, parking has become incredibly stressful. With the introduction of the flats being built on barden road this will get even worse, building a new medical centre is a great idea in theory but what about parking provision? The car park of the Teen and Twenty is already always full and that is with the building out of use.

The third pressure is on services such as schools and medical centres. Having just been through the school selection process I am aware of the pressure on numbers of school places we experience in Tonbridge. I also have issues getting appointments at my GP surgery which is the one being proposed to be housed in the new medical centre. High rise flats mean a large influx of people into the area at once without increased provision of services for them.

The River Lawn area is not well looked after and with a little care and some better lighting could be an asset to the town and community rather than an area left neglected so that it can be easily sold off to developers without any apparent thought or care for residents' views. I, along with other members of my community, are calling for the council to reconsider their plans and to have a proper public consultation and discussion about this issue.

I object to the sale of this land for the following reasons:

- 1. I consider that Tonbridge residents have not been consulted in any meaningful way on this sale of an important town centre public open space. The Kent Messenger in which the advertisement of sale was placed has limited, if any, circulation in Tonbridge. The advertisement did not appear on the Council's website anywhere the public might reasonably be expected to find it -- even if they knew it existed in the first place. I consider this is contrary to the spirit, if not the letter, of the relevant act.
- 2. River Lawn is an attractive area of open space in the town centre with mature and attractive trees. As such it is a rarity now that the town has been so extensively built over in recent years with poorly planned developments contributing little if anything to public amenity, particularly along the river banks.
- 3. The attractive riverside setting makes it inevitable that the site will particularly attract developers of so called "luxury flats". We already have far too many of these in Tonbridge, clearly aimed at attracting London overspill and well beyond the reach of local residents with housing needs.
- 4. If the land has to be sold then the Council must not simply hand it over to the highest bidder with free-rein to errect whatever best suits its bottom line, as seems to be the current intention. It must first ensure that development is achieved sensitively according to a blueprint that puts a priority on an attractive townscape and has been subject to public scrutiny through the usual planning process. Sale of the land with planning permission would probably achieve a better price anyway.

Having seen recent reports of plans to sell off and develop the Tonbridge green space known as River Lawn and also the site which was previously the site of the Citizens Advice Bureau, I'm writing to you to raise my concerns and objections to these proposals.

As a resident of Tonbridge for 24 years, I am concerned that this communal area at River Lawn will be given over a housing, which I feel is unnecessary when you consider the extent of the new developments already completed and still on-going in our town. Such communal areas are part of the reason that Tonbridge attracts new residents and why the existing ones stay. It should be maximised for that purpose rather than disposed of for fundraising.

I am writing to object to the River Lawn development proposed for Tonbridge.

As a father with young children River Lawn and the Teen and Twenties Club has played, and will continue to play, a large part in my life .

While I agree with the principle of the redevelopment of the Teen and Twenties Club, to create modern local facilities and the creation of a brand new state of the art medical centre for the town there are a number of issues I have with the proposals, and I would ask you to represent these views to the Planning Committee.

Why are two medical centres closing so a new one can be created? Surely the huge amount of development that has taken place in the centre of town and is taking place on Tudeley Lane means that more medical facilities (doctor's, dentists etc) need to be created and built in order to ensure that all residents of the town get access to medical care. Also in closing the 2 other centres more people will have to travel to go to the doctor, and currently there isn't enough parking planned for a medical centre of that size. The car park at Trenchwood Medical Centre demonstrates that most days.

Why is the council selling the land for development by a private company to then rent out, rather than build the medical centre itself? Surely this would then allow for other services to be included like a children's centre or community use space, so community or interest groups had somewhere to meet. The lack of interconnected services and delivery will be detrimental.

In terms of the River Lawn development itself, I am absolutely against this. River Lawn itself is not a big enough area to develop in a serious fashion that is sympathetic and fits in with the existing community. The lack of transparency around the whole development, including the publishing of the official notice in a paper that isn't even available in the town is disgusting and underhand. The lack of forethought about how the council itself may develop existing plots of land that might be developed in a way that both sensitively addresses local need and could provide income for the Borough Council is worrying.

I am also concerned by the lack of any service provision being included in the development. Not only are you proposing to build over a beautiful site, and put up expensive flats for non residents, the Council has also not thought about the knock on effect of the influx of new residents and the demand on services. The town centre developments and Tudely Lane developments are lasting proof of the need to incorporate and use Section 106 agreements to ensure that services for these new developments are included in any planning and building development. Medical centres, school spaces and community spaces must be included in order to ensure that there is enough provision for all potential users, even if it means the developers having to build these as part of the development contract. This has been done before in other areas.

Dear Ms Iggulden

I would like to object to the proposed sale and development of the River Lawn area of Tonbridge. This is a unique green area within the town and has great potential as a community space. I believe that the sale would inevitably lead to development of the site which would be inappropriate and unsustainable for the following reasons:

- 1. The area is designated as a conservation area. Tonbridge and Malling Borough Council's own website states that any development in such an area must 'preserve or enhance the character of the area'. It is difficult to understand how building on a green open space can enhance or preserve its character. Any plan to build on this space therefore surely directly contradicts the council's own policy.
- 2. The area is close to the river and on a flood plain and there is considerable evidence that this increases the risk of flooding both in the immediate and surrounding areas. Indeed the river lawn was underwater during the recent flooding of 2014/5. Although the primary cause of the flooding was due to the high river level caused by the operation of the Leigh barrier, the problem was exacerbated by the drainage in the area being overwhelmed. The loss of natural drainage provided by the lawn, and through further development in the area will place an unsustainable burden on the drainage system. It will also have to cope with the additional demands of the Enterprise House development currently being built in Avebury Avenue.
- 3. Any proposed development will also increase pressure on traffic and parking in the area as access to the site from the High Street is only possible via Avebury Avenue. Since the conversion of Avebury Avenue to one way, and the recent work in the High Street, access and egress to the Barden area has become more and more difficult for residents. Parking is also becoming increasingly problematic especially in the D1 area near the station. With the expected increase in traffic connected with the Enterprise House development and the proposed medical centre in the former Teen and Twenty club premises, any further development in this area will be unsustainable.

I urge the council to reconsider the decision to offer this land for sale and instead work with local residents to make this unique part of Tonbridge an asset to the community. Whilst I accept that development and and increased housing provision is necessary I feel strongly this is not the appropriate area for it.
