1 PARKING ACTION PLAN

Summary

This report updates Members on the phased approach to on-street parking management with a focus on the detail of the current initiative – Phase 7 and the Snodland Parking Review.

This report considers the responses to the formal consultations and makes recommendations based on those responses, to either set aside objections and implement, or to uphold objections and amend or abandon the proposals.

1.1 Introduction

- 1.1.1 The Borough Council's approach to on-street parking management has been divided into phases so economies of scale can be applied and work is delivered in a timely manner. Phase 6b was introduced last year, and we have been carrying out formal consultation on proposals that form Phase 7. We have also started compiling requests that will form Phase 8 for future investigation.
- 1.1.2 As well as Phase 7, we have been carrying out a parking review in Snodland.
- 1.1.3 Informal consultation has been carried out on all of the proposals and, where possible, the views of residents have been taken into consideration and minor alterations have been made to reflect those views.

1.2 Phase 7 and the Snodland Parking Review

1.2.1 The proposals that formed Phase 7 and the Snodland review covered 68 locations across the Borough. Ten Locations were withdrawn following the informal consultation process. The remaining 58 locations proceeded to formal consultation. The proposals are shown in [Annex 1] and [Annex 2].

1.2.3 Each location where restrictions or changes are proposed is discussed in detail in their respective Annexes, where the history of the request, the proposals and the

consultation responses are discussed, along with a recommendation for the Board's consideration.

1.3 Next steps

1.3.1 Pending the Board's approval, the on-street Traffic Regulation Order Amendment will be sealed to reflect the changes and the approved changes will be introduced.

1.4 West Malling

- 1.4.1 The West Malling Local Parking Plan has been evolving following the guidance of the Steering Group.
- 1.4.2 Since the last Steering Group meeting we have introduced changes in the town centre (Tesco) car park that have reduced the parking duration from 4 hours to 3 hours and prevented repeat parking.
- 1.4.3 This has had a noticeable effect on parking, with an increase in availability for short-stay parking by shoppers.
- 1.4.4 We are now seeking the views of the Steering Group over which direction they would like us to take next. We are preparing proposals for the following;
 - New permit parking areas in Norman Road, Offham Road and on the A20 London Road;
 - New uncontrolled parking areas on A20 London Road and double yellow lines (east of the roundabout and in to Leybourne Parish);
 - Re-allocation of the existing permit parking areas by changing the zone letters. This should allow us to re-distribute the existing parking permits more equitably amongst residents and make better use of kerb space.

1.5 East Malling Local Parking Plan Review

- 1.5.1 Though most of the changes and restrictions introduced in East Malling have settled in well, there are a few locations where there have been reports where parking issues remain or where the changes associated with the parking review have led to a change in parking habits.
- 1.5.2 In consultation with local Members, the locations where changes may be required were assessed, with specific surveys carried out in Rocks Close and The Grange.
- 1.5.3 Proposals for each of the locations covered in the East Malling Review have now been prepared and we are currently carrying out informal consultation with frontagers to gain their views on the changes.
- 1.5.4 Dependant on the outcome of that consultation the proposals may then progress to formal consultation.

1.6 Borough Green Parking Reviews

1.6.1 Next in our parking programme of work is a review of the Local Parking Plan for Borough Green, including a review of on-street disabled parking in the town centre. I will be in contact with local Members towards the end of the summer once we have completed the introduction of Phase 7 described in the report.

1.7 Hadlow – Local Parking Plan

1.7.1 Following the work at Borough Green I will be in contact with Hadlow Parish Council and the local Borough Councillors for Hadlow with the view to developing a Local Parking Plan for the community. Members will recall this was put on hold several years ago pending the Parish Council moving forward with a redesign project of the central area of the village. The Parish Council is now ready to consider options to address parking issues in various areas.

1.8 Phase 8

1.8.1 We are currently compiling a list of locations for investigating the possibility of new parking restrictions. Currently the list of locations for consideration is as follows:

1.9 Legal Implications

1.9.1 The on-street parking service is undertaken by the Borough Council on behalf of the County Council under the terms of the formal legal agreement.

1.10 Financial and Value for Money Considerations

1.10.1 Funding to implement the parking action plan is provided within existing approved Borough Council Budgets

1.11 Risk Assessment

1.11.1 The assessment and consultation process applied to parking management should provide the assurance that the Borough Council has the will and ability to adapt the Parking Plans, in the light of comment and circumstances, to ensure that it achieves a best balance of local parking needs. A regular review of the schemes is crucial to ensure that we can correctly and effectively manage on-street parking in these areas as the proposals are either introduced for safety reasons or to provide a more appropriate balance of parking needs.

1.11.2 A major risk is that scheme proposals encounter significant lack of local support. This risk is mitigated by the considerable effort devoted to ensuring there is widespread consultation on proposals through two stages of informal consultation before any formal stage of consultation is reached. There is also care given to ensuring that schemes are adjusted and adapted in the light of comments and observations received from the local community, without compromising safety or the Council's commitment to deal appropriately with identified safety concerns.
