### IMPORTANT NOTES

- (1) The requirement to notify the Monitoring Officer of a disclosable pecuniary interest applies not only to your own interests but also those of your husband/wife/civil partner, or a person with whom you are living as husband/wife or as if you are civil partners, where you are aware that the other person has the interest.

The term 'relevant person' therefore means you and any other person referred to above.

**I am a chartered engineer. I give advice but receive no income for this.**

**I own one quarter of Innovation Funnel CIC which, so far, has no turnover and generates no income. My wife owns another quarter. The intention is to encourage innovation and invention especially as regards 'Green' engineering projects.**

**I am chairman of the Kent Inventors Forum for which I am not paid**

**I am also co owner and co director, with my wife, of Shelley Engineering, which is a dormant company**

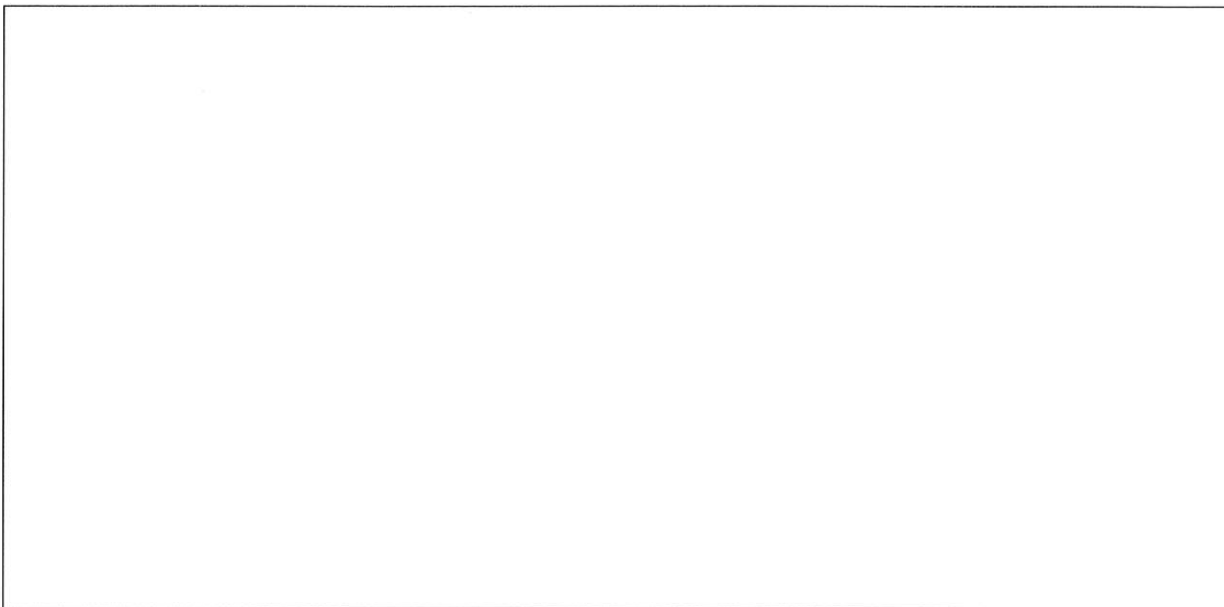

- (b) where the DPI is not entered in the authority's register and is not the subject of a pending notification, but is disclosed at a meeting of the authority (or any committee, sub-committee, joint committee or joint sub-committee) as required by s31(2) of the Localism Act, within 28 days beginning with the date of the disclosure (s31(3) Localism Act 2011));
- (c) where the DPI is not entered in the authority's register and is not the subject of a pending notification, within 28 days beginning with the date when you become aware that you have a DPI in any matter to be dealt with, or being dealt with, by you acting alone in the course of discharging a function of the authority (s31(7) Localism Act 2011)).
