We feel that introducing charges in the car park will be disastrous for the village and the businesses, it will cause absolute chaos where people will try to find alternative parking spaces especially at school times. We are lucky that we have a shared parking space behind the property but there will not be enough for all of us to park there and will cause so many complications. We have been blocked in on many occasions in the past with people parking on the pavement by the seats and we have been unable to get out ....I'm afraid that this situation will only escalate.

We have many patients that come in for treatment that also bring much needed revenue into the village, via the local shop, cafe and pubs, I'm afraid putting a time limit on their visit will deter them from staying any longer than they need to. Also a treatment takes between 40-60 minutes sometimes longer.... the last thing that they need to be worrying about is whether their ticket will run out before their treatment is completed!

We lived in the village for a number of years in one of the cottages in the High Street without parking and understand how difficult it is to find a parking space but to add an extra tax to the residents would be absolutely horrendous, we already pay a premium for living in the south east and the last thing we need is an additional premium added, please don't increase it even more.

If you want to continue on this crusade you will drive the businesses away or finish them off and you will kill what is already becoming a dying village! Its hard to believe that this village with so much history (being one of the oldest in the country) is so neglected! Compared with villages around the country and villages in France it looks so tired and unloved, if you succeed in bringing in charges you will be putting a nail in the coffin of this village.

Please reconsider for the sake of the village and the businesses!!
