Peters Village

- 2) The length of the proposed double yellow lines are too excessive. the section on Worrall drive is not near the school and is not currently affected by the school traffic in either the morning or afternoon. the section where it becomes unrestricted will become a choke point which it is not currently and cause more issues.
- 3) There are not currently enough resident parking spots as it stands, in an age where majority of households have more than 1 car there is not sufficient parking for these cars which leads to parking on the proposed streets. Some houses even have 3 and if the proposed plans were

actioned then there would become more parking issues and therefore more chokepoints on the surrounding areas with no double yellows.

4) The building companies who built the village did not add enough parking spaces and with no yellow lines existing or even proposed when people moved in, to add double yellows would be a kick in the face to the residents, we should not be punished by this unnecessary proposed plans when it is not required, especially on a major scale.

The parking problems in Peters Village are largely due to laziness of residents. Nobody was forced to move to Peters Village and everyone would have had the chance to view or see the plans for their property.

People just cannot be bothered to walk more than 5 metres to their car, or rotate their cars on their driveway. Residents have shortened their driveways to extend their gardens, or just choose to leave them empty, just to park at their front door.

I do however, believe the plans should be amended slightly in the following places;

1. The entrance to Keepers Cottage Lane (KCL) from Village Road is the biggest 'accident waiting to happen' in the village. Multiple cars and vans continuously line the road at all times, blocking the view into KCL. A head on collision here is inevitable.

Furthermore, the parking on the speed bump on KCL, forcing all traffic on one side of the road, has caused the speed bump to collapse and need repair, twice. The double yellow lines should be extended all the way from village road to Barge Walk, on both sides of the road.

This change would be supported by countless residents as this is regularly discussed on social media groups.

2. The double yellow lines should be extended on Worrall Drive from the entrance to Chalkpit Road, all the way round to the island at Edwin House. Parking outside house Numbers 11 - 27 Worrall Drive is terrible, however there are cars that park opposite the junction of Trevithick Drive, blocking the view when turning into Trevithick Drive. Another head on collision waiting to happen.

The current proposal will likely push the 11 - 27 Worrall Drive parkers to just park further along the pavement outside number 33 along to Florence House.

People parking fully on the pavement is a problem the length of Worrall Drive

However, I have concerns about the impact on residents, particularly where non-time-based restrictions are being introduced. Many, including disabled and pregnant parents, rely on parking near the green to access the field with their children and pets. Permanent double yellow lines seem excessive when timed restrictions during peak hours would be more appropriate.

The section of Worral Drive near Chalkpit and extending to Keepers Cottage Lane would benefit from restrictions preventing pavement parking, as this frequently obstructs pedestrians. As the only registered childminder in the village, my partner and I often struggle to walk safely with children due to inconsiderate parking. However, simply displacing vehicles from the main road is likely to push the problem onto side streets such as Kiln Park Drive and Lime Place, where limited parking already makes access difficult, particularly for those with buggies or mobility issues.

On Keepers Cottage Lane, the road is wide enough to accommodate parking and two-way traffic, so further restrictions seem unnecessary and will only frustrate residents. Likewise, imposing yellow lines near Peters Pit appears to be an unnecessary use of council funds, as parking here is not an issue.

The restrictions proposed for Village Road risk exacerbating congestion near the Peters Village roundabout, as parents will likely park here instead. This could create serious traffic delays affecting Wouldham, Burham, and surrounding roads, particularly without any regulations near the roundabout itself. The planned yellow lines on the left-hand side towards the school could also create a blind spot, increasing the risk of accidents.

Overall, these proposals seem to prioritise commercial interests over the needs of residents, many of whom are already facing financial pressures from developer-imposed fees. A more balanced solution would be to introduce time-limited restrictions—such as 6?AM to 6?PM on weekdays—rather than blanket bans. Alternatively, the council's funds would be better spent purchasing land next to Walter House to create a dedicated school car park, addressing the root of the parking issue without further penalising residents.

Dear Mr. Bracey,

I am writing to express my strong objection to the proposed double yellow lines outside the front of my property. Whilst I understand the concerns regarding obstructive parking near the school, on width restrictions and on corners, I believe the proposed solution is disproportionate and will negatively impact my property as well as some others. Fundamentally, there is no requirement for double yellow lines on this part of Keepers Cottage Lane which the attached photos clearly demonstrate. I strongly disagree with the need to place double yellow lines outside the front of my house. We do not have direct access to our carport from the front of the house. As you will see from the photos attached, we either have to walk all the way round past our neighbours house on the next road or go through two gates – our rear gate and then side gate. Therefore, having the ability to part outside our house is essential. My mother-in-law is disabled and regularly stays with us due to ill health, this will have a huge impact on our ability to care for her as we would not legally be allowed to park outside our own house.

^{*} Loss of Parking: The introduction of double yellow lines will significantly reduce available parking for residents and their visitors. This is particularly concerning in an area where off-street parking may be limited. We were attracted to Peters Village due to the availability of parking and the installation of double yellow lines (as witnessed

in Holborough lakes) will cause widespread issues. It will also cause us issues in accessing our property as we do not have direct access to our front door from our car port. There is no street lighting round here so at night it is very dark. I would be uncomfortable that my wife could no longer park outside the house when she gets back late at night.

- * Disruption to Daily Life: The restrictions will make it difficult for residents to manage everyday activities, such as carrying groceries, accommodating deliveries, and having visitors.
- * Potential for Displacement: Restricting parking in one area may simply displace the problem to neighbouring streets, creating further congestion and inconvenience.
- * Lack of Alternative Solutions: The letter does not indicate whether alternative solutions, such as single yellow lines or simply installing double yellow lines on bends have been considered. I fail to see why the council would need to install double yellow lines outside my house as there is no obstruction nor does it restrict drivers views when turning onto Keepers Cottage Lane. It is also highly concerning as this will have a big impact on the value of my property. I request that this be further reviewed as we do not wish for a community where there is no parking.



I am NOT in favour of the Borough Councils proposals for changes to the on street parking arrangements for Worall Drive & Keepers Cottage Lane area, Woulham, Rochester shown on plan DD607-28 1&2 Wouldham - Peters Village.

First and formost I am NOT in favour of the current plans on Keepers Cottage Lane. In this current environment its is almost impossible to purchase a house and be a single occupant so once again the development has been allowed to be build without adequate parking for the houses and flats. Profit over everything as always and now the hard working people who purchased these properties are having to suffer.

Under the current plans there is a break in yellow linea on one side of the road of Keepers Cottage Lane from Number 4 - 18 Keepers Cottage Lane and corner of Orchid Road. Who ever has decided to put the break on that side of the road has clearly never been down Keepers Cottage Lane. The opposite side of the road that has the majority of the on street parking which all park 2 wheels on the curb (which you are proposing to put double yellows) has a pavement of over 3 meters wide. This allows for the on street parking as well as the path still being able to accommodate wheelchairs, pushchairs, kids on bikes etc... where as the opposite side of the road where you won't have double yellows has a path of 1.5 meters, half the size. All the cars that currently park on the wide pavement are obviously going to just move onto the other side of the road and park partially on the path making no room for Wheelchairs, pushchairs and basically makes that path redundant and unusable. This in turn would make it impossible for any residents from 6 Keepers Cottage Lane to Orchid Road to leave their house in a wheelchair or with pushchair and safely get to any crossing. This will breach the disability act and restrict access to and from these houses.

Also by leaving such a break in yellow lines will force all the on street parking on Keepers Cottage Lane into the break in yellow lines between number 4-18. Therefore will make it impossible for refuse collectors to get bin on and off curb.

I strongly recommend you consider either moving the break in yellow lines to the wider path or put double yellows on both sides if the council are insisting on pushing through the plans.

If the current plans go ahead as per the drawings I will have no option to seek legal advice regarding access and how this breaches the disability act 2016.

In response to your proposed plans I hereby **Object** to your proposed plans due to the below reason;

I object to this proposal on numerous reasons; 1) the bus route mentioned is not frequent enough to warrant a change to the area, especially on the major scale proposed.

- 2) The length of the proposed double yellow lines are too excessive. the section on Worrall drive is not near the school and is not currently affected by the school traffic in either the morning or afternoon, the section where it becomes unrestricted will become a choke point which it is not currently and cause more issues.
- 3) There are not currently enough resident parking spots as it stands, in an age where majority of households have more than 1 car there is not sufficient parking for these cars which leads to parking on the proposed streets. Some houses even have 3 and if the proposed plans were actioned then there would become more parking issues and therefore more chokepoints on the surrounding areas with no double yellows.

Reference your letter dated 18 February 2025 regarding a proposal to apply double yellow lines to Worrall Drive.

I live at 32 Worrall Drive (Flat) and am not in favour of the proposals as currently drafted.

Account needs to be taken of the following factors so that a more considered scheme may be adopted rather than the proposed blanket approach:

- 1. Many of the households in this road have only one off-street parking space available whereas most have at least two cars (perhaps as a result of the total lack of public transport other than a solitary school bus)
- 2. No provision has been made for visitors to park on the development and their only option is to use the road
- 3. Double yellow lines are absolutely not required for bends in the road and if this is a valid concern (which I doubt) then a 20mph speed limit would be much more appropriate
- 4. No mention is made of the hazard to pedestrians posed by roadside parking, which would again be best addressed by a 20 limit or street lighting
- 5. Constant deliveries are made to every household in the area, primarily by vans, which require to stop on the road during deliveries
- 6. The dedicated school drop-off lane provided on the Wouldham Road is rarely used due to the ridiculous single lane and traffic lights arrangement adjacent to it restoring the two-way traffic would easily fix this and relieve school drop-off and pick-up traffic from Worrall Drive
- 7. By displacing resident's vehicles in the proposed scheme, all roadside parking available next to the school will become inaccessible to school parents as the space will be permanently occupied by displaced resident's cars

Finally I would comment that Peter's Village is a new development and the necessity to address this problem when housing construction is not yet complete highlights the inadequacy of the planning process, resulting in this proposal to immediately deprive residents of access to their new homes.



Firstly thankyou for consulting us on this matter.

We would like to add our approval of this scheme as at present the parking on the estate is becoming terrible.

The issues we seem to suffer from mostly are:-

- 1) People just do not want to use their allocated parking spaces and leave them empty and only get used when they have visitors
- 2) Parking on Worrall drive around school run times is absolutely disgraceful. Cars are not parked; they are simply abandoned in dangerous and careless locations, people only seem to be concerned about who can park closest to the school gates. I avoid driving down Worral drive on from around 1430 to 1530hrs on school days as the road is virtually impossible to drive through safely for me in a car, god forbid what it would be for an emergency services vehicle.





I received the letter regarding the new & amended parking restrictions to Worrall Drive and Keepers Cottage Lane. I am resident at ME1 3GT.

- 1. I am in agreement that the parking at the school needs to change. I agree that yellow lines around the island should be implemented. However, the lines that are proposed to limit parking on one side and at the roundabout will significantly & negatively affect the school drop and pick up. For the most part, parents park responsibly and are quick to move on once their children are collected/dropped off. These lines will prohibit a significant number of cars from parking with no reasonable alternative option available to them. The school gate is only open for 10 minutes in the morning which does not allow sufficient time to find alternative parking that is within a reasonable walking distance, especially for small children and/or in poor weather. As a parent at the school, I can say that the issues with the parking are:
 - the parents who park on the island/too close to the island blocking traffic
 - parents who park on the already restricted areas around the school entrance
 - parents who park on the pavement approaching the island opposite side to the school
- 2. The entrance to Keepers Cottage Lane from Village Road is regularly ending up a blind corner due to the high sided vehicles that routinely park there. The current proposal does not address this as only the corner is yellow-lined. Ideally the yellow lines would extend to Barge Walk so it could remain clear.
- 3. I don't feel that yellow lines the length of Keppers Cottage Lane from the island at Franks House to Corliss Vale are warranted. I drive along there daily and do not find it to be an issue. Lines around the islands make sense.







I am responding to your letter dated 18th February 2025 relating to the above.

As a resident in Redbrick Road, it alarms me how poorly parent's park in and around the school at drop off and collection times. On a few occasions they have even blocked the whole road by parking across the centre isles and adjacent to them.

This poses significant issues for anyone who wishes to pass as this is the main route into Peters Village. I often find I drive the long way round during peak times just to avoid it now. But surely, the main concern here is if an emergency vehicle, ie; a fire truck or ambulance is unable to get through!

There is also a major parking issue through the estate where cars are permanently parked on high rise curbed areas. These are pathways, but bizarrely designed to be the same width as a van or car, so people are incorrectly using them as parking bays. I have struggled with my children in the buggy and have to constantly walk in the road to avoid these parked vehicles on the pavements.

I therefore would like to submit my support for these roads to be adopted by the council, and for the proposed measures to be implemented.

I am writing in response to the planning consultation regarding proposed road safety improvements in the Worrall Drive & Keepers Cottage Lane area of Peters Village.

I welcome the proposed measures, particularly the introduction of double yellow lines and bus stop clearways to address obstructive parking near the school and on the bus route. These changes are much needed and will significantly improve safety for pedestrians, cyclists, and bus users.

I am particularly supportive of the efforts to prevent parking near the school, traffic calming measures, bends, and along the bus route, as these areas are frequently impacted by inconsiderate parking, especially during peak times. This is a problem we have raised with Hyde Housing on several occasions especially regarding the top end of Worrall Drive (after the junction of Thevithick Drive, where cars are regularly parked on the pavement, obstructing pedestrian access and making it difficult, and sometimes dangerous, to walk. The plans seem to suggest that this area will remain unaffected.

These ongoing issues highlight the urgent need for effective parking management in the area.

However, while the proposed double yellow lines and clearways are a positive step, I would like to understand how these restrictions will be enforced, especially during the crucial school pick-up and drop-off periods.

Experience suggests that simply introducing restrictions without effective enforcement may not be sufficient to deter persistent offenders.

Could you please provide details on the planned enforcement strategy, including the frequency of patrols and the penalties for violations?

Understanding how these measures will be actively enforced will give residents confidence that the proposed changes will genuinely improve road safety, and address the issues we have previously raised with Hyde Housing.



Hello,

I am a Principal Technical Planner for and I have worked as a transport planner for over 10 years now, so have a bit of experience in this area. I have also been a resident at the village for 4 years and my child attends the local primary school so I feel I am well placed to make an informed comment about this consultation.

Whilst I generally do support it in a large part and feel that it is necessary (and is long over due). I feel there are some keys areas that have been missed:

Directly outside the school on Worrall Drive - I do not think anyone should be allowed to park outside the school for a safety reason. It is extremely dangerous for the children to cross in this location (even with the island) and I fear everyday that my child (or another child) is going to get injured by a car any day now and that will be the only reason why something will be done about it but that will be too late. There are plenty of parking opportunities within walking distance of the school (even with the proposed yellow line restrictions) and parents should be forced to park further away for the safety of the children and to create a better environment outside the school gates let alone the environmental (pollution) impacts to the children. There are many cases where this has been imposed very successfully in London (called School Streets) and it is a good opportunity for a near enough brand new school to lead the way in Kent and introduce the same restrictions.

Secondly, the area at the end of Keepers Cottage Lane as highlighted is a nightmare for visibility where there are vehicles parked on one side of the road due to the nature of the bend in the road. Therefore as per Worrall Drive, this area of the road should also have double yellow line restrictions due to a bend in a road. There have been multiple times where I have witnessed near misses here because of large white transit vans parking in this location.

The main concern for me would be the enforcement - please can you reassure me that people will regular enforce these double yellow line restrictions as otherwise they will not be effective.

There is more than enough on plot parking on this development along with visitors parking space so there should be on street parking in my opinion.

I am raising concerns with regards to the recent letter sent by yourselves regarding the parking in and around peters village.

Whilst I agree that double yellow lines needs to be in certain places (mainly around the school area), I do not however agree with them being along areas of Worrall drive. I live at worrall drive, and in a household of 3 cars who share 1 allocated space only (not even with a carport). Whilst this is a bend, we park on the pavement so that it is out of the way of traffic and with enough space for disabled and pram use. We have to park here because there are no other areas near by where we can park and we are not comfortable leaving our cars further afield. Especially with the amount of car thefts etc happening around the area.

Applying double yellows of both sides of the road, along with surrounding areas, will cause a major issue for parking in this area for residents. The parking for residents is bad enough as it is.

If double yellows are to be proposed, additional parking should be required to compensate this. Or the use of single yellow lines should be considered, limiting when cars could park in such areas.

In addition, the bus route is not used that much. therefore, the use of single yellow lines should suffice.

But the final plea here is please provide more parking for residents, as stated above, it's already bad enough as it is hence why parking is "bad" in areas of Worrall drive.
