I just wanted to follow up on my earlier email from last week. The local parking officer has suggested that we may be able to apply for a parking permit for our concessions to be parked once a week in the proposed timed bays on Tonbridge Road outside St Johns church. If this was the case then we would be happy to support your decision to implement timed bays. Subject to the cost of the licence being reasonable.

If we are left with no choice but to stop trading then the community would lose x2 much loved food concessions. It would mean residents would then need to get into their cars and drive to the nearest fish n chip shop/pizza outlet, which I know they would not be happy with. WE have been serving the community of Hildenborough for 10 plus years. There has been a fish n chips on site for 20 plus years. Both vans are loved and supported by the local community. It would seem rather short sighted to force these local businesses to shut down, deprive a community of a service, particularly for the elderly and infirm who no longer drive, for no apparent reason. Residents do NOT seem to understand why the changes are being suggested.
